FISCAL NOTE ANALYSIS

BILL NO. HB 102

**Analysis**

This bill amends AS 45.45, related to rental car fees, and AS 43.52, related to vehicle rental tax levying and rates for passenger vehicles and recreational vehicles. This bill would remove the terms "car" and "rental car business" from AS 45.45 and replace the terms with "vehicles" and "vehicle rental," in conformity with the language used in AS 43.52. The bill would add vehicle rental businesses as a liable party for the purposes of paying vehicle rental taxes under AS 43.52.

The bill would also add two new sections to AS 45.45. One section would subject vehicle rental networks to the same laws and regulations as other passenger or recreational vehicle rentals. The second would provide for vehicle rental businesses to provide notice and disclosures electronically. Finally, the bill would provide and incorporate definitions for "passenger vehicle," "personal vehicle," "recreational vehicle," "vehicle," "vehicle rental business," and "vehicle rental network."

This bill affects the laws and regulations governing private vehicle rental businesses and networks. The Department of Law expects no fiscal impact if the bill becomes law.
