RE: Board of Nursing Appointments

Dear Representative LeDoux & Wool,

We are writing on behalf of the Alaska Nurses Association (AaNA) to express our concerns regarding Governor Dunleavy's recent appointment of Marisha Dieters to the Board of Nursing.

At the time of Ms. Dieters' appointment, she was a Registered Nurse and met the criteria established in the statute 08.68.010(4). However, on March 13, 2019, Ms. Dieters became licensed as an Advanced Practice Registered Nurse. One important tenant of the State's nursing regulations is the importance of nurses practicing at their highest level of education and licensure. We believe that this same concept is important for the appointment of nurses to seats on the Board of Nursing.

While we applaud Ms. Dieters for her advancement in the nursing profession, unfortunately this means that she no longer meets the criteria for the seat. AaNA strongly believes that it is important that the perspective and concerns of the State's Registered Nurses be represented through two RN designated seats on the Board of Nursing, as laid out in statute. For the Board of Nursing to be in compliance and to ensure the full representation of Registered Nurses, a replacement appointee of a Registered Nurse who meets the criteria will need to be confirmed.

We do thank you for moving these appointments in a timely fashion and working to ensure that Board of Nursing is fully constituted.
