Professional Teaching Practices Commission

Mission Statement

The Professional Teaching Practices Commission's intent is to serve as a preventative and positive force in helping to enhance the professional performance of all educators so that the public's right to the best education possible for all of Alaska's students is adequately protected.

In 1966, the education profession in the state of Alaska was granted the right and responsibility to define and to enforce ethical standards of its members. The Alaska Legislature established and empowered a nine-member Commission to impose sanctions against the certificates of educators who engage in illegal, immoral, or unethical conduct. The Professional Teaching Practices Commission is composed of five teachers, one superintendent, one principal, one representative of the Department of Education & Early Development, and one representative of higher education.

News

In October 2017 the Professional Teaching Practices Commission proposed three changes to the Code of Ethics of the Education Profession. Three people submitted written public comment by the December 20, 2017 deadline. A review by the Department of Law followed, resulting in their acceptance of the three proposals. For consistency and clarity, the regulations attorneys made minor wording and formatting changes. 20 AAC 10.020 (Code of ethics and teaching standards) is changed to clarify that the Code of Ethics explicitly prohibits sexual contact between educators and recently graduated students for up to one year after graduation from high school. 20 AAC 10.035 (Moral turpitude) is changed by adding "providing students marijuana or marijuana related products" to the list of crimes of moral turpitude. 20 AAC 10.900 (Definitions) is changed by adding the definition of "student." Lt. Governor Mallott signed the revisions on July 3, 2018 and they became effective August 2, 2018.



FY2019 Governor's Budget by Structure






FY2019 Governor's Budget by Line Item





According to the Alaska Department of Education and Early Development, all individuals holding a teaching, administrative or special services certificate, student teachers, and all other members of the teaching profession are held to the ethical standards stated in the Alaska Code of Ethics for Educators (20 AAC 10.020).

As I understand it, the purpose of the Professional Teaching Practices Commission (PTPC) is to work as a team to define and enforce the ethical standards of its members. As stated in the mission statement, the Commission's intent is "to serve as a preventative and positive force in helping to enhance the professional performance of all educators so that the public's right to the best education possible for all of Alaska's students is adequately protected" and "to impose sanctions against certificates of educators who engage in illegal, immoral, or unethical conduct".

Since becoming a teacher, I have experienced the importance being an advocate for my fellow educators, the students with whom I work, and for the teaching profession as a whole.

As an advocate for my peers, I have had the privilege of being asked on numerous occasions to participate in difficult disciplinary and/or non-retention conversations between teachers and their administrators. I believe that I was asked to participate because I have a clear understanding of our negotiated agreement, retention policies, and the grievance process. I further understand the need to exercise confidentiality and to maintain trust throughout the process. I have confidence that the outcomes, positive or negative, are intended to be fair, and that they are based on the facts gathered specific to each situation.

As a teacher, I advocate for my students when Individual Education Plans (IEPs) are being written, when curriculum is being selected and during parent/teacher conferences and conversations.

As an educator, I have had the privilege of speaking before the State Board of Education and Commissioner Johnson as a member of NEA-Alaska's Leading the Profession Committee. The purpose of my testimony was to advocate for Alaska's Education Challenge and to address the fallacy that test scores are the most effective and true measure of student success. I have also contacted Legislators, both face to face in Juneau and via email/text, concerning the need for adequate school funding.

I understand that we educators have a responsibility to our students, to our community, to our state, and to our profession to maintain our certification and to conduct ourselves in an ethical manner. I further understand that there are consequences when violations occur.

I would value the opportunity to work with people whose goals are to better the lives of our students, to ensure quality educators, to treat educators fairly in disciplinary matters, and to strive to promote a positive view of the teaching profession.
