FISCAL NOTE ANALYSIS

STATE OF ALASKA 2018 LEGISLATIVE SESSION

Analysis

This legislation amends statutes under AS 03 dealing with agriculture, animals, and food by adding new sections relating to the regulation, production, and transportation of industrial hemp. Specifically, it adds a new section under AS 03.05 making it a violation to produce industrial hemp with a tetrahydrocannabinol content between 0.3 percent and one percent, and adds a new paragraph under AS 03.05.100 defining "industrial hemp." The legislation also amends the definitions of "marijuana" under AS 11.71.900(14) and AS 17.38.900(10) to specifically exclude industrial hemp. The Scientific Crime Detection Laboratory (crime lab) provides analysis of suspected controlled substances, issues reports, and provides expert testimony for the State of Alaska. Under this legislation, industrial hemp is defined as the plant Cannabis sativa L. containing not more than 0.3 percent tetrahydrocannabinol (THC). The threshold amount of THC listed is very likely below the crime lab's detection limits, meaning the crime lab would need to do a threshold study to demonstrate their testing would not inadvertently identify something as marijuana that was actually industrial hemp, and to also confirm the THC content of the industrial hemp for purposes of law enforcement's determination of whether a violation has occurred. This threshold study can be accomplished within the lab's existing budget. Passage of this legislation is not expected to result in any significant increase in the crime lab's controlled substance analysis workload. Therefore, no fiscal impact to the crime lab is anticipated.
