#### **BUDGET ACTION:**

The Senate Finance Budget Subcommittee for the Alaska Department of Labor and Workforce Development held three meetings and analyzed the Governor's budget transactions. What follows are highlights.

#### **Governor's Amended Budget Request:**

- Accepted the Governor's amended budget request <u>except</u> for these items that he had proposed:
  - Travel funding cuts for:
    - 1. Wage and Hour Administration \$3,500 Unrestricted General Funds (UGF), Funding Code 1004
    - Mechanical Inspections \$3,800 Interagency Receipts, Funding Code 1007; \$52,800 Building Safety Account funds (Designated General Funds [DGF]), Funding Code 1172
    - Occupational Safety and Health \$6,800 General Fund Match (UGF), Funding Code 1003; \$26,500 Federal Receipts, Funding Code 1002; \$21,100 Workers Safety and Compensation Administration Account (DGF), Funding Code 1157
- Subcommittee Additions, Reductions and Changes:
  - Removed conditional language that allowed the Office of Management and Budget to transfer funds between appropriations within the department
- Other Changes:
  - Salary Adjustment figures in the table above are informational only and reflect the best guess at this time for what will likely be needed once employee contracts are finalized. The correct dollar amount will be added after budget subcommittee closeouts, in the full Senate Finance Committee version of the budget bill.

- Organizational Changes
  - There were no organizational changes.
- Intent Language
  - There was no intent language.
