## FISCAL NOTE ANALYSIS

### Analysis

**Assumptions** - Expenditures detail is based on compensation required for two permanent full-time employees and anticipated travel budget. Travel will be required to ensure quality assurance of the building inspection process. It does not include broad enforcement.

**Program Summary** - Alaska Housing Finance Corporation is legally required under state statute to have minimum construction standards, including building and energy minimums, prior to financing home loans. This requirement presently involves review and adoption of current building and energy standards that reflect best building practices, administration of the Home Energy Rating System (HERS) that allows for home energy performance evaluation, and quality assurance of Authorities Having Jurisdiction (AHJ), and third-party inspection processes.

This fiscal note includes funding to expand AHFC's building and energy code administration to a statewide level. Two positions would be necessary to handle the increased work. The new energy specialists would be responsible for building and energy code review, adoption, interpretation, and quality assurance. Each position is expected to be recruited between grades 17-19. Statewide travel would be necessary to perform quality assurance of AHJs and third-party inspectors along with technical education and services to industry as required.

**Performance Measures** - The legislation is not anticipated to have an impact on AHFC's mission, core services, or performance measures.
