Earlier in the session; Senate President Giessel spoke on a State-wide call in show on Alaska Public Radio noting that the CBR shouldn't be touched this year (except for emergencies) because the balance is only \$2 Billion dollars. Let's not forget that just a few years ago the CBR was \$16 Billion and the current balance of \$2 Billion is a direct result of the Legislators inability to address the issue of needing to raise revenue.

HB 1005 also keeps the full weight of spending to support services on Alaskans. This despite the fact that an income tax could collect dollars that are removed from our State and used to support services in other States.
