This bill is unacceptable with the wording to cut future PFDs by the use of an unacceptable formula that would cut all future PFDs to half or less than originally provided by the writers of the original law. I am appalled that there are those in the House who think that bribery will save their jobs. It will not!

I urge you to vote YES for the original fund formula to remain in place and for you to vote NO on a bill that takes away the citizens right to the fund that was designed for them by people who apparently understood how to keep the fund going and to reward the citizens for their investment into the Permanent Fund. The House Majority Coalition has submitted the HB 1005 for consideration to remove (**AS 43.23.025**), the current PFD formula as though current state law did not even exist.

The bill also requires permanently changing a separate section of state law so that 75% of all future permanent fund income will be spent to prop up unsustainable state spending, leaving at most only 25% for future dividends.

I urge you to instead hold a vote on HB1002 which is a bill to pay the full dividend and has no underlying "gotchas" I would also urge you to put HB 1003 and HB1004 that also apply to the PFDs for the future.

The bill to pay a full dividend, HB1002, was instead assigned to wait for hearings in three committees, the first two of which have effectively been disbanded, and are not scheduled to even hold a meeting until the year 2020.

The bill to payback the portions of prior dividends that were withheld, **HB1003**, received the same treatment as the bill for a full dividend. They also sent **HB1004**, to pay back the interest on the withheld dividends, to the same two committees that will not be meeting again until sometime next year.

The bill to pay a full dividend, HB1002, was instead assigned to wait for hearings in three committees, the first two of which have effectively been disbanded, and are not scheduled to even hold a meeting until the year 2020.

The bill to payback the portions of prior dividends that were withheld, **HB1003**, received the same treatment as the bill for a full dividend. They also sent **HB1004**, to pay back the interest on the withheld dividends, to the same two committees that will not be meeting again until sometime next year.

I urge you to vote NO on HB 1005 as written. Once again, I remind the House Majority Coalition that you are up for re-election in 2020 and we, the people are ready to remove those folks who have consistently, this year, moved against what the constituents in your districts are saying. I further urge you to take up hearings on HB1002, HB 1003. and HB 1004. ,
