



Long Term Services & Supports Continuum of Care for Seniors



Key Findings

- FNSB has the entire continuum of care, but within the borough there are gaps
- Greatest needs:
 - Quality, affordable senior housing
 - Long waitlists for subsidized, income-restricted senior housing
 - ~148 units by 2025
 - Coordinated transportation plan for seniors
 - Care coordination
 - Assisted living for people with challenging behaviors, many related to dementia
 - ~129 beds by 2025
 - Funding for "preventative" services. While some services (like personal care + home modifications) are available, not all seniors have the availability to pay out of pocket.
 - Workforce development for care providers
 - Primary care doctors who accept Medicare
 - Home modifications
 - Legal resources + advocacy services




Senior Population Growth Last 8 Years



Where do seniors live?






Population 60+ Peaks in 2025

Population 80+, requiring the most supports, will grow through 2040.










Senior Survey – Housing

Questions 22, 23, 26, 27 & 31

- 86% live in a house or condo that they or a family member owns.
- 15% of respondents live with their adult children
- 41% say their homes need some form of modification
- 84% plan to stay in Alaska
- 66% expect to be living in the same home five years from now
- 15% would like to live in a smaller space in 5 years

How respondents access LTSS Information




Senior Survey – Help with Activities of Daily Living

- Top ADL/IADLs Needs
 - General home maintenance (26% cannot do this)
 - Household chores
 - Shopping
- Over 95% of respondents indicate that they can manage finances, take care of personal tasks, prepare meals, manage medications and get to appointments on their own.
- 25% say they can get help only some of the time or never (3%)
- Top ways of obtaining help
 - Family (57%), self-pay (28%) and friends/neighbors (27%)

Senior Survey – Health Status

Questions 35, 37, 48

- 58% report very good or excellent health
- 28% have fallen at least once in the last six months
- 28% have, or know someone who has, experienced elder abuse or exploitation


Senior Survey – Access to Health Care

- 1. Providers do not accept Medicare
- 2. Shortage of specialists, gerontologists
- 3. Cost is too high and unable to pay
- 4. Doctor is not taking new senior patients

28 respondents who provide services to seniors in the FNSB Providers are serving more seniors than five years ago, expect this to continue

Top concerns: decreased government funding + recruitment and retention of quality staff

Most important issues for older adults

- In-home services
- Assisted living or long-term care facility
- Dementia care
- Financial need

Most important services missing/insufficient in the continuum

- Independent senior housing
- Transportation
- Family caregiver supports
- Home modifications
- Behavioral health/mental health services
- Chore/homemaker services




Meals Provided by NSCoA

Transportation

- ~133,000 MACS senior trips per year (182/day)
- \sim 1,000 Van Trans trips per year (incl. disabilities + seniors)
- ~2,000 NSCoA trips per year
- Large number of requests for afternoon transportation. More transportation between North Pole and Fairbanks needed.
- Need accessible taxis two exist, but aren't being used
- It would be good to have some sort of coordination between all of the agencies that provide transportation services so that efforts are not duplicated
 - Coordinating scheduling, insurance, etc. between govt, non profit and private agencies. Some agencies require drug testing for drivers, or other qualifications. Would need to have some consistency.
 - Call one specific number who schedules the trip with whoever is available/whoever serves that area.




Independent Senior Housing in the Fairbanks North Star Borough



- 4 out of 9 senior housing providers currently have a waitlist, and these four locations account for 69.1% of the accessible senior housing units surveyed - 175 out of 253 units total
- The two largest rental providers currently have no units available to seniors, and have waitlists that are months to years long


Estimated Percent of the Population 65 Years or Older





Assisted Living

4 open Pioneer Home Beds; 53 people on FPH waitlist, almost all level 3, 73% ADRD (Jan 2019);

12 open beds in other homes

Growing demand-more are opening

General relief – waitlist of 200+ statewide to get access to this funding source while people are waiting for Medicaid waiver assessment

Lack of care coordinators to get Medicaid waiver assessment

Gap: shortage of dementia care for people with behavioral challenges, even hard to serve in Denali Center

Seniors Experiencing Homelessness

- In 2018, 79 seniors age 62+ experienced homelessness
- Resources: emergency shelter, rapid rehousing (available for assisted living) permanent supportive housing; Food Boxes
- Part of a bigger issue related to not enough subsidized senior housing

Discussion: Findings

- Home and community-based services are generally able to expand to meet demand, though limited by funding
- Senior independent housing in high demand; new housing construction faces financial and market feasibility limitations.
- Greatest Needs:
 - Quality affordable housing
 - Coordinated transportation, transportation outside of Fairbanks
 - Care coordination
 - Assisted living for people with challenging behaviors
 - While some services (like personal care + home modifications) are available, not all seniors have the availability to pay out of pocket. Medicaid continues to cut eligible hours and this threatens seniors independence.
 - Workforce development, aging volunteer population
 - Medicare accepting doctors
 - Mental health services for seniors.
 - Legal resources + advocacy
