PDA: Overview

- Mission: To provide constitutionally mandated legal representation to indigent clients appointed by the court.
 - 83%-85% of all indigent appointments are handled by the Public Defender Agency
 - 13 offices Statewide

Workload Increases

- FY18 to FY19 Statewide Appointment Increases
 - 个 5% overall
 - ↑16% unclassified felonies (most serious)
 - ↑35% **unclassified** in Anchorage
 - 个33% misdemeanors
 - ↑75% misdemeanors in Anchorage
 - 个10% child in need of aid
- ↑53% Dillingham, ↑22% Kodiak, ↑18% Kenai
- ↑300% **A felonies** & ↑30% misdemeanors in Palmer

Retention

- Loss of highly skilled and experienced attorneys
- Increased training and supervision needs


Recruitment

 Vacancies increase backlog and workload, and decrease the effectiveness of efficiency initiatives




