### **SB 52: Alcoholic Beverages; Alcohol Regulation**

## **Explanation of Changes**

### **CS SENATE BILL NO. 52 (JUD)**

Version: 31-LS0004/K

1. **Page 6, Lines 13-15, Section 10: Brewery manufacturer license** (AS 04.09.020) Requires the fermentation process of all brewed beverages offered for sale for a brewery manufacturer licensee to occur on the holder's premises in the state. (SL&C)
2. **Page 6, Line 19, Section 10: Winery manufacturer license** (AS 04.09.030) Lowers the biennial fee from \$1,250 to \$1,000. (SJUD)
3. **Page 6, Lines 20-21, Section 10: Winery manufacturer license** (AS 04.09.030) Requires the fermentation process of all wine offered for sale by a winery manufacturer licensee to occur on the holder's premises in the state. (SL&C)
4. **Page 12, Line 2-Page 14, Line 3, Section 10: Restaurant or eating place license** (AS 04.09.210) Consolidates the requirements under a restaurant endorsement to be included in the REPL. Also included is the Seasonal restaurant or eating place tourism license on Page 26, Line 15-Page 28, Line 30. (SJUD)
5. **Page 19, Lines 19-22, Section 10: Sporting activity or event license** (AS 04.09.270) Adds skiing and snowboarding to the license and renames it to Sporting activity or event license. (SJUD)
6. **Page 22, Lines 21-23, Section 10: Brewery retail license** (AS 04.09.310) Clarifies that brewery retail license holders can sell up to 5.167 gallons of the holder's beer or sake for consumption off the premises. (SJUD)
7. **Page 23, Lines 9-11, Section 10: Winery retail license** (AS 04.09.320) Clarifies that the holder of a winery retail license can sell up to 5.167 gallons of the holder's wine, mead, or cider for consumption off the premises, regardless of alcohol content. (SJUD)
8. **REMOVED:** Section 10, AS 04.09.410 Manufacturer sampling endorsement requirements. Removed the prohibition for the holder of a manufacturer sampling license to advertise sampling activities. (Version U, Page 31, Lines 13-17) (SL&C)
9. **Page 34, Lines 25-26, Section 10: Large resort endorsement** (AS 04.09.440) Clarifies that consumption of alcoholic beverages on a large resort is permitted whether under or not the locations are in the same building or under the same roof of the large resort. (SL&C)

10. **Page 51, Lines 13-16, Section 11: Local option area prohibitions** (AS 04.11.010(a)) Restores current AS 04.11.010(a) to allow the Department of Law to continue prosecuting alcohol issues in local option areas as they currently do. (SJUD)
11. **Page 56, Line 26 to Page 56, Line 17, Section 27: Application of transfer to another person** (AS 04.11.280) Adds a new section to allow for the automatic transfer of a license if no action has been taken by the board within 90 days. This applies to restaurant and eating places with or without endorsements, and seasonal restaurant or eating place tourism license with or without endorsements. (SL&C/SJUD)
12. **Page 67, Lines 4-8, Section 44: Conditions or restrictions imposed on a license, permit or endorsement** (AS 04.11.395) Clarifies the board may delegate authority to the director to impose conditions or restrictions on a permit other than a conditional contractor's permit. (SL&C/SJUD)
