BILL NO. SB 81

Analysis

SB 81 allows telecommunications services to incorporate as cooperatives under the statutes pertaining to electric and telephone cooperatives. "Telecommunications services" means a service capable of electronically generating, acquiring, storing, transforming, processing, retrieving, utilizing, or making available information, through the use of broadband Internet access, data center services, information technology, or other technology services.
If the bill passes, the following expenses will be incurred:
Services: \$1.2 (printing, postage, and legal costs for the regulations project)
The Business Licensing section of the Division of Corporations, Business, and Professional Licensing is funded by General Fund/Program Receipts fund source 1005 GF/Prgm (DGF). Business licensing fees are set per AS 43.70, and revenue in excess of authorized budgeted expenses reverts to the State of Alaska general fund.
