FISCAL NOTE ANALYSIS

STATE OF ALASKA 2020 LEGISLATIVE SESSION

Analysis

•
This bill updates and restructures the current sex trafficking and human trafficking statutes. Specifically, it increases penalties for all forms of trafficking and establishes sex trafficking as a sex offense subject to increased penalties and requiring registration as a sex offender upon conviction. It establishes a new crime of "patron of a victim of sex trafficking" and provides a process for people convicted of prostitution to have their convictions vacated if they were a victim of sex trafficking, and prohibits the Department of Public Safety (DPS) from disclosing those criminal history records for certain employment background checks.
DPS manages the state's central registry of sex offenders and the state's criminal history repository. This bill will impact business and technical procedures for both. DPS Information Technology (IT) staff will need to make several programing changes to the state's criminal history repository in order to restrict dissemination of prostitution convictions for certain employment background checks when the offender successfully petitions to have the conviction vacated, and business processes and procedures will need to be developed regarding the limitations on dissemination of vacated prosttitution convictions. The IT staff will also need to make programming changes to process the proposed new registrable offenses.
Should this bill pass, DPS estimates programming changes will require approximately 100 hours to complete and can be accomplished within existing staffing levels. Therefore a zero fiscal note is being submitted.
