Analysis

This bill eliminates the Ocean Ranger fee as a separate fee and there will no longer be a fund code for tracking expenditures of Ocean Ranger fees separately from environmental compliance fees. There is no impact to the work in the State Support Services component, but a fund source change from Ocean Ranger fees to Commercial Passenger Vessel Environmental Compliance fees is required.
