Dear Co-Chairs Stedman and von Imhof,

Below, please see the responses to questions asked during the Office of Management and Budget's presentations to the Senate Finance Committee on February 6, 2020.

1. Senator Stedman: Please outline the State accounting process for Federal reimbursements.

When the State receives a grant, award, or entitlement allowing for claim of federal revenues, associated costs are tracked through specific revenue codes and program codes in the State accounting system. As federal funds are committed against these grants, agency accountants enter encumbrances into the State's accounting system to ensure that a program's budget is not overspent. Program managers are tasked with ensuring that charges meet the requirements for federal reimbursement. Invoices and payroll associated with these charges are paid out of the state treasury in anticipation of reimbursement. Depending on the specific grants requirements, requests for reimbursement are sent weekly, monthly, or quarterly to the federal government. Once these requests are approved and payment is remitted to the state, the treasury is repaid and the revenue collected is recorded in the accounting system.

2. Senator Hoffman: Please provide the beneficiary growth in the Medicaid program from 2015 - 2020 by geographic location.

4. Senator Wielechowski: Please provide detail on the public hearing process relating to the voter initiative process.

Under AS 15.45.195, "at least 30 days before the election at which an initiative is to appear on the ballot, the lieutenant governor or a designee of the lieutenant governor shall hold two or more public hearings concerning the initiative in each judicial district of the state. Each public hearing under this section shall include the written or oral testimony of one supporter and one opponent of the initiative." These hearings could occur in FY20 and/or FY21 depending on which ballot either appears on.

5. Senator Wielechowski: Please provide a breakout of the \$215.4 request for the Division of Elections, voter initiative review, certification, and language translation.

The supplemental request covers two initiatives that may appear on this year's primary or general election ballot: 19OGTX, Alaska's Fair Share Act; and 19AKBE, Alaska Better Elections Initiative. It provides the funding needed by the Division of Elections to review signatures and certify each initiative during FY20. Funding also provides for translation of the ballot measure language into 11 languages for audio and sample ballots, Official Election Pamphlet pro statement, Official Election Pamphlet con statement, and Official Election Pamphlet neutral summary, as required by the Toyukak Settlement and Section 203 of the Federal Voting Rights Act during FY20 and FY21.

• The statement of costs for each initiative provided the following descriptions:

Estimate by Category

- Voter Initiative 19OGTX, Alaska's Fair Share Act—FY20 Supplemental with 6/30/21 lapse date: \$96.1 UGF
 - The cost to the Division of Elections associated with certification of Voter Initiative 19OGTX, Alaska's Fair Share Act is estimated to be \$96.1 UGF.

- Six temporary employees will be required to review signatures for 2,520 hours at an estimated cost of \$44.6, and certification of the initiative application and review of the initiative petition estimated for 504 hours will cost an estimated \$16.0. Printing service expenses associated with certification of the initiative application and review of the initiative petition will require \$1.3 for the printing of voter booklets.
- The estimated cost of translating the ballot measure language for audio and sample ballots, Official Election Pamphlet pro statement, Official Election Pamphlet con statement, and Official Election Pamphlet neutral summary into 11 languages, as required by the Toyukak Settlement and Section 203 of the Federal Voting Rights Act, will cost an estimated \$34.2.

- Voter Initiative 19AKBE, Alaska Better Elections Initiative—FY20 Supplemental with 6/30/21 lapse date: \$119.3 UGF
 - The cost to the Division of Elections associated with certification of the initiative application and review of the initiative petition is estimated to be \$119.3 UGF.

- Six temporary employees to review signatures (estimated at 2,520 hours), and certification of the initiative application and review of the initiative petition (estimated at 504 hours). Estimated cost: \$60.6.
- Printing service expenses associated with certification of the initiative application and review of initiative petition. Estimated cost: \$1.3.
- Translating the ballot measure language is needed for audio and sample ballots, Official Election Pamphlet pro statement, Official Election Pamphlet con statement, and Official Election Pamphlet neutral summary into 11 languages, as required by the Toyukak Settlement and Section 203 of the Federal Voting Rights Act. Estimated cost: \$57.4.
- If the ballot measure is approved, future costs will include acquisition of new ballot tabulation equipment and voter education.

Because these activities will occur in both FY20 and FY21, a 2020 supplemental with a June 30, 2021 lapse date is requested.

6. Senator Wielechowski: Please provide a breakdown of the \$6,000.0 request for the Alaska Psychiatric Institute.

This request includes funding to provide services to patients when the Alaska Psychiatric Institute (API) is unable to hire staff. API has had to contract with Locum Tenens and other providers to ensure the proper care for the patients and those awaiting forensic evaluations. In order to ensure the safety of patients and staff, API had to increase coverage with a security company to provide campus security. API continues to contract with Wellpath to maintain the stability of operations at the hospital and maintain compliance with all regulatory authorities to ensure the hospital is able to collect federal revenues and serve patients.

7. Senators Olson and Stedman: Please provide the information in relation to the agreement between the Administration and the village of Utqiagvik for the reopening of the District Attorney's office and where the cases are currently being handled.

Attached, please find a copy of the agreement between the North Slope Borough and the Department of Law titled: *MOU of NSB and AK to fund Utqiagvik DA*. This agreement was signed in early November 2019. Since the closure of the office in FY16 and until the new positions are filled, the Fairbanks District Attorney's office continues to serve Utqiagvik.

8. Senator Wielechowski: Please provide the number of vacancies and filled positions within the Village Public Safety Officer (VPSO) program.

There are currently 43 positions filled and 5 positions unfilled. This does not include the 10 VPSO Coordinator positions funded by the program. Of the 43 filled positions, 9 have not yet received any training and are scheduled to attend the Academy in Sitka beginning February 23rd (historically, there is a low completion rate of the training which would suggest that less than 50% of the attendees will complete the training). Thirty-four VPSOs are currently operational in Alaskan communities. Also below are the last several years' turnover rates and end-of-year filled positions by budgeted positions.
