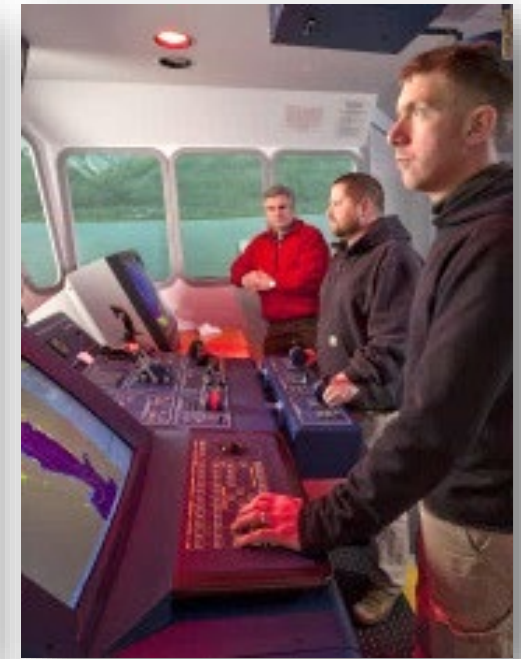

Department Overview

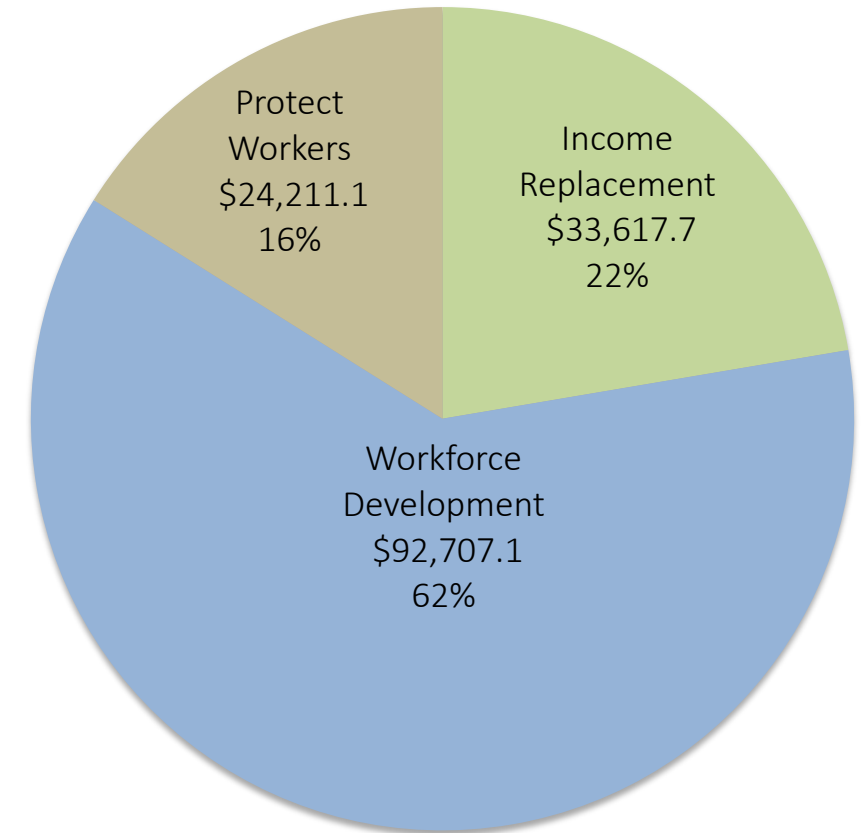
MISSION:

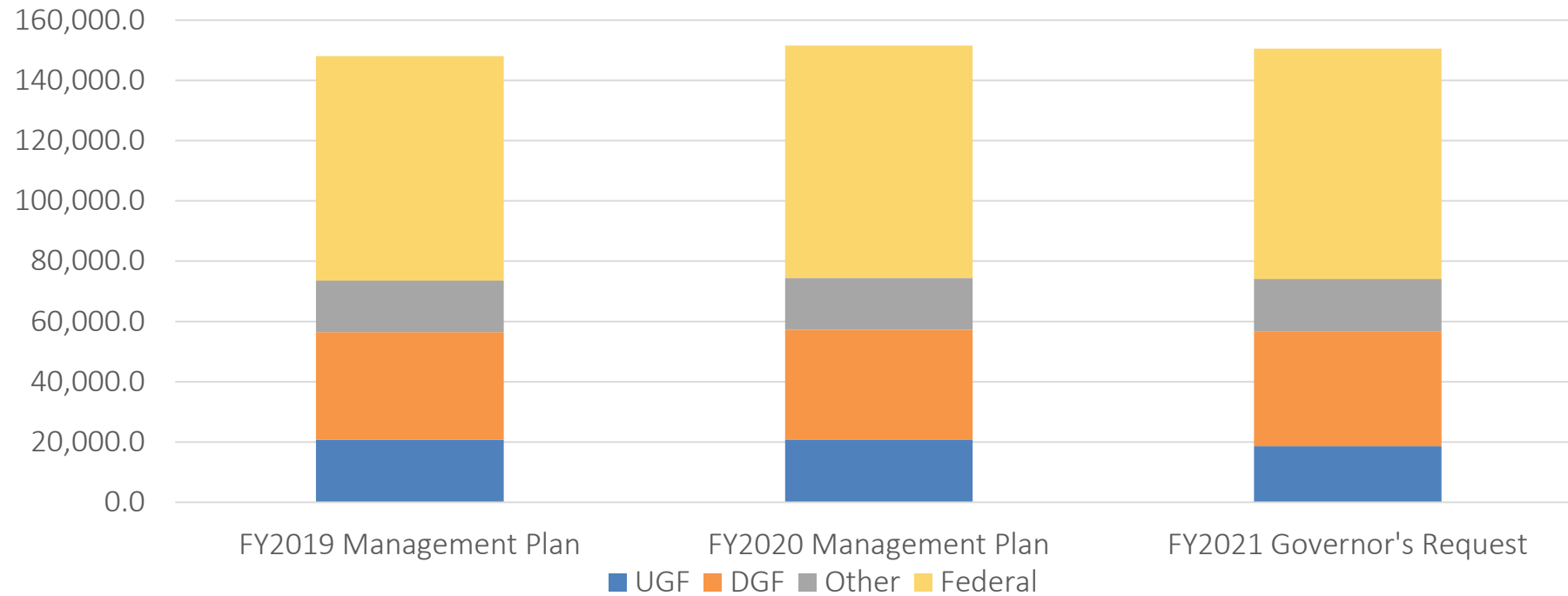
Department Priorities

<p>The Business Enterprise Program (BEP, AS 23.15.100) provides employment opportunities for blind individuals through the establishment and operation of vending facilities on federal and state properties. This appropriation will pay for replacement or repair of existing facility equipment, construction of new vending facilities, and further development of Business Enterprise Program assets. Refurbishment of antiquated sites, replacement of broken or outdated equipment, and modernization of facilities will strengthen blind & disabled vendors' ability to be self-employed and self-supporting, and generate revenue to ensure that the BEP program and partnerships are sustainable and self-supported.</p> <p>Capital expenditures and ongoing operating costs for the program will come from the Business Enterprise Program Revolving Fund (AS 23.15.130), which is funded by receipts and chargebacks from businesses and vending managed through the program.</p>		



Update on FY2020 Significant Budget Changes

Component	Budget Change	Status
Department-wide	Travel Reductions	<p>Most programs experienced travel reductions in FY2020. The department evaluates each travel request to ensure travel is essential, in line with the division's core functions, and that funding is available in the component. In some cases, divisions may determine that some travel is essential to their mission and is a higher priority than other program activities. Divisions may adjust their budgets in the future to reflect updated travel estimates.</p> <p>Many of the department's federal grants include travel that is recommended or required. Federally-funded or other third-party funded travel is evaluated on a case-by-case basis and is occurring as needed.</p> <p>In FY2020 Management Plan, the department adjusted the travel lines in some programs to align with planned FY2020 travel. The department will continue to monitor travel and program needs to ensure programs are meeting their mission effectively.</p>
Labor Market Information (LMI)	2020 Census Complete Count Promotion One-Time Item	<p>The 2020 Census kicked off in Toksook Bay on January 1, 2020, and Census Day is April 1, 2020. LMI is working with Alaska Counts and the U.S. Census Bureau to produce and distribute materials to increase awareness of the 2020 Census and encourage Alaskans to be counted. LMI is participating in Alaska Counts' mini-grants program, and is purchasing advertising in some markets to complement and fill gaps in the U.S. Census Bureau's existing advertising campaign.</p>
DVR / Disability Determinations (DDS)	Increase Federal Receipts for Social Security Administration Reconsideration Process	<p>DDS is working to implement the Social Security Administration's reconsideration process. Work to expand office space to accommodate additional staff is underway at their Ship Creek office, and recruitments for some of the positions associated with the program changes have occurred. All activity in DDS is fully funded by the federal Social Security Administration.</p>
AVTEC	Increase Program Receipts for Student-Funded Consumable Supplies	<p>AVTEC continues to examine program costs and student tuition and receipts. In the FY2021 budget, AVTEC is requesting additional general fund program receipt authority to allow students to cover more of the cost of program and consumable supplies, while still ensuring that AVTEC's cost of attendance is affordable and competitive.</p>
