## SB 6: Alaska Reads Act Explanation of Changes

CS Sponsor Substitute Senate Bill 6 (EDU) Version: 31-LS0159\O

Pages 1-25: Replaces all instances of "literacy" with term "reading". (SEDU)

Pages 1-25: Replaces all instances of "science of reading" with "evidence-based reading".

Definition of evidence-based reading is located on Pages 19 & 20, Line 28- Line 1 (SEDU)

**Pages 1-25:** Replaces all instances of "a statewide assessment" with "the statewide assessment" except in two locations, Page 13 Line 17 an Page 14, Line 18. (SEDU)

**Pages 2-3, Lines 22-19:** Amends AS 14.03.078(a) which directs the department to include information collected under AS 14.03.120 and AS 14.30-760 – 14.30.775 in their annual report to the legislature. (SEDU)

**Page 3, Lines 20-25:** Amends AS 14.03.080(d) by changing the date a student is eligible to enter kindergarten and establishes an eligibility waiver process. (SEDU)

**Page 3, Lines 26-29:** Amends AS 14.03.080(g) by changing the date a child is eligible to enter a public early education program. (SEDU)

**REMOVED:** Requirement that a district publish information collected under AS 14.03.120 on Internet website. (SEDU)

Page 4, Line 3: Requires districts report class size. (SEDU)

Page 4, Line 7: Requires districts to report student improvement on the statewide screening or assessment tool. (SEDU)

**Page 4, Lines 7 & 10:** Amends AS 14.03.120 by clarifying assessment is based on grade-level skill.

Pages 6-7, Line 30-25: Establishes AS 14.03.420, Parent as Teachers. (SEDU)

**Page 11, Lines 20-25:** Reduces number of years of required teaching experience in addition to department approved additional coursework requirement for individuals to qualify to teach in programs established under AS 14.03.410. (SEDU)

**Pages 12-13, Line 27-12:** Amend AS 14.20.015(c) to include evidence-based reading instruction three credit or equivalency requirements for holding a preliminary teacher certificate. (SEDU)

- **Page 13, Lines 6-12:** Amend AS 14.20.020 by adding subsection (l) to include evidence-based reading instruction three credit or equivalency requirements for obtaining a preliminary teacher certificate. (SEDU)
- Page 13, Line 21: Corrects drafting error. (SEDU)
- Page 14, Lines 9-10: Corrects drafting error. (SEDU)
- **Page 14, Lines 11-15:** Establish waiver process for districts regarding statewide screening or assessment tool. (SEDU)
- **Page 14, Lines 26-28:** Amends AS 14.30.760 by inserting new subsection (b)(4) which establishes recommendations for consideration by the department when adopting a statewide screen or assessment tool. (SEDU)
- Page 15, Line 8: Corrects drafting error. (SEDU)
- **Page 15, Lines 21-24:** Amends AS 14.30.765(a)(8) by removing 70-hour intensive reading instruction requirement. (SEDU)
- **Page 16, Line 15:** Amends AS 14.30.765(c) to allow a district or a school to notify parents in either conference or writing. (SEDU)
- **Page 17, Lines 12-13:** Aligns AS 14.30.765(d) with above language regarding written notification. (SEDU)
- **Page 17, Lines 22-23:** Amends AS 14.30.765(e)(1) clarifying scoring requirement on the statewide screening or assessment tool. (SEDU)
- **Page 17, Lines 28-30:** Inserts subsection (f) under AS.14.30.765 and directs the department to develop a recognition program. (SEDU)
- **REMOVED**: Strike subsection (h) under AS 14.30.765 to remove 120 parental notification requirements. (SEDU)
- Page 18, Line 25: Aligns parental notification for students in grade three with previously stated notification. (SEDU)
- **Page 19, Lines 25-26:** Inserts subsection (k) under AS 14.30.765 which prohibits a district or school from retaining a K-3 student who has been previously retained. (SEDU)
- **Pages 19-20, Lines 28-1:** Inserts definition of "evidence-based reading intervention". (SEDU) **REMOVED:** Language requiring a "reading teacher" be certified under AS 14.20 in AS 14.30.765(l)(2). (SEDU)
- **Page 20, Lines 7-13:** Amends AS 14.30.770, Department Reading Program, to determine the eligibility pool for direct support as determined by AS 14.03.123. (SEDU)
- Page 21, Line 18: Corrects drafting error. (SEDU)
- **Page 21, Lines 26-30:** Inserts subsection 10 to AS 14.30.770 to establish a panel of educators, administrators, and parents to periodically review implementation of The Alaska Reads Act. (SEDU)
