FISCAL NOTE ANALYSIS

STATE OF ALASKA 2020 LEGISLATIVE SESSION

BILL NO. HB189

Analysis

House Bill 189 adds a new section to AS 47.10 requiring notification to noncustodial parents and/or adult family members within 30 days after a removal of a child from their home. The section also requires the assigned Office of Children's Services supervisor to verify in writing the due diligence to locate the family members.

Federal law currently requires the Department to notify non-custodial parents and adult family members of the removal of a child from a child's home under 42 U.S.C. 671 (a)(29).

The Office of Children's Services has incorporated mandated relative searches and notifications into existing policy and practice, however, although federally required, there has never been state or federal funding specific to this task. Additionally, to assist in achieving the federal compliance, Alaska began providing general fund to Alaska Tribal Child Welfare Compact co-signers to perform diligent and ongoing relative searches. These relative searches are specific for children who fall under the Indian Child Welfare Act (ICWA) and are dedicated to finding all adult family members for that child. The Department does not perform these extensive relative searches for all children due to the lack of funding necessary to accomplish this task. For children who do not fall under ICWA, the Department identifies adult family members through interviews with the parents and searches of Department databases. While this legislation does not mandate an extensive relative search, in order to notify all adult family members, a diligent relative search would need to be performed.

To ensure a robust relative search with timely notifications for all children to non-custodial parents and all adult family members, the Office of Children's Services estimates the total cost at \$908.5. This amount is based on the 1,619 children removed from the home in calendar year 2019. It takes an average of ten hours for each relative search and notification, at an average personal services cost of about \$56.11/hr. Out of the \$908.5, \$312.8 is compacted with Co-signers of the Compact specific to relative searches for service populations designated in individual Tribal Support Services Funding Agreements. The balance, \$595.7, would be necessary to ensure compliance with the proposed statute for all children.
