FISCAL NOTE ANALYSIS

STATE OF ALASKA 2020 LEGISLATIVE SESSION

BILL NO. SB 176

Analysis

This bill defines and establishes concentrations limits for per-and polyfluoroalkyl substances (PFAS) in drinking water. It requires that the Department of Environmental Conservation periodically test all drinking water in areas where PFAS has been released near a drinking water source. If results are above the limits established by the bill, it requires the Department to provide alternative drinking water. While the Division of Spill Prevention & Response would maintain authority to conduct site characterization, testing, and monitoring, the Drinking Water program in the Division of Environmental Health has the expertise to ensure drinking water is safe.

The Department does not currently have regulatory authority over private drinking water systems. Changes to 18 AAC 80 will be required to add regulatory requirements for, and authority over, private water systems relative to PFAS releases. As these systems are not currently regulated, it is unclear what the universe of private drinking water systems is that could potentially be impacted.

Personal Services:

The Division of Environmental Health would require four additional positions. Three Environmental Program Sepcialists would conduct work specific to evaluating testing data, developing a database of impacted private drinking water systems, providing technical and compliance assistance to owners/operators of contaminated private drinking water systems, ensuring data integrity and availability of certified private drinking water laboratories, and coordinating with other local, State, and federal agencies. An Engineer would review and approve proposed treatment systems for contaminated private drinking water systems.

Travel:

Travel would be required for program staff to conduct site visits and inspections, provide outreach to impacted Alaskans, and for staff training. Some out of state travel may be required.

Services:

Contractual costs include maintenance of a database system to track private water systems contaminated with PFAS in the State. It is also expected outreach materials would be developed and distributed in areas with impacted private drinking water systems. The Department would also require assistance from the Department of Law to develop regulations, as well as to advise the program as needed.
