Analysis

| This bill amends AS 47.30 by adding a new section relating to temporary emergency protective custody at a correctional facility to limit placement only in those situations where a designated treatment facility, evaluation facility, crisis stabilization center, or health care facility either lacks the capacity to safely admit the person in a reasonable amount of time or is not available within the community. The bill limits protective custody to the amount of time necessary to transport the person to a clinically appropriate designated treatment facility or evaluation facility. |

| This bill further requires that the Department of Corrections (DOC) notify the Department of Health and Social Services as soon as practicable when a person is placed in emergency protective custody, and that the DOC make reasonable efforts to protect the person's health and safety while in protective custody including providing physical and mental health treatment either in person or using telehealth. These are services the DOC already provides to individuals being held in emergency protective custody, as necessary. |
| Passage of this bill is not expected to result in a fiscal impact to the DOC. Therefore, a zero fiscal note is being submitted. |
