## **A BILL**

## FOR AN ACT ENTITLED

"An Act relating to allowable absences for a permanent fund dividend."

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

\* Section 1. AS 43.23.005(a) is amended to read:

(a) An individual is eligible to receive one permanent fund dividend each year in an amount to be determined under AS 43.23.025 if the individual

(1) applies to the department;

(2) is a state resident on the date of application;

(3) was a state resident during the entire qualifying year;

9 (4) has been physically present in the state for at least seven [72] 10 consecutive days [HOURS] at some time during the prior two years before the current dividend year;

(5) is

- (A) a citizen of the United States;
- (B) an alien lawfully admitted for permanent residence in the

United States;

(C) an alien with refugee status under federal law; or 1 2 (D) an alien that has been granted asylum under federal law; 3 (6) was, at all times during the qualifying year, physically present in the state or, if absent, was absent only as allowed in AS 43.23.008; and 4 5 (7) was in compliance during the qualifying year with the military selective service registration requirements imposed under 50 U.S.C. App. 453 6 7 (Military Selective Service Act), if those requirements were applicable to the 8 individual, or has come into compliance after being notified of the lack of compliance. 9 \* Sec. 2. AS 43.23.005 is amended by adding a new subsection to read: 10 (i) Notwithstanding (a) - (c) of this section, an individual who was absent from the state for more than 120 days during the qualifying year is not eligible for a 11 dividend. The limitation in this subsection does not apply to an absence for a reason 12 13 listed in AS 43.23.008(a). \* Sec. 3. AS 43.23.008(a) is amended to read: 14 15 (a) Subject to (b) and (d) of this section, an otherwise eligible individual who 16 is absent from the state during the qualifying year remains eligible for a current year 17 permanent fund dividend if the individual was absent 18 (1) receiving secondary or postsecondary education on a full-time 19 basis; 20 (2) receiving vocational, professional, or other specific education on a 21 full-time basis for which, as determined by the Alaska Commission on Postsecondary 22 Education, a comparable program is not reasonably available in the state; 23 (3) serving on active duty as a member of the armed forces of the 24 United States or accompanying, as that individual's spouse, minor dependent, or disabled dependent, an individual who is 25 26 (A) serving on active duty as a member of the armed forces of 27 the United States; and 28 (B) eligible for a current year dividend; 29 (4) serving under foreign or coastal articles of employment aboard an 30 oceangoing vessel of the United States merchant marine; 31 (5) receiving continuous medical treatment recommended by a

licensed physician or convalescing as recommended by the physician who treated the 1 2 illness if the treatment or convalescence is not based on a need for climatic change; (6) providing care for a parent, spouse, sibling, child, or stepchild with 3 a critical life-threatening illness whose treatment plan, as recommended by the 4 5 attending physician, requires travel outside the state for treatment at a medical specialty complex; 6 7 (7) providing care for the individual's terminally ill family member; 8 settling the estate of the individual's deceased parent, spouse, (8) 9 sibling, child, or stepchild, provided the absence does not exceed 120 [220] 10 cumulative days; (9) serving as a member of the United States Congress; 11 (10) serving on the staff of a member from this state of the United 12 13 States Congress; (11) serving as an employee of the state in a field office or other 14 15 location; 16 (12) accompanying a minor who is absent under (5) of this subsection; 17 (13) accompanying another eligible resident who is absent for a reason permitted under (1), (2), (5) - (12), or (16) - (18) [(16), OR (17)] of this subsection as 18 19 the spouse, minor dependent, or disabled dependent of the eligible resident; 20 (14) serving as a volunteer in the federal peace corps program; 21 (15) because of training or competing as a member of the United States 22 Olympic Team or a United States national team for an Olympic sport; 23 (16) participating for educational purposes in a student fellowship 24 sponsored by the United States Department of Education or by the United States 25 Department of State; 26 (17)participating in a maritime registered apprenticeship 27 program under 29 U.S.C. 50; 28 (18) for any reason consistent with the individual's intent to remain a 29 state resident, provided the absence or cumulative absences do not exceed 30 (A) **120** [180] days in addition to any absence or cumulative 31 absences claimed under
