Please accept the following comments from Rick Delkittie, Sr., of Nondalton, Alaska. Mr. Delkittie called into the Friday, August 28 hearing, but was unable to share his testimony. He does not have email access, and so I submit them on his behalf:

Thank you for this opportunity to comment on the nomination of Abe Williams to the Alaska Fisheries Board. I used to fish commercially in Bristol Bay. I am a hunter gatherer. I am Dena'ina, 64 years old. I have been eating salmon all my life, as my people have for the past ten thousand years.

For the fisheries board of directors, on any issue that they have to address on behalf of their department, there has to be 100% participation. Every director has to have the ability to address the issues, and not have any conflicts of interests where they have to bow out, and say they have to step aside and not be a part of the board to address a specific issue.

I feel that anyone who is on that fisheries board needs to be representing We The People. They should have that ability. I feel that is so important in this part of the world over here. A great number of people – not only in this region – but in this nation, agree with those who oppose Pebble Mine. It just doesn't fit in this area. There is too much water.

It is clear that Mr. Williams does have conflicts of interest, and will not be able to represent We The People, particularly on the issue of Pebble Mine and its threat to salmon.

## Testimony Rebecca Knight Senate Resources Committee-(re. Board Of Fish) August 28, 2020

Hello Committee & Chair,

I am a resident of Petersburg. My family has fished Bristol Bay since 1991, including myself, my husband, my three sons and their respective families for a directly affected total of 8 individual family members. This does not include our crews who also have dependent families. We are heavily invested in the Bay, and a large chunk of our annual incomes are derived from the Bristol Bay fishery. I was heartened to hear Mr. Jensen's earlier recognition of the importance of the Board's decision today making process and its impact on future generations.

The proposed Pebble mine threatens our collective, long-time livelihoods as well as the decisions made by the Board of Fish. For this reason, I ask that you do not appoint Abe Williams to the Board due to his affiliation with the Pebble Partnership. To do so would introduce a level of bias that quite simply would destroy the public's confidence in the Board of Fish process.

Mr, Williams has been employed by the Pebble Partnership for 10 years and has been the Director of Regional Affairs for two years while collecting a quite lucrative salary of between \$100 -\$200 thousand during only a fourth month period. This is a direct conflict of interest and should immediately disqualify him from consideration because of the huge controversy that the proposed Pebble mine poses. Mr Williams duties with Pebble, seemingly as a as a de-facto lobbyist for the Pebble Partnership's agenda, would introduce conflict right out of the starting block. The Board has much hard work to do, especially during a time of struggling/declining fisheries. Spending time on the controversy revolving around his conflicts of interest would mean diverting already scare time away from working on these vitally important issues.

Certainly there are much more qualified and non-conflicted individuals who could represent the fishing community instead of the immediate conflict upon appointment, introduced by Mr. Williams association with the Pebble Partnership. The Board of Fish needs members who can vote on as many issues as possible without automatically being conflicted out.

Please reject Mr. Williams appointment to the Board of Fish.

## **RE: Governor's BOF Appointees**

Thank you for the opportunity to testify on Friday August 28, 2020, and again this upcoming September 3<sup>rd</sup>. To recap a couple of important issues that are of great concern to the fleet of fishermen I represent.

The BOF candidate selection and confirmation process are BROKEN. I understand it might not be an easy fix, but what worth doing is ever really easy. When well-rounded individuals with years of exemplary service to fisheries around the state are put forth as candidates yet not forwarded, while those with no experience are; the system is BROKEN. Our fisheries and fisheries resources are too important to have people "cut their teeth" on.

NO candidate should be able to sit and make judgement decisions that affect the lives and livelihoods, or historic cultural opportunities of the people of Alaska without first being confirmed. I implore the Senate and House to work together on legislation and/or amendments to the Alaska State Constitution if necessary, to correct this issue. People who are given such power should be seasoned, knowledgeable, and **fully vetted by the confirmation process**, period. I understand the reasoning behind the current language, but that intent has been overshadowed by appointments made intentionally when there is not time to confirm. These expiring terms happen at scheduled times and are not a surprise. The selection, vetting, and confirmation process should start a year out from any given expiring seat to allow for a seamless and consistent sitting Board of Fisheries.

SEAS' fully supports the re-appointment of Mr. Jensen. Member Jensen has served since 2003 and has a wealth of knowledge about Alaska's fisheries. He has demonstrated his approachability to all stakeholders, his knowledge concerning complex user group dynamics, and concern for the fisheries resource as a renewable asset to the state and all its users. Additionally, he is the lone voice of SE Alaska and of coastal communities; **we recommend his confirmation.** 

SEAS' agrees with the many callers on Friday that expressed that coastal communities are not adequately represented in the current slate of appointees. We understand that there are no "set" seats, yet there has always been an understanding that any BOF that makes resource decisions throughout the state should also have balanced statewide representation to have any real credibility.

Lastly, while on the subject of coastal representation. There was a name submitted to the Governor, a BOF member whos' term had expired. He had extensive knowledge of all the states fisheries, had demonstrated the desire and capability to understand the diverse issues and deliberate with fairness concerning all user groups, and he did the hard homework. His name- Robert Ruffner, not forwarded for confirmation, yet instead people with absolutely NO knowledge or experience are on your list today; that's criminal! It's an indictment on the many people who depend on this process to ensure the health of the resource and the ability to gain their livelihood from it whether they be commercial, subsistence, or sport fishermen. We wish to thank Mr. Ruffner for his exemplary service and years of dedication to the process. His re-appointment would have served to add coastal representation not to mention much needed experience and knowledge to the BOF.
