# Executive Order No. 119 Sectional Analysis

## Section 1: Findings of the Governor

## Section 2: Amends AS 08.68.700 Determination of Death by Registered Nurse

The change made in subsection(g) of AS 08.68.700 was made to clarify that the regulatory authority under this section will be with the Department of Health.

The change under subsection (g) to the definition of "health care facility" was to ensure that the Department of Health and Social Services did not have regulatory authority over another department's division. The Executive Order places the oversight and management of the Alaska Pioneer and Veterans Homes in the Department of Family and Community Services. This change does not preclude the Alaska Pioneer Homes and Veterans Homes form working with primary care physicians of their residents relating to the issuance of death certificates for residents.

Section 3: Amends AS 11.71.100 Controlled Substances Advisory Committee Amends the name of the Commissioner of the Department of Health & Social Services to the Commissioner of the Department of Health.

Adds the Commissioner of the Department of Family & Community Services or designee to the Controlled Substances Advisory Committee.

Provides that individuals and entities subject to the requirements of a criminal history check for foster homes, child placement agencies and runaway shelters may be submitted by the Department of Family and Community Services for the licensure, license renewal, certification, or certification renewal for the individual or entity.

- 8. Adopt regulations, defining need, prescribing the conditions for eligibility for assistance, and establishing standards for determining the amount of assistance that an eligible person is entitled to receive
- 9. Grant to a person claiming or receiving assistance and who is aggrieved because of the department's action, reasonable notice and an opportunity for a fair hearing by the Office of Administrative Hearings
- 10. Enter into reciprocal agreements with other states relative to assistance, welfare services, and institutional care
- 11. Establish the requirements for residence for assistance, welfare services, and institutional care that are considered advisable
- 12. Establish the divisions and local offices that are considered necessary to carry out a duty or authority assigned to it and employ personnel that are necessary to carry out the work of the divisions and offices
- 13. Actively seek to recruit quality foster parents and adoptive parents
- 14. Cooperate with and facilitate programs administered by the Department of Health
