You have asked about the effect of the use of the word "may" in AS 08.04.195(d) and the word "shall" used in AS 08.04.240(a).

AS 08.04.195(d) concerns the renewal of a license issued under the reciprocity license provisions of AS 08.04.195(a). AS 08.04.195(d) provides that the Board of Public Accountancy (board) *may* renew a license issued under AS 08.04.195 if the licensee complies with certain requirements. The word "may" as used in AS 08.04.195(d) exists in current statute and CSHB 44() does not add the word "may" or otherwise amend that word as it appears in AS 08.04.195(d).

AS 08.04.240(a) concerns the application of a firm for a permit to engage in the practice of public accounting. The subsection provides that the "board *shall* grant a permit to engage in the practice of public accounting" to a firm that meets certain requirements. The word "shall" as used in AS 08.04.240(a) exists in current statute, and CSHB 44() does not add the word "shall" or otherwise amend that word.

The word "shall" is used to impose a duty, and the word "may" is used to grant a privilege or a discretionary power. The use of the word "shall" in AS 08.04.240(a) imposes a duty on the board to issue a permit to a firm that meets the statutory requirements. The use of the word "may" in AS 08.04.195(d) allows the board to renew a license issued under AS 08.04.195(a) (licensure by reciprocity), but does not obligate the board to issue the license. You may want to reach out to the board for information regarding the board's process for renewing a license under AS 08.04.195(d), and whether the board has ever declined to renew a license under AS 08.04.195(d) for an applicant who was eligible for renewal.
