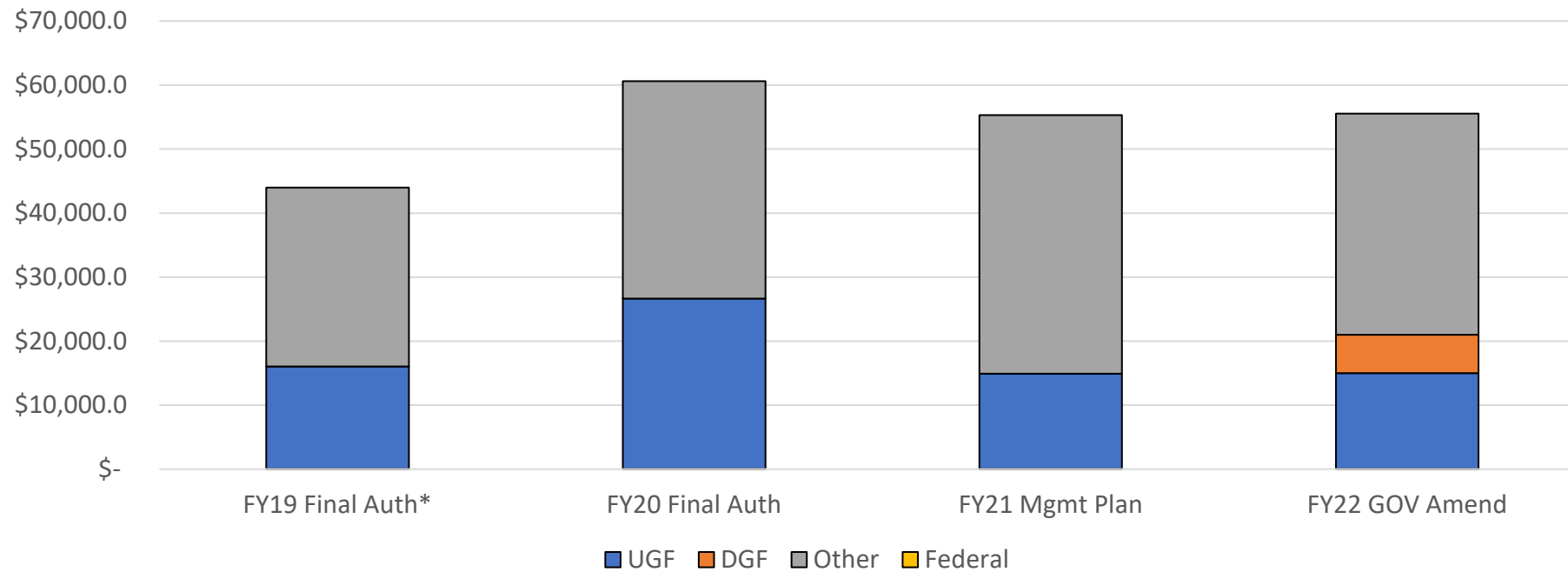

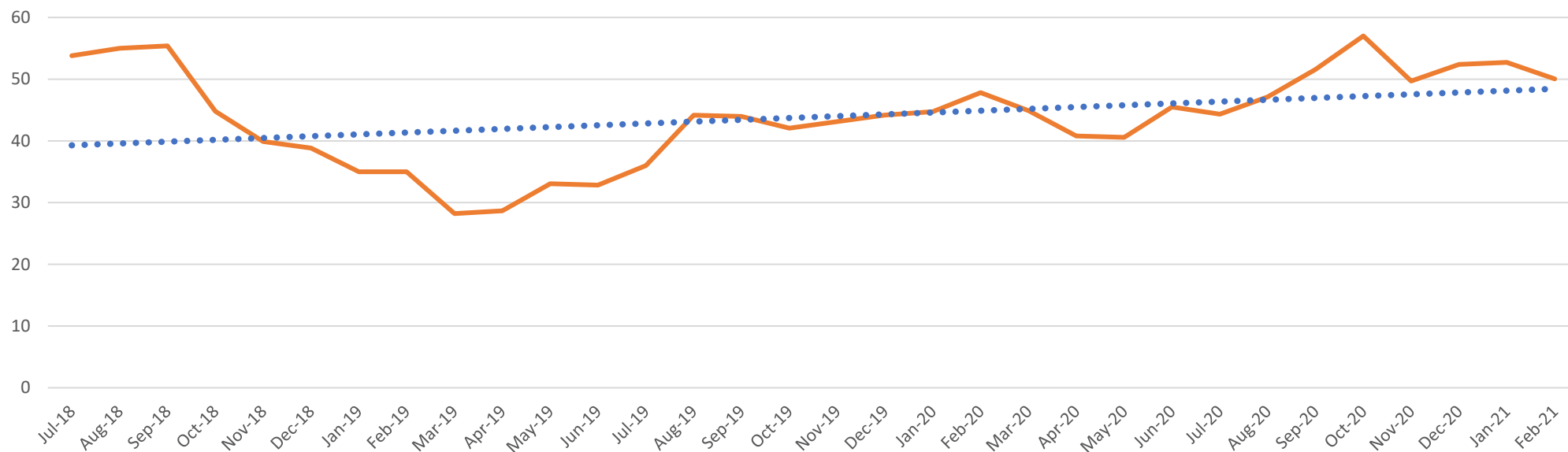

- Civil waitlist is a group of civil respondents that have been ordered to go to API for Title 47 (“health and safety”) evaluation but have not yet been admitted.
- Forensic waitlist is a group of criminal defendants that have been ordered to go to API for Title 12 restoration, restoring their ability to understand and participate in their criminal trial, but have not yet been admitted.

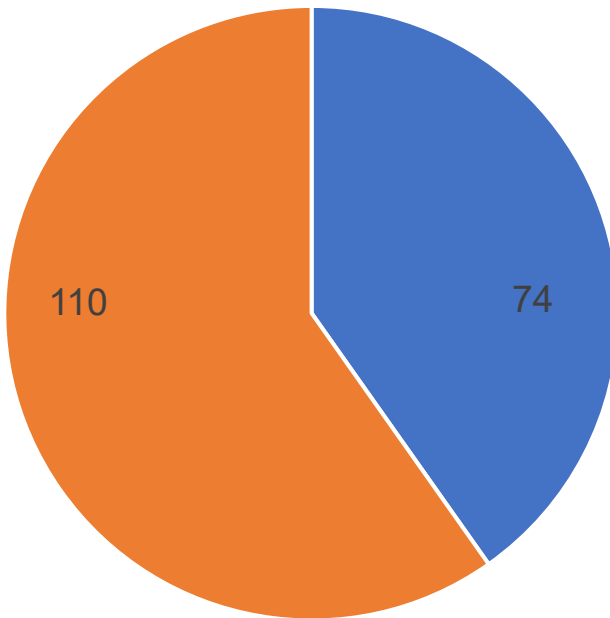

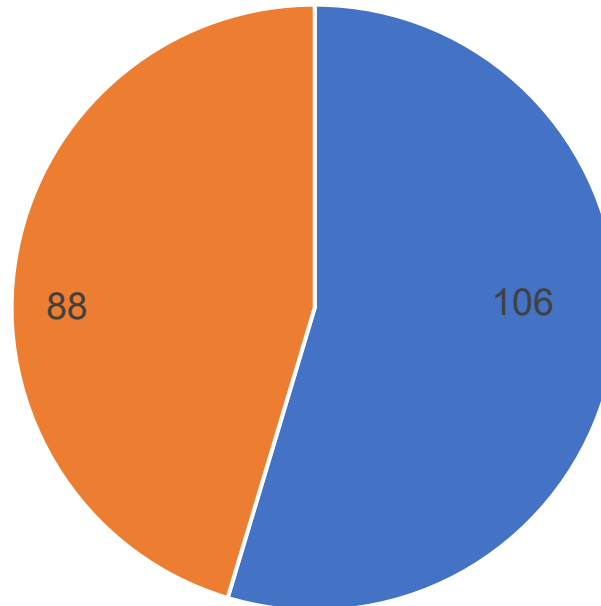

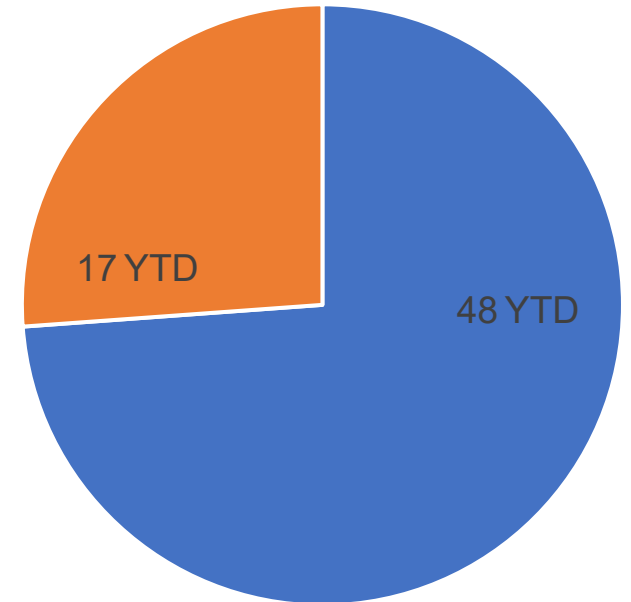
FY2020

Alaska Psychiatric Institute: Regulatory Compliance

2019 Progress With Regulatory Findings - 396 Citations

- Continued citation follow up includes:
 - Monitoring of treatment plan coordination of medical appointments
 - Seclusion and restraint monitoring
 - Resolve of non-ligature furniture
- 2020 Surveys (based on complaints)
 - Alaska Occupational Safety and Health
 - Centers for Medicare & Medicaid Services - 2
- Citation Resolution Completed
 - Monitoring of infection control training compliance



Alaska Psychiatric Institute – Future Vision

- Increase capacity to 80 beds by December 31, 2021
- Open Chilkat Adolescent Unit 2nd Quarter 2021
- Hire
 - Clinical Services Director – March 2021
 - Medical Director – March 2021
- Improve the therapeutic clinical program
 - Seven day a week programming
- Establish and/or improve relationships with community partners
- Be a leader within the Alaska community to identify gaps in the mental health infrastructure
- Take part in the development of solutions to assist with:
 - Complex discharges
 - Establishing specialty programs for individuals that require a long-term residential care beyond API
- Developing and training staff at all levels to be confident and proficient in their positions
