\$1,175.8 is lapsed authority associated with allocated funding that is restricted in use. This authority can only be used for the specified purposes and any remaining authority is lapsed back into the fund it was allocated from. This amount includes the following fund sources:

Mental Health Trust Authority funding Recidivism Reduction funding

\$16,245.9 is lapsed authority associated with the Palmer Correctional Center start-up funding. This funding was allocated as Power Cost Equalization (PCE) funding through the fiscal notes associated with passed legislation Chapter 4, FSSLA 19 (HB49). \$16,000.0 of this lapsed PCE funding was extended through the FY2021 budget process with a new term date of June 30, 2021 to allow for the continued construction efforts to reopen the facility. The remaining balance of unspent funds were lapsed back to the PCE Fund.

Department of Corrections FY2020 Lapse Summary

The overall general fund (UGF) lapse for all Divisions was \$17,948.6 which was returned to the general fund. The amount lapsed by Division is as follows:

\$5,387.4 UGF lapse within the Division of Institutions is related to the following circumstances:

\$1,925.6 UGF in one-time funding was added in the FY2020 budget to increase the CRC bed capacity by 100 beds. As this was one-time funding, these beds were not added until late in FY2020 resulting in the lapsing of these funds. This funding was reversed out of the budget in FY2021.

\$1,000.8 UGF in one-time funding was added to increase the number of Electronic monitoring participants by 100. There was not sufficient eligible offenders that applied for the EM placement to meet this increased capacity resulting in the lapsing of a portion of the one-time funds. The one-time funding was reversed from the budget in FY2021.

\$2,461.0 UGF was lapsed due to the excess authorization from the FY2020 supplemental. During FY2020, the Division of Institutions received \$7,595.7 in supplemental funding to meet operating expenditures. The amount lapsed is associated with excess authorization and expenditures covered by CARES funding.

\$9,818.6 UGF lapse within the Division of Health & Rehabilitation is related to the following circumstances:

This lapse is primarily related to the COVID-19 pandemic impacts. When DOC activated its COVID Response Plan in late March/early April 2020, it meant that all non-urgent & non-emergent medical procedures were postponed. This was similar to what was put in place for many communities, a shut-down of nonessential services. These efforts included postponing expensive hepatitis C treatments for offenders in certain categories. Additionally, most medical contracts were suspended in an ongoing effort to protect the facilities from outside entities who could potentially bring the virus into the congregate settings. These efforts are the primary drivers causing the FY2020 lapse in this division.

\$2,455.5 UGF lapse within the Division of Pretrial, Probation & Parole is related to the following circumstances:

\$2,060.8 UGF was lapsed primarily associated with vacant Adult Probation Officer (APO) positions and reduced caseloads. For efficiency purposes, Adult Probation Officer positions are filled based on caseload counts and as caseload fluctuate, positions are transferred to other locations to meet the caseloads or are left vacant pending the changes in the caseload counts. The reduction of the caseloads and vacant positions has resulted in the lapse of these funds.

The caseload capacity is identified in AS 33.05.040 which limits the number of cases that can be assigned to an APO to 75 per officers requiring the DOC to have funded positions to meet the offender population that are released to probation/parole supervision.

\$394.7 UGF was lapsed associated with staffing turnover and vacancies as well as suspended travel due to COVID-19.

\$187.4 UGF lapse within the Division of Administrative Services is related to the following circumstances:

This lapse was associated with staffing turnover and vacancies as well as suspended travel, technology equipment delays, and inmate records shipping/imaging delays due to COVID-19.

\$99.9 UGF lapse within the Board of Parole is related to the following circumstances:

This lapse was associated with staffing turnover and vacancies as well as suspended travel due to COVID-19.
