Honorable House Finance Committee Members:

I write on behalf of my clients the Alaska Wild Sheep Foundation and the Alaska Professional Hunters Association who are working with a coalition of non-profit fish and wildlife conservation groups in support of HB 128.

First we thank you for your time and consideration of this important reform that will benefit Alaska non-profit charitable gaming permittees broadly. Our goal is to work towards passage of HB 128 this session, therefore we want a version that generates broad consensus within the legislature.

My clients worked with the fish and wildlife non-profit coalition to develop consensus points that are incorporated in Representative Rasmussen's amendment. We support incorporation of her amendment today in Hfin.

My clients do not fully understand the policy implications of Representative LeBon's amendment dropped yesterday, Sunday @ 1PM. Expedited requests for legal analysis have resulted in a cursory opinion that the LeBon amendment will provide an avenue for a significant expansion of gaming. The extent and real world implications of this expansion are not clear. Given our priority of securing passage of this bill inline with the response to the discussion initiated by the expiration of the disaster declaration we are unable to support that amendment at this time. We simply have not had enough time to understand the effects or implications of these changes and we do not want to see HB128 stalled.


As always, we defer and trust your process. We have done our best to understand Representative LeBon's amendment in the few business hours we have had leading up to today's hearing but more questions than answers remain.

This letter is written in support of HB 128: Use of Internet for Charitable Gaming. Since the temporary guidance was enacted, Monroe Foundation, Inc. has held two raffles which may not have been possible otherwise. Both raffles were very successful. In large part, we owe the success of these events to our government representatives who worked to give nonprofits the ability to sell raffle tickets online.
