A brief summary of the exemptions allowed under AS 42.05.711(r):

- 1. AS 42.05.221 42.05.281 Requires a public utility to have a certificate of public convenience and necessity before providing service. States a public utility cannot discontinue or abandon a service without RCA approval. Requires a public utility to pay the RCA regulatory cost charges.
- 2. AS 42.05.291 42.05.351 States each public utility shall furnish and maintain adequate, efficient, and safe service and facilities. A public utility may not establish or provide an unreasonable difference to service.
- 3. AS 42.05.361 42.05-441 Rates are to be just and reasonable and are to be stated in a tariff for RCA approval. A change in the public utility's tariff requires RCA approval.
- 4. AS 42.05.451 42.05.501 Requires a public utility to keep account and reports according to the uniform system of accounts. The RCA has authority to inspect the books and records of a public utility.
