Dear Senator Bishop and Senator Stedman:

This letter presents responses to the Senate Finance Committee member questions received by the Department of Health and Social Services (DHSS) at the Monday, March 29, 2021 Senate Finance Committee hearing on HB 76 Extending COVID-19 Disaster Emergency.

Senator Wielechowski Referencing Page 5, lines 7-8, the appropriation made in sec. 37(a), ch. 8, SLA 2020, of excess federal receipts received during the Fiscal Year ending June 30, 2021 – how much excess federal receipts did DHSS receive under Sec. 37(a) and how much has the department spent?

The legislature has approved a total of \$426.6 million in federal funding through the revised program legislative (RPL) authority provided in the FY2021 budget bill section 37 (a). Of this funding, only \$379.7 million was tied to federal funding for the coronavirus (COVID-19) pandemic. Attached to this letter is a document with further details on the approved FY2021 RPLs.

Senator Wilson: What regulations have been suspended that pertain to telehealth, particularly those regulations related to telehealth for behavioral health?

Dear Senator Stedman,

During the Senate Finance Committee meeting on Monday, March 29th, Senator Wielechowski asked a question that required follow up from DMVA. Question and the corresponding answer are below.

Senator Wielechowski: Was this authority used at all between January 15<sup>th</sup> and February 14<sup>th</sup>? If so, how much? Or have we just been using the authority provided under SB 241 for using funds from the Disaster Relief Fund (DRF)? How much has been spent from the Disaster Relief fund for SB 241 or another subsequent disaster declaration? *(regarding the section HB 76 authorizing the spending of \$10 million from the Disaster Relief Fund)* 

DMVA used the \$10,000,000 authorized in SB241 to allocate \$7,000,000 into the two COVID-19 declared disasters:

- AK269 (State)
- DR4533 (Federal)

The majority of these allocated funds will be returned to the unallocated balance of the DRF based on the fact that CARES Act funds can be utilized. DMVA anticipates an estimated need of \$1,000,000 of the authorized DRF funding for any items of State Management that are not eligible for reimbursement from either FEMA or CARES Act funding over the life of this disaster.

To date, there is approximately \$1,800,000 obligated between the State and Federal disasters. The department anticipates the majority of those obligations to be reimbursed by either CARES Act funding or FEMA.

With FEMA allowing payments to come from CARES Act funding instead of FEMA/State funding, DMVA can now reallocate up to \$6,000,000 of State funds to the 2018 Cook Inlet Earthquake and/or the 2020 Southeast Storm.
