






## Wasilla stops short of ATV ban in approving new rules

WASILLA -- All-terrain vehicles are still welcome within Wasilla city limits -- provided riders park them by 10 p.m., avoid danger or destruction, and carry a valid driver's license.

That's a paradigm shift in this still-growing city of about 9,000 where people on snowmachines and four-wheelers were once accustomed to free rein but now trigger complaints about riders speeding, churning up fresh grass or spitting up bike path gravel.

The new ATV regulations, approved by the Wasilla City Council Monday night in a 5-1 vote, represent the city's way of avoiding a total ban.

Dozens of agitated riders came out for public hearings last year after the council floated the idea of prohibiting ATVs altogether. The owner of an ATV rental business near downtown Wasilla said he gathered thousands of signatures opposing a ban, though it wasn't clear how many came from city residents.

None of those people attended Monday night's meeting, which drew a small crowd only because a new downtown overlay district was on the agenda.

The new regulations are based on recommendations of a six-member task force that met four times between January and March after the council put off a decision on a ban. But officials say they still



## Strategy 1: Implement education/awareness practices to enhance off-highway vehicle safety.



#### ACTION 1.1

### Conduct public education and outreach to raise awareness of OHV safety issues

ATVs and snow machines are common forms of transportation, especially in rural Alaska where quite often they are the main or only modes of transportation. These OHVs are often used as work vehicles and vehicles that provide general mobility. While most ATV and snow machine travel occurs off the road, these vehicles also travel within the road rights-of-way (ROW). Snow machines and ATVs are allowed within the State Road ROW, but not on the road surface itself. Data collected by state agencies show that

crashes and injuries are occurring within and outside the highway ROW. The purposes of this strategy are to educate Alaskans about the dangers of OHV use and the importance of safety while using these vehicles.

#### ACTION 2.1

### Establish a multiagency task force to address OHV safety issues

#### Background

No one state or public agency has purview over off-highway vehicle (OHV) use or training in Alaska. Grashes involving ATVs and snow machines were identified as a significant safety issue for Alaska during the 2003 Safety-Conscious Planning Summit. The purpose of the multiagency task force would be to further examine this problem and the data available related to this problem; identify potential solutions or strategies that can be implemented at the

local level; study what has been done and what has worked in other states and communities that have significant OHV use; implement effective strategies; and raise the overall visibility of this issue with the public, local governments, and the legislature.

#### Objective

Greater collaboration among agencies and organizations (public and private) with an interest in OHV use in Alaska.



"A number of users of Alaska's highway system are those on vehicles traditionally considered offhighway vehicles (OHVs): all-terrain vehicles (ATVs) and snow machines. Many Alaskans rely on ATVs and snow machines for work, basic transportation, and recreation. While OHVs are not being studied as an emphasis area, this transportation mode has Alaska-specific uses and crash patterns and the users of these vehicles should therefore be considered as part of the Special Users emphasis area."

Figure 2.21 Off-Road Vehicle Fatalities, 2011-2017





Figure 2.22 Off-Road Vehicle Serious Injuries, 2011-2016



## **OBJECTIVE**

The objective was to develop a holistic framework that considers what data currently exists, what data is needed, and what the status of conflict and safety concerns exist for OHVs on and near to roads, highways, and other transportation infrastructure. This research addresses the need for both safety and travel demand data in rural areas where the frequency of off-highway roadside users are generally considered to be negligible, un-reported, or non-existent. The results and deliverables of this research contribute significant knowledge for this specific special user group.


## APPROACH PT. 2

Review crash data, specifically the injury data published by the Alaska eHealth network to supplement previous analysis of the Alaska State Motor Vehicle Crash Database and the Alaska Vital Statistics Trauma Registry with consideration of:

- a. Crashes occurring on/near public roads and public facilities (e.g., pedestrian or multi-use)
- b. Crashes involving ATVs/OHVs occurring on the traveled way
- c. Crashes involving ATVs/OHVs occurring off the traveled way but within ROW of the highway corridor; and
- d. Crashes resulting from crossing a public facility to get to a non-traveled way trail versus crashes resulting from using the traveled way.


### ALASKA TRAUMA REGISTRY TOTALS 2009 - 2014


with percent of records occurring on roads or within right-of-way




### ALASKA TRAUMA REGISTRY TOTALS 2009 - 2014

National media was tracked for the period of July 1, 2017, through June 30, 2018; and

- The analysis yielded 1,327 articles in total, 812 (61.2%) of which dealt with on-road OHV use and 18 of which were from Alaska; and
- 482 articles covered on-road incidents that resulted in severe injury or fatality, 297 articles covered issues related to on-road policies, and 33 articles discussed issues related to education about on-road use; and
- 10 of the articles from Alaska (55%) involved OHV fatalities.





The Specialty Vehicle Institute of America states that "ATVs are intended for off-road use only. Never operate an ATV on public roads, and always avoid paved surfaces. ATVs are not designed for use on public roads ..."

Consumer Federation of America (CSA) coalition members have signed onto over 230 letters in 26 states since 2014 advocating agains legistlations to allow OHVs on roads as they "are not designed for roadway use and therefore should not be allowed on public roads."
