Dear Senator Wilson:

As CEO of Providence Health & Services Alaska, I am writing in strong support of the extension of the Alaska Public Health Disaster Emergency Declaration, as authorized by SB 56.

Roughly one year ago, the first COVID-19 patient in the United States was treated at a Providence hospital in Washington. Providence caregivers have worked tirelessly to care for our families, friends, neighbors, and communities during this once-in-a-generation pandemic. I am humbled by the countless stories of amazing sacrifice, compassion, and heroism displayed by our caregivers and in our community this year. As we see promising rates of vaccinations in Alaska, we can finally look toward positive days ahead. However, we cannot lose site of the policies that will take us there.

The COVID-19 response has required the health care community to act nimbly and creatively while delivering care and protecting our most vulnerable patients. The state and federal government acted swiftly during the beginning months of the COVID-19 pandemic to provide hospitals and the health care community with tools necessary to deliver care and protect public health. This partnership continues to save lives.

The state's Public Health Emergency Disaster Declaration is the foundation for the framework that allows hospitals and providers to partner with the state and federal government to access walvers, flexibilities, and disaster relief. Some examples of partnerships that are made possible because of the state emergency declaration include<sup>1</sup>:

- Waiving physical premises and other site-specific requirements, allowing hospitals to partner on off-site COVID-19 testing and alternative care sites.
- Requiring state-regulated insurers to waive cost shares and onerous prior authorizations for COVID-19 testing and treatment.
- Monitoring COVID-19 patients safely from their homes, thereby augmenting critical capacity, reducing additional potential exposures, and the need for hospitalizations.
- Providing telehealth for vulnerable Medicare patients without a prior physical examination.

- Expediting the professional licensure and renewal process, allowing physicians and nurses to work across state lines, providing relief during times of critical workforce shortages.
- Allowing businesses to manufacture and distribute PPE and the ability for hospitals to safely sanitize existing supplies during times of extreme shortages.
- Allowing Alaskans with existing serious health conditions to maintain their out-of-state provider relationships through phone and telehealth, while travel restrictions make in-person visits impossible.
- Increased federal aid, including the Federal Medical Assistance Percentage (FMAP) and CARES Act funding.

The pandemic has brought dual health and economic impacts and many Alaskans are also financially struggling. This is evident by the increased demand on social service organizations that provide to those in need. Without a state disaster declaration in place, many of these organizations will not be able to access critical federal funding for food and housing insecurity. We have been monitoring a similar discussion in Wisconsin, whose legislative budget office estimated a monthly loss of \$49 million in federal food aid without a state disaster declaration.

We appreciate Governor Dunleavy for introducing SB 56 and we thank you for your consideration of this important legislation. It has been a long year with many sacrifices, and we can't falter in our response and resolve now. Please pass SB 56 as soon as possible, allowing all of us to continue caring for Alaskans in partnership and with the best tools available.

The Key Coalition of Alaska, representing a large coalition across the state of Alaska made up of people experiencing disabilities, their family members, and providers of service is adding our collective voice to urge the adoption of SB 56 to extend Alaska's Public Health Disaster Emergency Declaration.

The pandemic has taken a toll on all of us, and yet there is much to be grateful for, as Alaska has not experienced the mortality rates of people experiencing disabilities other states have witnessed. As frontline staff and those living in assisted living homes get access to vaccinations there is a glimmer of hope growing.

However, without the extension of the declaration and the access to federal funding and approved adaptations of services will further erode the potential of recovery and further restrict people with disabilities. It is critical flexibilities available through public health emergency declarations providing alternate service delivery modalities (telehealth, telemedicine), regulatory extensions (professional and occupational licensing), and travel considerations necessary to protect our native communities have enabled our service providers to remain as active partners in our statewide mitigation efforts are maintained through the declaration extension.

The Appendix K waivers approved by the Centers for Medicare and Medicaid Services (CMS) and related provisions are critical to maintaining essential supports under pandemic (and pandemic recovery) conditions. Alignment of the Federal and State approval is critical as the "blanket waivers" by CMS and SB241 provisions are renewed or extended throughout 2021.

We believe that this Act is essential for our state to recover its freedoms and economy, giving disability support providers as much flexibility as possible to adapt to rapidly changing challenges in this pandemic recovery year.

We strongly urge the HSS Committee to unanimously approve SB56 to extend the public health disaster declaration through September 30, 2021 for the benefit of our coalition members.
