## **A BILL**

# FOR AN ACT ENTITLED

- 1 "An Act relating to concurrent vocational education, training, and on-the-job trade
- 2 experience programs for students enrolled in public secondary schools; relating to child
- 3 labor; and providing for an effective date."

#### 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

- \* Section 1. AS 12.62.400(a) is amended to read:
- 6 (a) To obtain a national criminal history record check for determining a
  7 person's qualifications for a license, permit, registration, employment, or position, a
  8 person shall submit the person's fingerprints to the department with the fee established
  9 by AS 12.62.160. The department may submit the fingerprints to the Federal Bureau
  10 of Investigation to obtain a national criminal history record check of the person for the
  11 purpose of evaluating a person's qualifications for
- 12 (1) a license or conditional contractor's permit to manufacture, sell, 13 offer for sale, possess for sale or barter, traffic in, or barter an alcoholic beverage 14 under AS 04.11;

10	(9) a position involving supervisory or disciplinary power over a minor
11	or dependent adult for which criminal justice information may be released under

21	(a) The department shall
22	(1) exercise general supervision over the public schools of the state
23	except the University of Alaska;
24	(2) study the conditions and needs of the public schools of the state
25	adopt or recommend plans, administer and evaluate grants to improve school
26	performance awarded under AS 14.03.125, and adopt regulations for the improvement
27	of the public schools; the department may consult with the University of Alaska to
28	develop secondary education requirements to improve student achievement in college
29	preparatory courses;
30	(3) provide advisory and consultative services to all public school
31	governing bodies and personnel;

1	(4) prescribe by regulation a minimum course of study for the public
2	schools; the regulations must provide that, if a course in American Sign Language is
3	given, the course shall be given credit as a course in a foreign language;

22	consecutive years of improvement consisting of not less than two percent

26	continuing or discontinuing the department's intervention;
27	(17) notify the legislative committees having jurisdiction over

5	Sec. 14.35.100. State policy. It is the policy of this state to provide public
6	secondary school students over 14 years of age the opportunity to participate in
7	concurrent vocational education, training, and on-the-job trade experience programs
8	from nonsectarian agencies providing industry-standard instruction.
9	Sec. 14.35.105. Program contracts. (a) The department shall negotiate
10	contracts with agencies providing industry-standard instruction and certifications to
11	offer concurrent vocational education, training, and on-the-job trade experience
12	programs for students enrolled in a public secondary school.
13	(b) The department may establish minimum program eligibility standards.
14	(c) The department may not contract with a sectarian agency.
15	(d) A contract entered into under this section must include
16	(1) a description of the program, including the program curriculum and
17	the public purpose that the program supports;
18	(2) the number of eligible students over 14 years of age who may
19	participate in the program each year;
20	(3) the annual tuition for each student for program participation;
21	(4) the name and proof of industry-standard certification of each
22	instructor who will instruct students in the program;
23	(5) a statement that all instruction provided in the program meets
24	industry standards for apprenticeship or journeyman or equivalent certification, based
25	on agency accredited national, regional, or programmatic instruction standards;
26	(6) an explanation of the method by which the program will credit a
27	student for coursework that satisfies industry standards completed concurrently in a
28	public secondary school;
29	(7) program policies and procedures;
30	(8) the location and description of the agency;
31	(9) a statement that the agency will comply with all state and federal

1	requirements for receipt and use of public money;
2	(10) a termination clause providing that the department may terminate
3	the contract for an agency's failure to meet department educational goals or for other

9	provide to school districts, and publish on the department's Internet website a list of
10	concurrent vocational education, training, and on-the-job trade experience programs
11	that the department contracts with to provide concurrent vocational education.
12	(b) For each listed program, the department shall identify any geographic
13	attendance restrictions, program availability, and the districts that may participate in
14	the program.
15	Sec. 14.35.115. Student enrollment. (a) The department shall enroll in a
16	contracted concurrent vocational education, training, or on-the-job trade experience
17	program a student over 14 years of age who is enrolled in a public secondary school
18	eligible for the program and who submits a timely application. If the number of
19	applications for a program exceeds the capacity of the program or age group, the
20	department shall select students by random drawing.
21	(b) A secondary school shall pay the program tuition for an enrolled student
22	who participates in a contracted concurrent vocational education program in
23	accordance with the terms of the contract entered into under AS 14.35.105.
24	Sec. 14.35.120. Individual learning plan. (a) For each student enrolled in a
25	public secondary school who participates in a contracted concurrent vocational
26	program, the secondary school shall annually provide an individual learning plan
27	developed in collaboration with the student, the parent or guardian of the student, a
28	school counselor assigned to the student, and other individuals involved in the
29	student's learning plan.
30	(b) An individual learning plan must
31	(1) be developed with input from the counselor assigned to the student;

1	(2) provide for an in-school and concurrent vocational education
2	program course of study appropriate for the student's age and grade level consistent
3	with state and district standards;
4	(3) provide for an ongoing assessment plan that includes industry-
5	standard certification progress and statewide assessments required for public schools
6	under AS 14.03.123(f); and
7	(4) provide for monitoring of the student's work and certification
8	progress by the counselor assigned to the student.
9	Sec. 14.35.125. Instructor certification. (a) A person may not instruct
10	students in a concurrent vocational education, training, or on-the-job trade experience
11	program unless the person possesses a valid instructor certificate and an industry-
12	standard master skill certification or equivalent.
13	(b) The board shall establish requirements for the issuance of instructor
14	certificates by regulation.
15	(c) The board shall require instructors to submit fingerprints and the fees
16	required by the Department of Public Safety under AS 12.62.160 for criminal justice
17	information and a national criminal history record check. The board shall submit the
18	fingerprints and fees to the Department of Public Safety for a report of criminal justice
19	information under AS 12.62 and a national criminal history record check under
20	AS 12.62.400.
21	(d) The department may not issue an instructor certificate to a person who has
22	been convicted of a crime, or an attempt, solicitation, or conspiracy to commit a crime,
23	involving a minor under AS 11.41.410 - 11.41.460 or a law or ordinance in another
24	jurisdiction with elements similar to an offense described in this subsection.

If employed, the minor's work may be performed only between 5 a.m. and <u>10 p.m.</u> [9 P.M.] Employment outside school hours may not exceed 23 hours in one week, domestic work and baby-sitting excepted.
