We support SB 8 as a strong pathway to reading proficiency for all Alaskan Children. SB 111 weakens this effort in several ways. We address a few below:

• SB 8 emphasizes the importance of culturally responsive teaching and intervention. SB 111 eliminates this key component. We have wonderful diversity in Alaska. It can be a tool for improvement if used properly and must be acknowledged.

• The Parents as Teachers program helps parents to become partners in their child's learning. This is one great way to ensure cultural responsiveness, but the funding sunsets in SB 111. New parents are born with new children. That will not end and we need to continually help them to help their children. (most of us had no experience being a parent until we were a parent...this is an ongoing need.)

• Help for districts to implement effective pre-K programs sunsets. These programs will always be needed. We have no understanding of why we would stop this funding at any time.

• SB 111 also sunsets the ability for districts to count Pre-K students in their Average Daily Membership calculations. Again, why?

• Retention of young children remains a controversial decision. SB 111 takes the decision away from the folks that know the children best, the local school district.

The clauses that sunset funding for these important issues make no sense. Do we think the problems we see are going to vanish in a few years? Investing in children's learning is vital to Alaska's children.

Accredited teacher education programs must (and do) teach evidence based reading instruction practices. We would be better served to ensure that all teachers have access to continued learning as their careers continue and research evolves as well as helping teachers adjust to the needs of cultural responsiveness.

We support SB8 and oppose SB111!
