Dear Representatives Neal Foster and Kelly Merrick, and to the rest of the House Finance committee,

Thank you for this opportunity to testify today. My name is Angelica Afcan and I am a TWC board member.

Thank you to Rep. Merrick and the DPS subcommittee for their work to fully fund victim services through the Council on Domestic Violence and Sexual Assault. Unfortunately, we just learned that federal funding for life-saving advocacy and shelter services for victims and survivors is being cut by **34%** starting in FY2022. This will have devastating impacts across Alaska. Crime victims should not be expected to bear the brunt of these cuts.

**I'm here to stand for the domestic violence victims and their children who have no place to go, who feel stuck, and who need somewhere to heal and grow.**

Without the proper funding, shelters like TWC, Emmonak Women's Shelter, and others will not be able to be there for our communities.

We are reaching out to you to let you know that this is happening now. I see firsthand the importance these life-saving supports offered to victims. Please help us in community by finding a solution to this crisis before the end of session.

**Consider allocating state general funds to cover the gap created by the VOCA shortfall.**

Alaska continues to have some of the highest rates of sexual and domestic violence, including violence against children. Now is not the time to cut lifesaving services to victims and survivors of domestic and sexual violence.

Co-Chair Foster, Co-Chair Merrick, and Members of the House Finance Committee:

My name is Louis Imbriani, and I am an Eagle River Resident. I am writing to you regarding HB-69. I am writing on behalf of myself and I am not representing any special interest groups or organizations.

I had the opportunity to speak with Representative Merrick at the Eagle River Community Council Meeting on 4/8/2021. She had mentioned that the Permanent Fund may be in a separate bill. I do see it in the budget. I wanted to speak briefly about the PFD for this year. This year more than ever people need money in their hands.

The COVID-19 Pandemic has disproportionately impacted Alaskans. By paying the full PFD based on the original formula and paying Alaskans back for the PFD fund that were capped in previous years is needed. It is needed because there are those who need the money to pay bills and for those that don't need to pay bills, they will have more money to spend here in the community and supporting the struggling businesses.

Most businesses haven't recovered from last year's lack of tourists and this season is not looking much better. This is a year where recovery is needed, and the people of Alaska need the support. This is an excellent opportunity to give this much needed support. I know that you can find a way to fund the PFD while keeping the fund strong for future gains.

The previous year's cap on the PFD needs to go away. The cap on the PFD is a tax, and it is a disproportionate tax. Every PFD is taxed at the same rate with the cap. This means that a 6-year-old living in Bethel is getting taxed at the same rate as a Doctor in Anchorage.

The other issue that I wanted to bring up is pay for state employees. I know that each bargaining unit negotiates its contract there has been a disproportionate willingness to negotiate. This disparity is setting up Alaska for failure. The State relies on certain positions more than others to best serve the state. Two of the most neglected areas are the ones that Alaska heavily relies on.

These two areas are "middle management" and Judicial Services. The group of state workers that make up "Middle Management" are the ones that help implement any policy that comes from upper/executive management. Without these state employees the vision that these departments have cannot be properly executed. Anyone who has served in the Military can tell you that the Sergeants carry the largest load. These groups of workers are our Sergeants.

Judicial Services and their Court Service Officers are the driver behind the courts. They transport people awaiting trial or court hearings too and from the jails and courthouses. While they are a part of the Department of Public Safety their compensation is out of sync with their counterparts. There has been a premium put on recruiting, training, and paying Alaska State Troopers a Competitive wage. While judicial services have been put on the back burner.

These officers go through the same training as the troopers and they generally have the same abilities yet are compensated at significantly lower rates. The court systems are already overwhelmed. The Courts rely on these officers to bring people waiting trial to them. Without them being fully staffed the court can't operate at its capacity causing a further back up in an already overwhelmed system. This puts an individual's right to a speedy trial in already further jeopardy. Things were tough before the pandemic and are going to be even harder while we recover from the pandemic.

However, if we do not take care of these two groups then we will just be digging a deeper hole. The Governor pitched creating a new department by splitting DHSS in two. This would have created more executive or exempt positions. The idea to do this wouldn't have been there if there wasn't funding available.

I would suggest that we use the money that was intended for those positions in the split of DHSS to fund those sections of state government workers. I would also suggest reallocating some funds that can be used from the American Recovery Act to fund a full PFD and make Alaskans "whole" from previous years.

**TO:** Co-chairs Foster and Merrick and members of the House Finance Committee:

I missed the time set for Wrangell testimony on April 8 so am submitting this email.

I was the state social worker serving Wrangell in a full-time position from 1982 to 1990. I continue to live in Wrangell and am now retired.

I was called at times to travel to Petersburg, Kake, and remote areas to provide services there in addition to my Wrangell caseload. In my experience, it is very difficult to investigate, evaluate, and monitor child abuse and neglect complaints when you are not a resident of the

community. In these situations, you may rely on only 2 or 3 sources of information rather than the larger body of information you would have from better knowledge of the community. This leads to less nuanced judgements and actions, some of which have dramatic outcomes for children. Do you remove the child to foster care or set up a network of support to maintain the child in the home? Do you understand the family dynamics and how other relatives can step in with support? If a community has no local social worker, interventions tend to be delayed until a situation escalates and requires more severe remediation.

I strongly support the request to fund Wrangell having a resident social work position. The families of Wrangell will be much better served. It's cost-effective as well. The availability of a resident social worker can result in less expensive and disruptive services (such as though the juvenile justice system) in subsequent years.

Thank you for this opportunity to testify today. My name is Jennifer Hampton and I am representing myself today as a member of the Bethel community and a supporter of Tundra Women's Coalition.

Thank you to Representative Merrick and the Department of Public Safety subcommittee for their work to fully fund victim services through the Council on Domestic Violence and Sexual Assault. I recently learned that federal funding for life-saving advocacy and shelter services for victims and survivors is being cut. This will have devastating impacts for Tundra Women's Coalition and for survivors of domestic violence across Alaska. Crime victims should not be expected to bear the brunt of these cuts.

I work as a pediatrician at the local regional hospital, and see firsthand the importance of their services to those in our community who have been victim to domestic violence. They have provided help for many of my patients' mothers when they had no other options.

Please help us in Yukon-Kuskokwim Delta by finding a solution to this crisis before the end of session. Consider allocating state general funds to cover the gap created by the VOCA (Victims of Crime Act) shortfall.

Alaska continues to have some of the highest rates of sexual and domestic violence, including violence against children. During the stress caused by COVID, the incidence has likely increased as I have seen more children in my practice who have fallen victim to abuse. Now is not the time to cut these services.

Dear Representatives Foster and Merrick and members of the House finance committee,

I wanted to share my concerns about the proposed cuts to DV shelters across the state. Alaska has the highest rate of DV and sexual assault in the nations, and the DV shelters offer a lifeline to many people in our state.

The proposed funding cuts would force shelters to:

1. Discontinue Sexual Assault Response to exams
2. Outsource 24hr helpline
3. Reduced advocacy staff
4. Reduce the number of victims shelters are able to provide services to
5. Reduce the amount of services shelters can provide to victims

Shelters in Alaska are already underfunded and do a superhuman job with very limited resources. The cuts would be a death sentence for some of their clients.

I know from my personal experience how important these services are. When I was assaulted, an advocate from AWAIC met me at the hospital, asked me if I needed a hug and gave me one on the day of my life I needed it the most. AWAIC advocates helped me navigate the VCCB process, filing a report with the troopers, dispute hospital billing mistakes and connected me with a therapist when I had no health insurance. I could not have faced these challenges alone.

To stop the awful DV/SA cycle, we need more services, not less. It is imperative that the State of Alaska find funds to, at a minimum, cover the federal funding cuts.

Legislators on the Finance Committee:

While these two issues seem to be very different, they have many similarities and are highly deserving of robust funding. My grandpa used to say, "If you care about something, you take care of it." That is certainly the case with an Operating Budget. Whatever entities are funded and put into place, they will need funds for successful operation.

In a similar way, full funding of Mental Health resources is taking care of Alaskans, the folks who pay the taxes and who sent you to do the business of the people. The pandemic has overlaid a crisis on top of an already dire mental health picture in our state. Our citizens are in pain. I have worked in mental health in the past, as a therapist, a victim advocate and suicide prevention officer. It is not news to anyone that our state has unacceptably high rates of abuse and suicide, and trauma that reaches into the past for some of us. I have worked and lived in Cordova, Alaska for 7 years and have served on the city council for 3 years now. My comments are my own.

First, thank you for the opportunity to provide written testimony on the State's FY22 Operating and Capital Budgets.

I am writing to urge you to fully fund the Cordova Family Resource Center (CFRC). Currently, the CFRC is facing a 30-34% reduction to their FY22 budget (which is included under the Public Safety Budget,



Council on Domestic Violence and Sexual Assault). CFRC is an important asset to the Cordova community. They provide direct services and emergency shelter to victims of violence and sexual assault, as well as provide programming for youth of all ages. If this funding cut is implemented, they will be forced to cut staff, services, and programming at a time when these services have been increasingly needed.

I would also ask that you fully fund School Bond Debt reimbursement. Reduction in those funds over the past couple years has placed a huge burden on our municipal budget. I was heartened to see this item funded in the Governor's budget, and would like to see it fully funded by the legislature.

Finally, I urge you to fund the Harbor Matching Grant Program for the Cordova harbor project. Upgrading the Cordova Harbor is the top priority for the City of Cordova and has been the #1 project on the Harbor Matching Grant program's list for several years. Unfortunately, funding has never been included in the final and approved Capital Budget. Our harbor is the backbone of our economy here in Cordova, providing jobs and revenue to the City as well as to the State of Alaska. This project will fund essential repairs to a year-round, heavily-used harbor.

Thank you for taking the time to read my comments today. My name is Lisa Whalen. I am a member of the Bethel community and an ardent supporter of Tundra Women's Coalition in Bethel.

Thank you for your steadfast commitment over the years to survivors of domestic violence and sexual assault. We see you and recognize you as strong advocates and consistent funders of victim services. As I'm sure you are aware by now, victim services organizations are in desperate peril across the nation and in Alaska due to a sharp decrease in available VOCA funding for the next two years.

**I want to share with you one of the myriad ways I have seen our local domestic violence shelter, Tundra Women's Coalition, save lives in Bethel- and it's not what you might be thinking.** I worked at Bethel Regional High School for five years. High school presents difficulties for almost everyone, but there are additional challenges for teenagers in rural Alaska, and resources to share with students to help with coping and resilience are sometimes in very short supply. One of our most consistent and dependable resources, however, is Teens Acting Against Violence (TAAV), a program at Tundra Women's Coalition that focuses on healthy relationships, empowerment and leadership for teens. Most importantly, though, TAAV is a support system- a family- for teens who sometimes join the group clinging to the fraying ends of their rope. I have seen students who I was genuinely worried wouldn't make it through the year find their place and their voice and their community in TAAV. I am not being at all hyperbolic when I say that I truly believe that TAAV saves lives.



It is for this reason that I implore you to find a way to keep Tundra Women's Coalition fully funded over the next two years until the VOCA Fix is able to step in and relieve the pressure. I absolutely understand that this is a situation that you did not create, but it is one that you have some power to rectify. **Please consider allocating state general funds or American Rescue Plan Act funds (if possible) to cover the gap created by the VOCA shortfall.**

Victim services organizations are the front lines of safety in our communities- in the immediate moment, with crisis lines and emergency shelter, but also over the long haul, with legal services, transitional housing services and violence prevention programs like TAAV. **Thank you for finding a way to keep these essential organizations fully funded and at the ready to serve those in need all across Alaska.**

Hello,

My name is Samantha Taylor. I grew up on Prince of Wales Island. Growing up there I experienced, myself, mom, all of my friends, and even my teachers going through domestic violence and or sexual assault. Through all of these experiences not one time were their perpetrators put into jail, face charges, or receive great community support.

Some of the examples of this are my friend while babysitting she herself a child was molested by the father. When she went to report it, she was told that more people would have to come forward, and she was not offered counseling or any other support. I had multiple friends who were the spawn of incest. I lived in a house with a physically and emotionally abusive father. My once best friend's boyfriend became physically abusive towards her. His mom witnessed this, and lied about the actions of her son. I once had my favorite history and art teacher show up to class with a black eye that not even make-up could cover. My friend and her sister whose father was the VPSO was molested by her father. The father did not face any jail time. My only friend to go to college at that time was sexually assaulted in her own dorm room. She was not offered support and did not know where to turn. I can continue with these experiences and I can tell you that every single woman who grew up in Alaska has a similar story. These experiences made me choose a career in the domestic violence and sexual assault field.

While working at the Interior Alaska Center for Non-Violent Living I have seen what really dark things perpetrators are capable of doing. Some of us advocates say that perpetrators make it their full time job to be a perp. The role of an advocate is not for everyone, only people who work here for an extended amount of time can fully appreciate how hard this job is and how much more we should be doing but are unable to due to funding. Residents and clients would be the exception to this statement. There are numerous times that we are not able to attend a meeting with clients, respond to a domestic violence call at the hospital because of low staffing and the high volume of needs. When individuals relocate to Alaska or to Fairbanks and do not have support I worry about them. I worry because of the already limited amount of resources and that just environmentally, Alaska is a hard place to live.

Alaska has the highest rate of domestic violence, sexual assault, and violence against women in the United States. In addition, Fairbanks is the most dangerous place for a woman to live in the U.S. This fact is not always acknowledged due to Alaskans culture of being independent, wanting to keep the peace, and sweeping things underneath the rug. Domestic violence, sexual assault, and violence against woman is not an act that affects one person or one part of a person's life. It has a ripple effect on every part of the individual's life, their friends, family, work, school, goals, their sobriety, mental health, their counselor, law enforcement,

forensic nurses, ER staff, advocates, and community members. The best way to end domestic violence and make Alaska a safer place is to increase funding for survivors not decrease it.

Good day,

I am writing to ask that you do not cut any funds aimed at supporting the mental health of Alaskans. I am writing as a consumer of mental health services, a parent of two children who experience ADHD and receive services to support their needs, and as a professional in the field for 20 years. As anyone in the field can tell you, we do not go into this field with the intention of becoming rich. Yet, individuals who work in this field still need to support their families. Due to years of either budget cuts or flat funding, while inflation has been increasing these wages have remained stagnant or even been cut. This leads to significant staff shortages either from turn over or from inability to hire into these positions. Frontline positions in mental health pay the same or even less than retail, yet are significantly more difficult and emotionally draining. We know that individuals with poor mental health benefit from consistent and competent services, yet this is not happening in part because those in the field are not being adequately compensated for the work they provide. Furthermore, we know that those who experience poor mental health often experience higher incidents of school disruption, employment disruption, contact with law enforcement, contact with child protective services, increase physical medical needs, and homelessness. Ultimately, by fully funding mental health services, costs in these other areas can be reduced eventually. Unfortunately, due to the impacts of COVID over the past year, the mental health of many Alaskans has deteriorated. To aid in the community recovery of the impact of COVID, we will need to rely on the services of our mental health professionals. They are vital to our recovery as we move back to "normal" and adjust to that new "normal". We do not know yet, what the long-term impact of the past year is going to have on an entire generation of youth who have lost their foundation nor on an entire generation of parents who had to figure out how to parent and work in a totally different way. Cutting mental health funding at this time could potentially have an even larger ripple effect than it would have 2 years ago due to the trauma we collectively experienced as we have lived through the COVID pandemic.

I respectfully ask you to put the mental health needs of Alaskans at the forefront of your budget decisions. Please consider using the federal CARES Act Funding as a supplement to boost the overall budget to support mental health services to Alaskan instead of agreeing to the Governor's proposed \$35 million reduction of general funds related to Medicaid Health Coverage or defunding or cutting the Behavioral Health Treatment and Recovery grants.

RE: FY22 Budget: Operating (HB 69) and Mental Health (HB 71)

Dear Chairs and Members of the House Finance Committee:

I am writing you concerning the FY22 Operating and Mental Health budgets. I have been a resident of Alaska since 1984. I live in Anchorage where my husband and I own a home; we have children and grandchildren living here. All of our futures as Alaskans are at stake in this budget process. I appreciate your attention and close scrutiny of the budget proposals before you.

I am writing to you today about four budget items.

**Legal Services funding:** The Governor recommended a \$450,000 GF reduction to the Civil Legal Services Fund. His proposal should be unequivocally rejected by the Legislature. More than ever in the next fiscal year eligible indigent Alaskans will require legal assistance with eviction processes, with obtaining access to healthcare, and with seeking legal protections against abuse. Legal Services is already hard-pressed to meet the burgeoning needs of Alaskans. As someone who has volunteered with the many free legal clinics run by ALSC, I know how great the need is among our state's residents, particularly the elderly and those seeking harbor from abuse.

**Therapeutic Courts funding:** The Governor has proposed a \$488,400 increase to expand therapeutic court services and I understand that a House Finance Subcommittee has endorsed this proposal. I agree with this action. So many of the individuals appearing in the courts have behavioral and addiction disorders and incarceration for these individuals does not effectively reduce recidivism. I have had the opportunity to observe the Therapeutic Court judges, staff and agency representatives as they meet to discuss individual cases. The efficacy of the Therapeutic Courts' wraparound approach is well-established, and its expansion should be supported.

**Medicaid Coverage:** The Governor's proposal recommending a \$35 million reduction in general funds should be rejected. Relying on an unexplicated and undeveloped funding strategy, the Governor contends he can back-fill the \$35 million difference with federal CARES Act funding over the next fiscal year and yet not have to fund the same the next fiscal year. This is a dangerous gamble and should not be approved without a fully-clarified and achievable plan as to how essential programs and services will be covered in FY23.

**Behavioral Health Treatment and Recovery Grants:** A House Finance Subcommittee has proposed adding 1.25 million in general funds and MET (Marijuana Education and Treatment) funds. I strongly agree as these funds provide behavioral health treatment services for those Alaskans not covered by Medicaid or private insurance. This group is greatly underserved, and the additional funds help with that.

My name is Kim Sibrel and I am a member of the Kodiak Women's Resource and Crisis Center Board of Directors. First, I appreciate Governor Dunleavy's recognition of April as Sexual Assault Awareness Month, for recognizing the need for more prosecuting attorneys in the Department of Law's budget, to respond to sexual assault backlog cases, and his call to all of us to "make Alaska the safest state in the country, especially for our most vulnerable, our women and children." Thank you to Rep. Merrick and the DPS subcommittee for their work to fully fund victim services through the Council on Domestic Violence and Sexual Assault. Unfortunately, we just learned that federal funding for life-saving advocacy and shelter services for victims and survivors is being cut. This will have devastating impacts here in Kodiak, and across Alaska.

On April 1 community-based victim services agencies received a memo from CDVSA stating that the State of Alaska's FY2021 VOCA (victims of crime act) funds would be reduced by \$4.1 million and that all victim services should expect a 30% cut in

their grants starting in FY2022. Crime victims should not be expected to bear the brunt of these cuts. Our agency provides critical services to the Kodiak community, including the remote villages within our archipelago. If we lose 30% of our funding, we will be forced to make drastic cuts to nearly every aspect of our organization. These cuts will have a devastating impact on survivors, victims, their families, and our community work.

We are reaching out to you to let you know that this is happening now. Within my Board work at KWRCC, I see firsthand the importance these life-saving supports offer to victims. Please help us in Kodiak by finding a solution to this crisis before the end of session. Consider allocating state general funds to cover the gap created by the VOCA shortfall.

Alaska continues to have some of the highest rates of sexual and domestic violence, including violence against children. Now is not the time to cut lifesaving services to victims and survivors of domestic and sexual violence. As Alaskans, we can, and must do better.

**Subject:** Imminent Cuts to Funding for Victim Services

Thank you for your work for the people of Alaska.

My name is Anne Doerpinghaus, I have worked as an RN in Fairbanks since 1993, and I am currently a Forensic Nurse at Fairbanks Memorial Hospital. I represent myself, and also the women and men I provide care in the Emergency Room - in the past four years that is over 400 people, and I am one of a team of six.

The upcoming cuts to community based victim services agencies in Alaska will be devastating for victims of violence in Alaska. Without the expertise and presence of advocates victims will have to navigate invasive medical exams, grueling interviews, complicated legal procedures all without support and skilled guidance. The teams that work to respond to sexual assault, strangulation, and domestic violence include law enforcement, prosecutors, and nurses, but we all rely on victim advocates to come to the hospital whenever we call - 24/7. They help victims survive trauma, seek justice, find healing. Shelter services are also critical for victims and families in crisis.

Growing up, I attended the after-school group that the Children's Program, and then later joined the Teens Acting Against Violence. Looking back at the memories I have created in those programs warms my heart, because with the limited amount of programs for children and young adults, they really helped mold the person I am today. Both programs instilled resiliency in me, for the world around me, and helped pave the path into adulthood. I was and am able to express myself, while also having the comfort of being able to ask questions. Especially if you are a young adult and have question that need answers to. Thank you for the opportunity to testify today.

Respectable House Finance Committee regarding HB69 and HB71. My name is Nate Taylor, I am the Police Chief of the Cordova Police Department and I am speaking on behalf of my agency.

First, I appreciate Governor Dunleavy's recognition of April as Sexual Assault Awareness Month, for recognizing the need for more prosecuting attorneys in the Department of Law's budget, to respond to sexual assault backlog cases, and his call to all of us to "make Alaska the safest state in the country, especially for our most vulnerable, our women and children."

Thank you to Rep. Merrick and the DPS subcommittee for their work to fully fund victim services through the Council on Domestic Violence and Sexual Assault. Unfortunately, we just learned that federal funding for life-saving advocacy and shelter services for victims and survivors is being cut. This will have devastating impacts across Alaska.

On April 1 community-based victim services agencies received a memo from CDVSA stating that the State of Alaska's FFY2021 VOCA (victims of crime act) funds would be reduced by \$4.1

million and that all victim services should expect a 30% cut in their grants starting in FY2022. Crime victims should not be expected to bear the brunt of these cuts.

Our small community benefits greatly from the services provided by the Cordova Family Resource Center (CFRC). CFRC handles thousands of clients a year, providing services that are not available from other resources in our community. The proposed cuts in funding would have a devastating impact to victim services in our community and put a higher workload on our small police department which has just four sworn officers.

I am reaching out to you to let you know that this is happening now. Our police department sees firsthand the importance these life-saving supports offer to victims. Please help us in Cordova by finding a solution to this crisis before the end of session.

Consider allocating state general funds to cover the gap created by the VOCA shortfall.

Alaska continues to have some of the highest rates of sexual and domestic violence, including violence against children. Now is not the time to cut lifesaving services to victims and survivors of domestic and sexual violence.

I have traveled from Fairbanks to attended their meetings in person at the home office in Anchorage. I have flown out to numerous villages to testify in response to their proposals. I have called in to their board meetings to plead for more transparency, fiscal responsibility and moral accountability. In each instance the board members and staff appear troubled that the public has comments and concerns about the corporate welfare that they propose. Subsidizing the extraction of Alaska's raw materials for the benefit of foreign companies seems to be a policy above reproach to them. They gamble with our land and resources like it's just another weekend in Vegas.



As Alaska is gripped by recession and economic uncertainty the board members repeatedly close the doors and retreat to extended "executive sessions". The phone line goes silent for hours. They have reduced a right to public comment from 3 minutes to 2 minutes as their actions produce a growing alarm across Alaska and subsequently more participation in their randomly scheduled meetings.

My name is Ashley Simon and I work as a victim advocate at the Interior of Alaska Center for Non-Violent Living in Fairbanks, Alaska.

First, I appreciate Governor Dunleavy's recognition of April as Sexual Assault Awareness Month, for recognizing the need for more prosecuting attorneys in the Department of Law's budget, to respond to sexual assault backlog cases, and his call to all of us to "make Alaska the safest state in the country, especially for our most vulnerable, our women and children."

Thank you to Rep. Merrick and the DPS subcommittee for their work to fully fund victim services through the Council on Domestic Violence and Sexual Assault.

Unfortunately, we just learned that federal funding for life-saving advocacy and shelter services for victims and survivors is being cut. This will have devastating impacts across Alaska.

On April 1 community-based victim services agencies received a memo from CDVSA stating that the State of Alaska's FFY2021 VOCA (victims of crime act) funds would be reduced by \$4.1 million and that all victim services should expect a 30% cut in their grants starting in FY2022.

### **Crime victims should not be expected to bear the brunt of these cuts.**

Our agency provides critical services in our community of Fairbanks. If we lose 30% of our funding, here are some of the choices we will be forced to make:

- \* We will be forced to reduce services and limit our emergency shelter space because we will be forced to cut our staff in half or more. What this ultimately means is that **victims of sexual assault and domestic violence seeking a safe and secure location away from their perpetrator will be turned away and forced to return to their unsafe situation.**

- \* We will be forced to cut all children's services, including counseling and art therapy programs available to minors who are victims of domestic violence and/or sexual assault.

- \* We will no longer be able to respond to the hospital to provide support and resources to clients who have just been violently sexually assaulted or strangled.

- \* We will be forced to limit access to legal assistance available to victims.

These cuts will have a devastating impact on survivors, victims, their families, and our community work. I have personally helped dozens of individuals in the last week alone by:

- \* Checking individuals both with and without children into our emergency shelter because their partner was actively trying to **kill them**.

- \* Helping to relocate individuals to other parts of the state or country because their partner or stalker was actively trying to **hunt them down to kill them**.

- \* Coordinating counseling referrals for men, women, and children because they were sexually assaulted and/or victims of domestic violence.

- \* Coordinating with forensic nurses and law enforcement to help mothers seek safety and justice for their **minor children who have been sexually abused**.

\* Coordinating legal referrals for victims of domestic violence and/or sexual assault as they seek justice through the court system.

\* Helping victims to secure safe and affordable housing once they are considered safe from their perpetrator.

\* Educating clients who have been controlled and abused their entire lives on resources available to help them to survive on their own rather than depend on their perpetrator.

\* Being available at all times, whether by phone or in-person, to help victims of domestic violence and/or sexual assault to process and discuss the horrific violence they have experienced.

I am reaching out to you to let you know that this is happening now. This is happening every hour. My cohorts and I see firsthand the importance these life-saving supports offer to victims. Every. Please help us in Fairbanks by finding a solution to this crisis before the end of session.

Co-Chairs Foster and Merrick,

My name is Farah Sears and I am a Family Nurse Practitioner at Yukon Kuskokwim Health Corporation in Bethel. I perform medical forensic exams for both adult and pediatric sexual assaults. In the YK Delta, we have 2 times the number of SA (child and adult) than the Alaska state average which is already 4 times higher the lower 48 average. In Bethel we have worked very hard to build a multidisciplinary SART



that responds to each and every Child or Adult SA. This team includes a Law Enforcement agency, either Bethel PD or the Troopers, the medical forensic examiner and an advocate from CAC or TWC. I consider the advocate to be the glue that holds this team together and helps the patient navigate the medical, law enforcement and judicial systems.

Unfortunately, we just learned that federal funding for life-saving advocacy and shelter services for victims and survivors is being cut. This will have devastating impacts in our region.

The advocate is with the patient before the team comes together, throughout the forensic interview/exam to gather DNA evidence/photos, and the advocate remains available to the survivor for as long they need or want afterward. These advocates become a trusted ally and go-to for the survivor to answer questions about their case, sit with them during glass warrants, help them with protective orders, secure shelter at TWC, help them relocate, connect them with local resources, get them in to see Behavioral Health and countless other services. If the funding of Victims Services in our region is cut, that will devastate our community, that desperately needs these services and undermine the foundation that our multidisciplinary team is built on and continues to rely heavily on. I urge you to consider allocating state general funds to cover the gap created by the VOCA shortfall as I have seen on an almost daily basis how invaluable the services of our TWC and CAC are to the YK Delta survivors of Domestic Violence, Sexual Assault, Child Sexual Assault/Abuse and Child Abuse.

Dear Alaska Representatives,

As you are meeting to decide on the course of Alaska's financial future for the next year or more, and as you are accepting public testimony this week, I would like to offer the following comments.

First, I urge you to consider Alaska's long-term financial future above all else, and ensure that we will have adequate, sustainable sources of revenue. I strongly urge you to consider all options currently under consideration, but especially a restructuring of oil taxes and income taxes on corporations and high earning individuals. Cutting the budget further will not result in a sustainable economy, and risks doing permanent damage to Alaska's long-term future.

Second, as a long-time Alaskan, I know that education funding is the first and foremost responsibility of the Alaska State Legislature. No other need is as important as ensuring that our younger generations of Alaskans are provided for with high quality educational opportunities. These opportunities should extend from early childhood, when they make their most long-lasting impact on a human being, through college, when they affect the lifetime earning potential of our young adults. Please ensure that education across the state is securely and adequately funded, in all school districts throughout the state.

Third, I would like to place special emphasis on the needs of our University of Alaska system. As a proud graduate of the University of Alaska Fairbanks, I can testify firsthand to the quality of the education I received and the advantages it provided me in the workforce. (I earned a Master of Science degree from the School of Fisheries and Ocean Science, and have made my career working in Alaska fisheries management and research.) Our institutions of higher education are what really set our population apart from the rest of the country. Although many states have far greater numbers of, and older and more prestigious, universities, none in my opinion have anything that equals the relevance, adaptability, and dedication to the unique needs and opportunities in Alaska. As just two examples, the programs in Alaska Native studies - culture and language revitalization - and in Arctic sciences and related economics, are globally respected and cannot be replicated anywhere else. Equally important is the ability of the University of Alaska system to provide affordable education in relevant, workforce-driven programs for all Alaskans. The value of these opportunities to Alaskan families cannot be overemphasized.

I am of course aware that you must also consider many other funding needs for the state, including transportation, law enforcement, resource management, assistance to municipalities, etc. I would re-iterate my first point about the urgent need to put in place sustainable systems of revenue generation for our future. One area that has been sadly hurt and neglected by the current Administration is our marine transportation, the Alaska Marine Highway system. Alaska is a maritime state, and marine transportation is vital to our economy. Dismantling the Marine Highway system is a serious mistake and must be reversed, so that all of our coastal communities can survive and thrive.

I greatly appreciate this opportunity to provide comments, and thank you for taking the time to listen to and read what your fellow Alaskans think about our finances and economy.

The residents of Petersburg voted over ten years ago on issuing debt for these projects with the assumption that the State would be reimbursing over 60% of the annual bond interest and principal each year. Alaska municipalities all over our state have issued bonds relying in good faith on the State of Alaska to live up to its financial commitments to education. In recent years the funding commitment by the State for school bond debt reimbursement has been variable and has created increased hardship for municipalities to budget and plan with confidence in our communities.

Honorable Co-Chairs Foster and Merrick and House Finance Committee Members:

Thank you for the opportunity to address you today. I was unable get through on the teleconference line, so I am submitting these comments via email.

I am writing to address the appropriations for the Alaska Industrial Development and Export Authority (AIDEA). AIDEA's dividend for fiscal year ending 2022 should be carefully reviewed in light of AIDEA's questionable policies and lack of transparency. The formula AIDEA uses for its dividend should be



compared to other State entities, such as AHFC, to ensure that AIDEA is declaring the proper dividend, and not wastefully or unlawfully expending funds without legislative oversight.

AIDEA has a non-transparent, non-public process that disregards Alaska tribal governments and entities, in favor of foreign mining companies. As an example, AIDEA has held many hours of private executive sessions and work sessions and numerous hearings with Trilogy, Ambler Metals and Rick Van Neuwenhuyse about the Ambler Road Project. However, when the Alaska Tribes whose economic and subsistence security is impacted by the Ambler Road requested a specific hearing with AIDEA to address their concerns, AIDEA responded:

*"Both the Board Chair and the Executive Director state that public comments or statements relating to the Ambler Project fall within the "public comment" portion of the board meeting."* [email Response of AIDEA] This is limited to 2 minutes per comment.

AIDEA's non-public, non-transparent decision-making violates the Open Meetings Law and potentially jeopardizes the finances of any Alaska project that AIDEA is handling.

The Legislature is respectfully requested to conduct an audit of AIDEA's finances and ensure that the audit results are transparent.

**Subject:** Please offset reduction in Federal VOCA (Victims of Crime Act) Funds

Representative Foster, Representative Merrick, and Honorable members of the AK House Finance Committee,

Thank you for your service to our great state. It is a hard job to legislate and understand all of the complex issues that come before you. I appreciate the time and dedication you commit to the democratic process. I understand you are considering and deliberating HB 69 (Operating Budget) and HB71(Mental Health Budget) in your committee this week. As you have likely been made aware by now, CDVSA (Council on Domestic Violence and Sexual Assault) has been informed that all victim service providers in the state will suffer a 30-33% funding cut as of July 1 due to a reduction in funding that has occurred with the Federal Victim of Crime Act's (VOCA) Crime Victims Fund (CVF) – an non-taxpayer source of funding that supports thousands of crime victims services providers serving millions of victims of crime annually . This massive cut to funding for Alaska's community-based victim services agencies will be devastating to communities throughout the state. **I ask that you please consider offsetting a decrease in federal VOCA funds by**

**appropriating state funds to support the numerous victim service agencies across the state who are impacted by this cut in federal funding.** As our state is about to receive a massive influx of funding from the American Rescue Plan Act, please consider designating some for a short term fix for victim services. A longer term fix is in the works at the federal level; however, it's estimated that it will take approximately 2 years.

I have had the great honor to work with several of the agencies who are impacted by this funding cut. Currently, I sit on the Board of Directors to STAR (Standing Together Against Rape) and through my work as a consultant I have helped to support the work of TWC, Tundra Women's Coalition in Bethel and the SHARE coalition in Petersburg which is supported by WAVE (Working Against Violence Everywhere). I have seen firsthand the commitment and dedication of the staff of these organizations, their efficient operations, and the real need that they serve in communities. To have 1/3 of a non-profit organization budget eliminated means laying off staff and a dramatic reduction in services to Alaskans who have been the victims of sexual assault and domestic violence.

This is particularly troubling since, as I imagine you know well, Alaska has some of the highest rates of domestic violence and sexual assault in the nation. Over half of all adult women in Alaska report having experienced intimate partner violence, sexual violence, or both in their lifetime in our State. That statistic is horrifying. That means one out of every two women in Alaska carry with them the trauma and toll of having experienced this violence. The community-based agencies across Alaska that are there for community members experiencing violence must be made whole and funded fully.

I know this funding issue is not of your making, but I hope you will consider helping in the short term.

Planned Parenthood Alliance Advocates – Alaska (“PPAA”) urges the committee to fully fund victim services through the Council on Domestic Violence and Sexual Assault (“CDVSA”) grant program in the Public Safety Budget. Without full funding, the committee will be cutting critical, lifesaving services to survivors of domestic and sexual violence.

As a trusted provider of sexual assault and domestic violence survivors, PPAA is deeply committed to advancing policies and programs that work to reduce sexual assault and domestic violence, provide support for survivors, and help survivors seek justice. Alaska’s sexual assault and domestic violence rates are some of the highest in the nation – and these rates are likely underestimates because these occurrences are often tragically underreported. We know that survivors, many of whom are our patients, face a myriad of obstacles when accessing justice and seeking support services.

On April 1<sup>st</sup>, 2021, recipients of CDVSA grants were notified by the Council’s Executive Director to expect a 30 percent cut in recipient grants for FY 22, due to \$4.1 million less in anticipated federal Victims of Crime Act (“VOCA”) coming into Alaska. This means that the funds that appear in the House Finance sheets are not actually available to programs that provide emergency safety and shelter for survivors of domestic violence and sexual assault. Without action by the House Finance Committee, these programs will experience dramatic funding decreases in less than 12 weeks.

These cuts will have a devastating impact on survivors and their families and will be particularly devastating given the increased need for these services in the wake of COVID-19. If the House Finance does not fill this funding gap, community providers will be forced to reduce services and limit emergency shelter space – which is already at capacity – meaning fewer survivors will have access to safe shelter and critical resources. This will also cut all children’s services, medical accompaniment for both domestic violence strangulation and sexual assault to hospitals, and limit access to legal assistance.

We appreciate the opportunity to testify and urge the committee to allocate adequate state general funds to cover the gap created by the VOCA shortfall.



Thank you for this opportunity to provide written testimony regarding the proposed budget cuts to victim services. My name is Jennifer Peeks. I am a Behavioral Health Clinician and the Director of the Behavioral Health Department at the Bethel Family Clinic in Bethel, Alaska; I am writing to you today in this capacity.

Thank you to Representative Merrick and the DPS subcommittee for their work to fully fund victim services through the Council on Domestic Violence and Sexual Assault. Unfortunately, we just learned that federal funding for life-saving advocacy and shelter services for victims and survivors is being cut starting in FY2022. This will have devastating impacts to all of our communities across Alaska. Victims of crime should not be expected to bear the brunt of these cuts.

I have worked in the Yukon-Kuskokwim (YK) Delta as a social worker since 2004 and served with the Bethel Family Clinic (BFC) since 2019. Throughout my career in the YK Delta, I have developed a close working relationship with the Tundra Women's Coalition (TWC) and the Children's Advocacy Center (CAC)- IRNIAMTA IKAYURVIAT. For decades, these agencies have consistently provided crisis services, legal support, medical and behavioral health resources, shelter, preventive and educational services, and more, to the people of our region. These programs will be significantly impacted by the proposed cuts.

Our clinicians at the BFC work in partnership with TWC/CAC to ensure that our clients are safe from harm and have the support they need to navigate through traumatic and often life-threatening events. Our Behavioral Health team has collaborated both directly and indirectly with TWC/CAC in several situations where TWC/CAC were instrumental in providing rapid removal of individuals and families from crisis situations where they were at risk of being harmed and, in some situations, being killed. The TWC/CAC staff work around the clock to promote safe and healthy communities using both traditional and western approaches to meet the unique needs of each family. We desperately need their services to be fully funded.

Alaska continues to have some of the highest rates of sexual and domestic violence, including violence against children. Now is not the time to cut lifesaving services to victims and survivors of domestic and sexual violence.

My name is Marianne Mills and I am the Program Director of Southeast Senior Services. Our mission is to help older Alaskans remain in their own homes and traditional communities for as long as possible through providing meals on wheels, wheelchair accessible transportation and other services.

We operate a network of senior centers throughout Southeast Alaska and most of the communities we serve are only accessible by boat or plane. Our staff and senior citizens live in Angoon, Craig, Haines, Hoonah, Juneau, Kake, Ketchikan, Klawock, Klukwan, Saxman, Sitka, Skagway, Wrangell, and Yakutat.

Today, I am asking you to support a long-range management plan for the Alaska Marine Highway.

The Alaska Marine Highway is a virtual lifeline to our communities and to our programs. The most cost-effective way that our senior centers in communities such as Angoon and Hoonah can get their food is through transportation made possible by the Alaska Marine Highway. In the months the ferry is not running, our food costs skyrocket. Alaskans need a stable and reliable service that operates year-round.

We also depend on the ferry to transport our lift-equipped buses to Juneau for their annual preventative maintenance. This past year when the ferry service was curtailed, our senior center vehicles were not able to get timely maintenance. This affects their ability to operate efficiently, safely, and to last for the many years we need each of them.

Most importantly, the elders in our villages depend on the Alaska Marine Highway to access life-sustaining medical care in Sitka, Ketchikan, Juneau and beyond. Especially during the winter months and in inclement weather when planes cannot fly, the elders need the ferry to get the care they need. Older Alaskans have built our state and we owe it to them to give them access to the services they need through dependable Alaska Marine Highway service.

Honorable Members of the House Finance Committee,

City of Cordova is an isolated fishing town of nearly 2500 people. We take pride in being able to maintain a good quality of life through services paid for with local sales and property taxes.

Cordova looks to the State as a partner in investments in our economic future but also for support in extraordinary times of need. In FY20, COVID-19 resulted in an unexpected loss of nearly \$700K in budgeted revenue, eroding our reserves, and potentially impacting essential services City of Cordova provides its residents.

Cordova cannot make up this lost revenue on its own. The State can help by avoiding cost-shifting or cuts that impact local governments. We ask that you fully fund Community Assistance and School Bond Debt Reimbursement programs. We applaud rejection of the Department of Law's misdemeanor proposals. We encourage continued revenue sharing arrangements.

Economic growth is only possible with investment. As a coastal community, Cordova has relied on the Alaska Marine Highway for its transportation needs for over 50 years. The sudden and dramatic defunding of the ferry system (last year we had no service for eight months) has been debilitating. Cordova pleads for appropriate funding of the Alaska Marine Highway system.

Cordova's economy is fisheries based and we are consistently ranked among the top ten commercial fishing ports nationally, producing over 80 million pounds of seafood valued at over \$60 million dollars. Cordova contributes an average of \$1.3 million annually to the State of Alaska in fisheries taxes. Reliable science-based Fisheries policy and adequate funding for Alaska Department of Fish and Game for management is essential for the statewide fishing industry to succeed.

Rebuild of our South Harbor is Cordova's top infrastructure priority. We have been the state's top-rated harbor project for two years and hope our \$5M request is funded this year. This nearly \$30M harbor improvement project will sustain the fishing fleet that drives our economy. Cordova has skin in the game with a voter approved \$5M bond and we are actively pursuing other funding avenues.

We acknowledge the difficult financial decisions you are facing, but also understand the possibilities presented by the Federal Government through the American Rescue Act. I encourage you to invest those resources for maximum local impact.



Thank you for this opportunity to testify today.

My name is Michael Hicks and I am a Cordova Family Resource Center Board Member, the Chief of the Cordova Volunteer Fire Department, and a Retired Chief of Police for the City of Cordova. I have been a member of the Cordova community for the past 32 years and have a vast variety of first-hand knowledge and experience concerning crimes of Domestic Violence, Sexual Assault, and homelessness in our community.

First, I appreciate Governor Dunleavy's recognition of April as Sexual Assault Awareness Month, for recognizing the need for more prosecuting attorneys in the Department of Law's budget, to respond to sexual assault backlog cases, and his call to all of us to "make Alaska the safest state in the country, especially for our most vulnerable, our women and children."

Thank you to Rep. Merrick and the DPS subcommittee for their work to fully fund victim services through the Council on Domestic Violence and Sexual Assault. Unfortunately, we just learned that federal funding for life-saving advocacy and shelter services for victims and survivors is being cut. This will have devastating impacts across Alaska.

On April 1 community-based victim services agencies received a memo from CDVSA stating that the State of Alaska's FFY2021 VOCA (victims of crime act) funds would be reduced by \$4.1 million and that all victim services should expect a 30% cut in their grants starting in FY2022. Crime victims should not be expected to bear the brunt of these cuts.

Being in a remote community like Cordova presents unique challenges as it does in other remote communities around the state. We have extremely limited resources that are already being strained to their limits. A 30% cut to our program would be devastating. We do not have a homeless shelter and must pay as we go to house those in need. In FY21 we have provided temporary housing for 195 people so far. Last year we did not house any homeless people because there was no money. These people were housed this year from a grant we were awarded. The number of DV shelter nights have more than doubled from the FY20 total of 80 to 171 and counting in FY21. The direct services we provide to DV/SA victims have climbed from 804 in FY20 to 1,444 in FY21 so far.

These are a couple examples. Our numbers are on the rise across the board and will likely continue to rise. If we sustain any cuts to our program, we will have to make choices between providing services or paying the rent and utilities to keep our doors open.

This will be devastating to the survivors, victims, their families, and our community work.

If you combine the direct non DV/SA participants (420), the Crisis Helpline responses (279), the Covid-19 services (259), and the DV/SA program participants (132), the combined total represents 1,090 people who have benefited directly in some way from some of our programs. That number represents approximately 50% of our entire community of 2,100 people that have received one or more of our services.

It makes absolutely no sense to cut these vital programs when people all over the country are asking for exactly these types of services to be provided. I cannot speak for other communities, but I would be willing to bet that they have similar if not higher needs.



The statement you issued recently regarding the Emergency Declaration for Tuluksak said that your administration is working with local partners “to ensure the people of Tuluksak have constant access to drinking water and that the ice road is maintained.” Calista, an Alaska Native Regional Corporation representing over 33,000 shareholders in the Yukon Kuskokwim (YK) Delta region, and the Native Village of Napaimute, write to thank you for issuing the Declaration and to call attention to the ongoing emergency needs of our Region. We request the State deploy the National Guard to deliver fresh water supplies to Tuluksak and direct a portion of emergency funds toward maintenance of the essential and life sustaining Kuskokwim Ice Road that is maintained by Napaimute in collaboration with other Tribes and regional organizations.

The Yukon-Kuskokwim Delta region in Western Alaska is home to 56 federally recognized Tribes, nearly one-quarter of all the Tribes in Alaska. The YK Delta communities are located along the Yukon and Kuskokwim Rivers and Bering Sea. Spread across an area the size of New York State, our communities are not connected to each other by road system and the only access to each community, and the rest of Alaska, is by ice road, frozen tundra, or airplane. The YK Delta region also has some of the highest costs of living in the nation and vehicle access to Bethel can offer significant cost savings for food, fuel, and other essential supplies, and of course, access to health care. Over 200 vaccinations were recently delivered by way of ice road when a doctor and two nurses traveled to Kwethluk over the frozen Kuskokwim River.

We receive near daily communications from community and Tribal leaders telling us how the COVID-19 pandemic has profoundly impacted their daily lives. Stores in villages are not always stocked, mail delivery is inconsistent and unreliable, and as you know, a recent fire devastated the Tuluksak community by burning down the only facility that provides fresh water to the village. In addition to the devastating fire, Tuluksak, along with many other YK communities, continues to suffer serious COVID-19 outbreaks and recently lost a respected elder to the virus.

With severe climate impacts now permeating the region, harsh winter blizzards frequently impede air travel and in such dangerous winter storm and blizzard conditions wind chill can cause frostbite on exposed skin in as little as 10 minutes. Flying in water to Tuluksak may not always be an option with weather delays. The Ice Road can also be unsafe and difficult to navigate in certain weather conditions. Therefore, it is necessary to deploy the National Guard to deliver emergency water supplies to Tuluksak, not only due of the enormous expense of flying in pallets of water, but because Tuluksak is only one big storm away from total isolation and no access to potable water amidst a COVID-19 pandemic.



Calista Corporation, the Native Village of Napaimute, Donlin Gold, the Yukon Kuskokwim Health Corporation, and numerous other public and private organizations throughout the region and beyond, help fund the Ice Road program. The Native Village of Napaimute has long played a leading role in the establishment and maintenance of the Ice Road and works cooperatively with all the tribal transportation departments along the River. Napaimute leadership has been instrumental in maintaining the road every year, which allows families to travel to and from their communities along the frozen river.

Advocacy by Napaimute and other partners also helps fund plowing and safety marking of the winter road. The cost to carve out the first road and maintain it throughout the winter easily exceeds six figures annually. It is important to note that many State and federal agencies use the Ice Road regularly to perform governmental operations. Yet, the only maintenance funding that has been offered by the State has been by way of grant, which must be requested and secured annually.

As you know, last year the Alaska Legislature included \$50,000 in operating funds for management of the Napaimute Ice Road, similar to \$50,000 in funding that the State has long appropriated to the Northwest Arctic Borough to provide safe and efficient ice road construction between Kotzebue, Noorvik, and Kiana. Unfortunately, while the shorter Noorvik ice road funding remained intact, funding for the nearly 300-mile-long Kuskokwim Ice Road was line-item vetoed by your administration. To our rural river communities, the Kuskokwim winter Ice Road is as integral a part of the rural transportation system as the Alaska Marine Highway is to rural coastal communities, also to the many State and federal agencies that regularly use the road to carry out governmental functions. We are asking the State to provide funding parity for the rural communities of the YK Region.

The Alaska Native Claims Settlement Act (ANCSA) of 1971 makes it clear: the duties and obligations to protect and promote the welfare of Alaska Native people as citizens belong to the State and Federal government. The Tuluksak emergency highlights just one emerging crisis in rural Alaska: dozens of villages reliant on decades-old infrastructure that is now failing. Power plants providing electricity and heat to homes are often run by old diesel generators. When old generators fail, an entire community may lose power and families can lose several weeks or months of food. In addition, dozens of rural Alaskan communities, including Tuluksak, still lack basic running water and sanitation. The State of Alaska must do more to protect the health and welfare of its rural citizens, particularly after benefitting so considerably from rural resource development resulting from ANCSA.

We are acutely aware of the fiscal challenges, particularly as our State and nation are nearly a year into this devastating pandemic. However, when it comes to supporting rural Alaska, as Calista noted in an [editorial](#) published last March, "more than 40 years and 17 billion barrels of oil after ANCSA was signed into law, it is well past time for clear and specific action by our elected officials."

We look forward to continuing to work together and hope the Tuluksak emergency underscores the clear and critical need for your administration to support essential maintenance funding for the Kuskokwim Ice Road.

## FUNDING PARITY FOR THE YUKON KUSKOKWIM ICE ROAD

February 24, 2021

### Request:

*We are seeking funding parity for the Yukon Kuskokwim Region and respectfully request \$370,000 in annual operating budget funds to be appropriated to the Native Village of Napaimute to construct and maintain safety of the critical Kuskokwim Ice Road.*

### Background

The Yukon-Kuskokwim Delta region in Western Alaska is home to 56 federally recognized Tribes, nearly one-quarter of all the Tribes in Alaska. The YK Delta communities are located along the Yukon and Kuskokwim Rivers and the Bering Sea. There are currently six school districts within a region spread across an area the size of New York State. Our communities are not connected to each other by road system and the only access to each community, and the rest of Alaska, is by ice road, frozen tundra, or airplane.

The YK Delta region also has some of the highest costs of living in the nation and the COVID-19 pandemic has profoundly impacted the daily lives of YK region residents. Stores in villages are not always stocked, mail delivery is inconsistent and unreliable, and a recent fire devastated the Tuluksak community by burning down the only facility that provides fresh water to the village. In addition to the devastating fire, Tuluksak, along with many other YK villages, continues to suffer virus outbreaks.

With severe climate impacts now permeating our region, harsh winter blizzards frequently impede air travel and in such dangerous winter storm and blizzard conditions wind chill can cause frostbite on exposed skin in as little as 10 minutes. Flying in supplies and mail is not always an option with weather delays. The Ice Road can also be unsafe and difficult to navigate in certain weather condition so frequent safety maintenance is an absolute necessity.

### Current Status

The Native Village of Napaimute manages ice road construction and maintenance and a recently completed financial analysis of the true cost of Kuskokwim Ice Road maintenance established the needed

maintenance cost at \$370,000 annually. The Kuskokwim Ice Road serves communities all along the river from Kasigluk to Crooked Creek and in some winters is over 300 miles long, connecting 17 or more villages. When there is a justifiable need, such as for emergency services, fuel delivery, school construction, etc. the road can be extended even further up and down the river system.

Calista Corporation, the Native Village of Napaimute, Donlin Gold and numerous other public and private organizations throughout the region and beyond, help fund the Ice Road program. The Native Village of Napaimute has long played a leading role in establishing and maintaining the Ice Road and works cooperatively with all the tribal transportation departments along the River. Napaimute's leadership has been instrumental in maintaining the road annually, which allows families to travel to and from their communities along the frozen river. Vehicle access to Bethel can offer significant cost savings for food, fuel, and other essential supplies, and of course, access to health care. Over 200 vaccinations were recently delivered via Ice Road when a doctor and two nurses traveled to Kwethluk over the frozen Kuskokwim.

Advocacy by Napaimute and other partners also helps fund plowing and safety marking of the winter road. The cost to carve out the first road and maintain it throughout the season easily exceeds six figures. It is important to note that many State and federal agencies use the Ice Road regularly to perform governmental operations. Yet, the only maintenance funding that has been offered by the State has been by way of grant, which must be requested and secured annually.

Last year the Alaska Legislature included \$50,000 in operating funds for management of the Napaimute Ice Road, similar to \$50,000 in funding that the State has long appropriated to the Northwest Arctic Borough to provide safe and efficient ice road construction between Kotzebue, Noorvik, and Kiana. 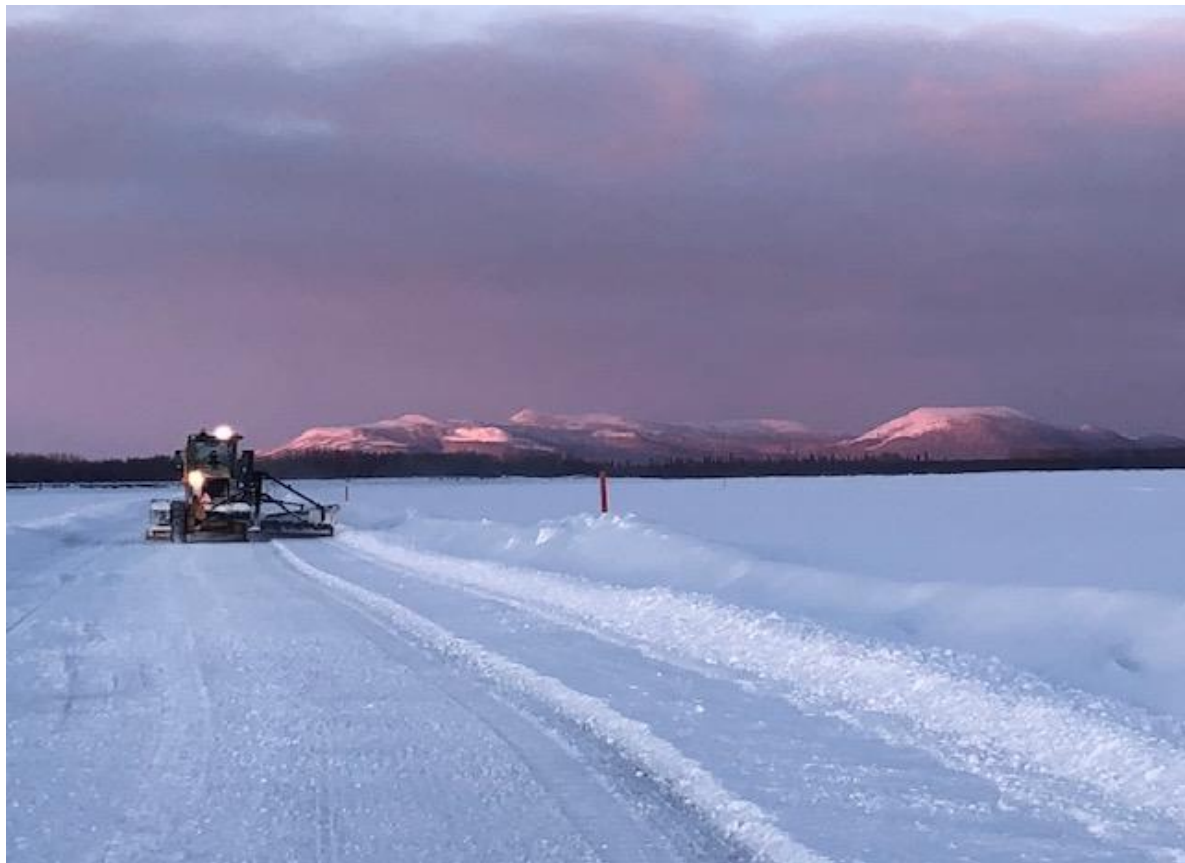

Dear Representatives Foster, Merrick, and Other Members of the House Finance Committee:

The Eyak Corporation submits this letter to express our support for Cordova Family Resource Center (CFRC) and other victim services non-profits across Alaska. We recently learned of an anticipated 30% reduction in funding from the Council on Domestic Violence and Sexual Assault to these non-profits due to reduced federal funds.

At CFRC, these cuts will likely result in staff cuts, program reductions, and the elimination of services despite experiencing higher community need for their services in the past year. These cuts will directly impact vulnerable victims of domestic violence and sexual assault, many of whom have no other safe place to go.

As the Alaska Native Village Corporation for the Eastern Prince William Sound, Cordova and Copper River area established pursuant to ANCSA, The Eyak Corporation is concerned about the impacts these cuts will have to our Shareholders, Descendants, and their families. We have 587 Shareholders, with approximately 180 living in Cordova and an additional 160 Shareholders living in other parts of the State.

As we all unfortunately know, Alaska continues to have some of the highest rates of sexual and domestic violence, including violence against children. We urge the legislature to help fill this funding gap.

I am writing to you about a cut to a federal funding stream that has a dire consequence for victims of domestic violence and sexual assault. The Council on Domestic Violence and Sexual Assault (CDVSA) receives federal funding from the Victims of Crime Act (VOCA). Victim service agencies were just informed that they would be facing 30% cuts in the upcoming fiscal year because of cuts to VOCA which will slash funding for core services for victims of domestic violence and sexual assault.

I support Abused Women's Aid In Crisis (AWAIC) in Anchorage. AWAIC is the only emergency shelter for victims of domestic violence in our community. Due to COVID-19 they have already had to reduce services to victims in the community. This cut will drastically reduce the funding they receive to maintain basic services for those they serve who are among the most vulnerable in our community.

I am asking that the legislature use general funds to make up for the loss of this federal funding. It is critical that AWAIC maintains its services for the safety of victims of domestic violence and sexual assault.

My name is Mark Lackey. I am the Executive Director of CCS Early Learning and offer my testimony in support of the recommended \$5,000,000 increment that was offered by Representative Story in House Finance DEED subcommittee for increasing pre-k services in Alaska.

CCS Early Learning is celebrating our 50th Year (since 1971) of providing high quality early childhood education services in Chugiak, Eagle River, and the Mat-Su. I have worked for CCS for 22 of those 50 years and I am very proud of the countless young children (and their families) that we have assisted to be more prepared for success in school and in life. Our primary programs are Head Start and Early Head Start. These programs are primarily federally funded with funds flowing directly from the Federal Office of Head Start to 17 local grantees around the State of Alaska (CCS is one of these). Currently, nearly \$60 million of federal funds come into our state annually for these programs - and in some years millions more are obtained for one-time facility projects, school buses and the like. I have provided a document from the Alaska Head Start Association that shows federal funds to Alaska since 2008.

Alaska has long been behind the rest of the nation in supporting Pre-K services. This recommendation for a two year increment is a fabulous opportunity for our state to increase the number of children and families that enter the school years more prepared.

Having worked in this area for 22 years, I also have experienced the ongoing challenges that come with a fragmented and piecemeal approach to early childhood education. This recommended increment also presents an opportunity for us to establish more coordination and collaboration - more efficiency and less duplication. With that in mind, I offer four suggestions which I believe will strengthen early childhood education in Alaska, both now and in the future.
