We are testifying on behalf of the organization, Mat-Su Moms for Social Justice, in support of House Bill 66, sponsored by Representatives Tuck and Schrage, and against Senate Bill 39, sponsored by Senator Shower. Mat-Su Moms for Social Justice is a group of 318 individuals living in greater Palmer and greater Wasilla.

Our organization stands in support of House Bill 66. We believe it is a strong voter enhancement bill because it makes an often confusing process simpler and more consistently predictable for Alaska's diverse group of voters.

Since our country was built on democracy, it is only right that voting get easier — not harder. And SB 39 will indeed make voting more difficult by making it a crime to help one's family members and friends vote, limiting by-mail voting, requiring witnesses for absentee ballot signatures, and changing the popular 2016 PFD automatic voter registration law.

Many influential Alaskans have spoken out against SB 39, including Kendra Kloster, executive director of Native Peoples Action, and Celeste Hodge Growden, president of the Alaska Black Caucus.

We stand with these Alaskan leaders. In 2021, it's time to improve upon voting rights, not make them worse. SB 39 risks knocking Alaska backward into days of voter suppression and inaccessibility that dangerously echo Jim Crow-era laws. Put simply, SB 39 would be an insult to the activists who fought long and hard for voting access in Alaska.

Our state already has a long and turbulent history when it comes to equitable voting access. Elizabeth Peratrovich helped to secure equity and anti-discrimination rights for Alaska Native people with the passage of the Alaska Equal Rights Act of 1945, but it took over 40 more years, the passage of the federal Voting Rights Act of 1965, and two long federal court cases — [Nick v. Bethel](#) and [Toyukak v. Treadwell](#) — to achieve baseline voting rights for Alaska Native people.

If passed, SB 39 would make it more difficult for Alaska Natives — especially those who live in rural areas and/or who speak Indigenous languages — rural Alaskans, the elderly, disabled people, members of the military, Slope workers, fishing industry workers, and more to vote early or absentee.

House Bill 66, on the other hand, aims to make voting easier for all Alaskans by allowing us to register to vote on Election Day and expanding accessibility to mail-in voting. It would require the Division of Elections to include postage-paid return envelopes with absentee

ballots, make early voting locations consistent year after year, and increase pay for poll workers.

HB 66 also proposes eliminating the witness requirement for absentee votes. Alaska is one of only a handful of states to cling to this prohibitive and discriminatory witness law, which disproportionately and negatively impacts people of color, those with disabilities, and the elderly, all of whom deserve fair and easy access to their vote.

Mail-in voting, along with pandemic-related accessibility measures, helped result in a record voter turnout for Alaska in 2020. As citizens of a democracy, we should all agree that increased voter turnout is a good thing.

If state lawmakers are frightened of increased voter turnout to the point that they conjure up cases of serious fraud with no supporting evidence and write bills like SB 39, this is frankly anti-American and anti-democratic, and it is a major cause for concern.

The Mat-Su Moms for Social Justice urges our lawmakers to pass HB 66, which drives our state closer to equity and justice for all, and to eliminate SB 39, which would not only suppress and discriminate against Alaska voters but would also place Alaska under the same national scrutiny and decreased tourism and support that Georgia's voter suppression bill has provoked.

In the spirit of moving our state and country closer to social justice and not further away from it, we once again urge you to pass House Bill 66 and to eliminate Senate Bill 39.

I would like to testify in favor of HB 66.

I believe that the strength of our democracy depends on the degree of participation in elections. HB 66 addresses issues which present obstacles to participation by individuals who may have restricted access to the polls, for reasons of limited transportation or mobility, and improve access to voting for a variety of voters who might be prevented from voting for a number of reasons. Those reasons might be something as simple as no access to a stamp, to voters who have recently moved or come of age, or had their ballots improperly rejected for poor penmanship in signature matching.

There is no good reason not to level the playing field for voters who are home-bound, who lack transportation, who don't have a stamp, just moved or broke a finger the day before signing an absentee ballot.

Of these issues, the most important to me is to notify voters of the rejection of an absentee ballot, and to offer an opportunity to cure those ballots. Signature matching is a subjective judgment, and a poor signature match should not disenfranchise a voter.

I approve of other measures in HB 66, including the provision allowing candidates to have their own poll watchers, and increasing pay for poll workers to \$15/hour.

To the House Judiciary Committee,

I am an Anchorage resident and am writing on behalf of both myself as a private citizen and as a senior researcher with Sightline Institute, a regional, nonpartisan public policy think tank focused on Alaska and the Pacific Northwest. In both capacities, I support HB66. It contains many of the pro-voter recommendations I made last year in the following article:

Among them are a cure process, dropping the witness requirement, and setting up “one and done” absentee voter sign-up, meaning we Alaskans would only need to sign up once to receive absentee ballots for all statewide elections in which we are eligible to participate, rather than signing up every year.

Security in elections is of paramount importance for a functioning democracy. The policy proposals in HB66 do not present credible threats to the security of Alaska’s elections. That is, they would not all of a sudden allow ineligible voters to vote, nor would they enable any person to cast more than one ballot AND have it count. Cases of voter fraud in Alaska are already negligible—that is, they are so low they have no effect on the outcome of elections. The pro-voter policies in HB66 would not weaken any of the safeguards already in place for verifying the identities and eligibility of voters. And although the proposals may be new to Alaska, they have been implemented successfully in a significant number of states.

Take the witness signature requirement. The state Division of Elections has no way to verify the authenticity of witness signatures. Therefore, they play no actual role in ballot security while also inconveniencing voters and making it more likely their ballots will not count. It thus makes sense to eliminate witness signatures as a requirement and focus on more effective security measures, such as electronic signature verification for voter signatures.

Finally, ALL voters, not just those from particular political parties, benefit from better access to voting. This Washington Post op-ed by Robert Griffin of the bipartisan Democracy Fund Voter Study Group found that the reflexive tendency to assume that more accessible elections helps Democrats and more restrictive practices help Republicans is not based on solid data. “The reality is that election laws are complicated and [incentivize voter behavior in complex ways](#) that are context-dependent. This makes it very difficult to predict precisely who would benefit from a given overhaul — if anyone at all, Griffin writes.
