### Analysis

This bill would allow for the creation of the Alaska Invasive Species Council. The Council would include a seat for the Commissioner of the Department of Environmental Conservation, or their designee, and allows for audio or video teleconferenced meetings. Serving on this council is not expected to have a material impact on the workload of the Department, or generate travel costs.
