### Analysis

This legislation extends the sunset date for existing funding allocations for program and grant distributions under AS23.15.835(d) for the Alaska Technical and Vocational Program (TVEP) through June 30, 2024. Funding authorization for the TVEP recipients was included in the FY2022 Governor's budget request and is modified by this fiscal note.
