Appointments Made to Fill Vacancies That Occurred More Than Thirty Days after Death or Resignation of Legislator

You asked for the times in which a governor's appointment to fill a seat in the Alaska State Legislature occurred more than 30 days after the vacancy arose.

The procedures for filling legislative vacancies are outlined at AS 15.40.320 through AS 15.40.470. Under AS 15.40.320, the governor must appoint a "qualified person" to fill a vacancy within 30 days. The appointee must meet the qualifications of a legislator as defined in Article II, Section 2, of the Alaska Constitution, must be a member of the same political party as the predecessor, and is subject to confirmation by a majority of the members of the legislature in the same political party and the same chamber as was the predecessor. If the governor's appointee is rejected, the governor must select another appointee—subject to confirmation—within ten days (AS 15.40.350).

The governor may not fill a vacancy if the remainder of the term of the outgoing legislator will expire, or if a vacancy in the state Senate will be filled by a special election before the legislature will next meet, convene, or reconvene (AS 15.40.320).

In the following table, we show, for each vacancy that was filled more than 30 days after the death or resignation of the legislator, the name of the former legislator, the effective date of the vacancy, the reason for the vacancy, the name of the appointee, the date the appointee was sworn in, the number of days the position was vacant, and any further notes on the appointment. We used the date of confirmation to determine whether the vacancy was filled before or after 30 days. In other words, we included those instances when an appointment was made before the 30-day deadline, but the confirmation occurred more than 30 days later. The table also includes those vacancies that were not filled by the governor under AS 15.40.320. We referred to the *Alaska Legislature Roster of Members* 1913-2020 to compile this information.
