FOR AN ACT ENTITLED

1 "An Act relating to voting and elections; relating to voter registration; relating to ballots 2 and a system of tracking and accounting for ballots; relating to retention of election 3 data; designating as a class A misdemeanor the collection of ballots from other voters; 4 designating as a class C felony intentionally opening or tampering with a sealed ballot, 5 certificate, or package of ballots without authorization from the director of the division 6 of elections; designating as a class C felony breaching, hacking, altering, or tampering 7 with election data or ballots; designating as a class B felony election fraud; designating 8 as a class C felony sharing election data results before the close of the polls on election 9 day; and providing for an effective date."
