A BILL

FOR AN ACT ENTITLED

- 1 "An Act relating to state education policy; relating to school climate and connectedness;
- 2 establishing the School Climate and School Connectedness Improvement Committee;
- 3 and providing for an effective date."
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:
- * Section 1. The uncodified law of the State of Alaska is amended by adding a new section
- 6 to read:
- 7 SHORT TITLE. This Act may be known as the School Climate and School
- 8 Connectedness Improvement Act.
- 9 * Sec. 2. AS 14.03.015 is amended by adding a new subsection to read:
- 10 (b) It is the policy of the state to acknowledge and take into account the
- principles of early childhood and youth brain development and, whenever possible,
- consider the concepts of early adversity, toxic stress, childhood trauma, and the
- promotion of resilience through protective relationships, supports, self-regulation, and
- services.

1	" Sec. 3. The uncodiffed law of the State of Alaska is affielded by adding a new section to

3	SCHOOL CLIMATE AND SCHOOL CONNECTEDNESS IMPROVEMENT
4	COMMITTEE. (a) The School Climate and School Connectedness Improvement Committee
5	is established as an advisory committee in the Department of Education and Early
6	Development.
7	(b) The committee consists of the following members appointed by the governor:
8	(1) two current school superintendents;
9	(2) two retired school superintendents;
10	(3) three current K-12 teachers;
11	(4) three retired K-12 teachers;
12	(5) four parents of K-12 students;
13	(6) one representative from the division in the Department of Health and
14	Social Services with jurisdiction over juvenile justice who is involved in direct youth services;
15	(7) two school social workers;
16	(8) two school counselors.
17	(c) When appointing committee members, the governor shall consider
18	(1) geographic representation and appoint not fewer than six members who
19	reside in communities that are rural, as defined in AS 14.43.700; and
20	(2) representation across grade levels, appointing at least one current or retired
21	teacher of students in each of the following:
22	(A) kindergarten through grade two;
23	(B) grades three through five;
24	(C) grades six through eight; and
25	(D) grades nine through twelve.
26	(d) Committee members serve without compensation and are not entitled to per diem.
27	(e) The committee shall meet at least once a year. Meetings may be held by audio or
28	video teleconference.
29	(f) The committee shall organize regional and subject-matter subcommittees to
30	address the specific needs of English language learners, vocational and technical education,
31	special education student athletes and other subject matter the committee considers

2	* Sec. 4. The uncodified law of the State of Alaska is amended by adding a new section to
3	read:
4	DISTRICT SCHOOL CLIMATE AND SCHOOL CONNECTEDNESS PLANS. (a)
5	Each school district shall develop a school climate and school connectedness plan to improve
6	student, staff, and family relationships and establish connections and partnerships between
7	district schools and local communities. The School Climate and School Connectedness
8	Improvement Committee shall support districts in plan development and implementation.
9	(b) A district shall designate district representatives to coordinate with the committee
10	and draft the district's plan. The plan must identify actions the district will take to improve
11	school climate and school connectedness.
12	(c) A plan may incorporate use of
13	(1) social and emotional learning;
14	(2) trauma-informed and healing-centered practices;
15	(3) instruction in cultural competence and alignment with indigenous values;
16	(4) multi-tiered support for behavioral intervention, including restorative
17	practices that are nonshaming, nonpunitive, and effective in addressing conflict and repairing
18	relationships;
19	(5) methods for reducing racial disparities, disproportionate behavior

- * Sec. 5. The uncodified law of the State of Alaska is amended by adding a new section to read:
 - PLAN SUBMISSION. On or before January 1, 2023, each school district shall submit a school climate and school connectedness plan to the commissioner of education and early development, the senate secretary, and the chief clerk of the house of representatives and notify the legislature that the plan is available.
- * Sec. 6. Sections 1 and 3 5 of this Act are repealed July 1, 2023.
- * Sec. 7. This Act takes effect July 1, 2021.
