RE: House Bill 198, Alaska Community Health Aide Appreciation Day

Dear Chair,

The Alaska Native Health Board (ANHB)¹ writes in support of House Bill 198 to proclaim September 10 as Alaska Community Health Aide Appreciation Day. Community Health Aides and Practitioners (CHAPs) are the backbone of rural Alaska health care.

The CHAP Program was born out of necessity to have providers in our rural Alaska Native communities. Our Community Health Aides/Practitioners are the backbone of the Alaska Tribal Health System. Tracing their modern history back to the tuberculosis epidemic of the 1940s and 1950s², the CHAP Program has grown to provide frontline care in our rural communities and they are usually the first providers our patients see in the Alaska Tribal Health System. They have continued their work to help their communities, even in the face of the COVID-19 pandemic. Our CHAPs are often community members who have strong ties to and are respected and important members of their communities.

The Alaska CHAP Program is authorized in federal statute³ and has been so successful at delivering care to our Alaska Native communities, that it now includes community level therapists in the disciplines of behavioral health and dental health care. The program has become an international model and the model is now being adopted by the federal Indian Health Service to help deliver care in rural areas of the lower 48, where providers are hard to recruit and retain.

Our CHAPs are an example of the hard work and self-reliance of our Alaska spirit. They
