Out year costs for both the 3-year Early Education Grants and the PEF will be adjusted annually within the Department of Education and Early Development's (DEED) budget based on how the grant program rolls out and the number of districts that by-pass the grant program and seek DEED's approval of their early education program and those students roll directly into the Foundation Formula.

School Improvement Reading Program is repealed on June 30, 2034 (5 Reading Specialist positions, \$830.5 total annual program cost) (Fiscal Note #5)

***Early Education Grant Program, Parents as Teachers Program, and average daily membership (ADM) funding are repealed on June 30, 2034.

Early Education Grant Program: 3 DEED supporting positions (\$354.9 annually), Total Grants: \$32,967.8 (Fiscal Notes #2 and #3)

Parents as Teachers Program: \$474.7 annually (Fiscal Note #3)

Early Education ADM Funding: \$35,973.9 (\$26,973.7 grant cycle funding moved to ADM, \$9,000.0 cap on programs that roll directly into ADM) (Fiscal Note #1/#4)
