Southcoast Region

•DOT provides the maintenance on these facilities under reimbursable maintenance agreements. The state provides these services to the communities to help and partner with them because they have no other infrastructure in the area or they lack the expertise to maintain the specialty infrastructure.

Central Region

•The roadway agreements listed for Central Region above have been entered into to support operational efficiencies in both department and local entity infrastructure. By exchanging winter roadway maintenance this allow for more efficient use of resources through adjustments to plow routes and/or equipment. Exchanging activities (striping for winter maintenance) allows the sharing of qualified staff and equipment to perform specific work.

Northern Region

•Murphy Dome Road – According to the department's records the department has maintenance responsibility from Mile Point 0.00 to 8.56 and the Fairbanks North Star Borough (FNSB) has maintenance responsibility from 8.56 to 15.41 (end of roadway). The FNSB does not have road powers and only provides maintenance to isolated areas within the borough through use of contractors and establishment of Rural Service Areas. The area beyond Mile Point 8.56 has very little private development and or population base to support a Rural Service Area capable of funding roadway maintenance activities.

While some Alaska residents benefit from the department maintaining the entire length of Murphy Dome Road the primary purpose for performing year round maintenance is to provide consistent access to the Long Range Radar station which is part of Alaska Radar System. This radar station does require routine maintenance and fuel deliveries to support is operations so consistent access is required for its operations.

•City of Eagle, City of Fairbanks, Eielson Air Force Base, and Gunsight Mountain Homeowners Association are all reimbursable service agreements to deliver specific maintenance services to the listed organization. The state provides these services as assistance to these entities/communities because often they do not have other infrastructure or resources in the area to perform these duties and/or they may lack the expertise or experience to perform the specified work on their infrastructure.
