I look forward to seeing your long-range plan re a sustainable budget before the legislature meets in August. I think a 5% [or close to 5 %] POMV draw should be a crucial part of this. If you propose budget cuts, and or revenue enhancements, be specific. One may get lots of support from the public by saying, for example, that we will cut the UGF spending by ,say, 10 %. This support would diminish if a community realized its public safety response, for example, would be diminished.

AD-HOC draws, like the \$ 3B one the governor proposed, can lead to a continuation of a slippery slope that, in the past, resulted in the CBR being reduced from \$ 16 B or so to around \$ 1B.

One idea that I like re the PFD is to give each of us a sustainable amount like \$ 500 and use the money saved from a larger amount to increase HESS funding to help those who are in real need. At least half of us will survive just fine with \$ 500. This is especially true this and next FY with all the CARES related federal funding. I'd rather see my share of a personal income or sales tax used this way rather than to have me pay, say, a \$ 2000 income tax one day, and then, in return, get a \$ 2000 PFD.

Re the POMV split, I would like to see a serious discussion about splits other than 50/50 such as 75/25. Is there some magic about 50/50? I'm very concerned about putting a large PFD guarantee in the constitution. Does that mean that if the POMV amount [based on a 5 yr average] falls a lot, we all get a PFD but we eliminate much of public safety and education. I don't think

you want that.

In your discussions , I'd like to see more said about the fact that the premise under which the 1980 [statutory PFD] formula was enacted is no longer valid. Then, none of our government was funded by the PF earnings. We could have given it all as PFDs and our government would have been fine. The opposite is true now with 2/3 of our UGF revenue coming from the PF earnings. Talking more about this would help the legislature and the public better understand the issues.

Dear Fiscal Policy Working Group members, I write to you, as an Alaskan of 65 lifelong years.

As you deliberate and work to formulate a just PFD for the over 600,000 eligible Alaskans, please remember that 130,000 Alaskans are Senior citizens, as I am. Thirty percent (30%) of Senior households have incomes of below \$30,000 per year. My income from SSA is only \$13,000 a year. I always used my PFD for property tax, winter heating bills, and general living expenses. Over the last 6 years, the Legislature has taken from me and all Alaskans over \$10,000.

Your recommendations and agreement on the 2021 PFD will have a dramatic effect on 30,000 plus Seniors, in addition to all other Alaskans. To put that into perspective, legislators will be receiving over \$36,000 tax-free per diem payments for a mere 4 months of living expenses.

While a few Alaskans may not "need" the PFD, they are certainly entitled to it by the 1982 statutory formula for the PFD. It wasn't until SB26 was passed in 2015 that the confiscation of the PFD began. This confiscation needs to end.

A constitutional amendment for the PFD will protect it permanently! I support passing a PFD resolution now, with no more paid out for government than for Alaskans. It is time to take the PFD off the table, so the Legislature can do the job they were elected to do, instead of wasting your time fighting over Alaskans rightfully owned Permanent Fund and PFD.

I know that Alaska's fiscal situation is precarious. I know that it is expensive to live here and support Alaska's people. I also know that we are a relatively new state and suffer from the lack of centuries of infrastructure development. I also know that, though we pride ourselves on self-sufficiency, we appear unwilling to pay for the services we and others need.

I suggest we use information from our researchers to make the decision. I also think our legislature needs to make the decision to move us forward. People will not vote to tax themselves.

A Feb. 2017 research paper from the Institute for Social and Economic Research (ISER) is titled *Effect of Alaska Fiscal Options on Children and Families*

Cutting the PFD is most costly to families with children, especially to single parent families. A graduated income tax is the least costly revenue generating option for the single parent family. (it is the most costly for households without children, while their PFD cut is less costly).

In that paper, the authors also explore other options. Perhaps we need a tax package, rather than just a tax.

In May 2019, ISER presented a paper titled, *What do we know about the effects of the Alaska Permanent Fund Dividend?* Clearly, it is important in Alaska and probably should remain in some form.

Some of the main findings to consider include:

- Alaskans spend more on non-durables (e.g. food, fuel, clothing) in the first quarter after the dividend payment
- the PFD has a small, but positive effect on birth weight and childhood obesity, especially for low income mothers
- the PFD has resulted in substantial poverty reductions for rural Alaska Natives, especially the elderly
- The PFD increases income inequality (probably because there is no

income requirement.)

Member of the Fiscal Policy Working Group:

Thank you for taking the time to read my idea. It is based on past and even present state and federal government funding programs. The goal of my plan is avoid paying a PFD to ALL while collecting back a portion from SOME. It will NOT be popular....

In simple summary:

The PFD would be converted to an age & needs based test

If you're still reading, here are the particulars, corresponding history associated and net fiscal affect

1. Only those age 18 and over will qualify to receive the divided
2. Only those with income less than \$61,000* annually will qualify

*this amount is suggested based on average wage data provided by SoA DoL. The plan is not limited to this amount and, if the means testing standard of annual wage were to be used, it would need to be adjusted annually as well for dividend application purposes.

Historical correlation:

In 2003, then-Governor Frank Murkowski authored a plan to radically alter the Longevity Bonus. As a reminder, the original Longevity Bonus was based only on 2 factors: age and time of residency in Alaska.

After much hue and cry, we have a program today that remains age based, yet adds an element of need. The wealthiest Alaskan's regardless of age or time of residency do not qualify for the program any longer.

Also, the recent federal stimulus and aid checks have been age and income based. It's true that children were included in one round of payments, but at a reduced rate and paid directly to the parents.

Still reading?

The original statutory formula must be amended or deleted rather than just being ignored as is the case now. Attached is my commentary and a specific proposal using estimates for discussion purposes. (I have the privilege of hosting radio station KSRM's "Sound Off" call-in talk show; this was originally promoted there)

Thank you for working with each other to develop a comprehensive long range fiscal plan for Alaska. No longer can we afford to “kick the can down the road.”

To me it is more important to fund essential government services than it is to fund large PFD checks. We have to be adults and recognize that the free ride is over. Nor can we “cut the budget” to close the fiscal gap. The budget has been cut substantially already. To the point where essential services are not being adequately funded.

We are the only state in the country that doesn’t have a broad based tax (sales tax or income tax). And we hand out PFD checks. The 50/50 plan requires us to create new revenue. So it's counter-productive. Corporations do not pay dividends on money they haven't yet made.

If we are concerned about people dropping into poverty if they don't receive a PFD, then the PFD can be made needs-based.

Minors' PFDs should be placed in an interest-bearing trust, unless the family lives below the poverty line.

If the "oil belongs to all of us, so we each deserve a piece", then we each deserve a piece of minerals, salmon, timber, tourist revenue, etc. This kind of thinking generally repulses the majority of Alaskans as being "socialism".

I prefer to see a budget that prioritizes the needy and helps create a more desirable environment for a diversified economy. If this requires taxation, then I'm ok with that, as long as SB21 is revoked. The PFD can be a tax credit.

Income Tax Revenue

We have already made deep cuts to services and the University. The legislature should continue their ongoing annual evaluation of spending priorities but shouldn't cut any deeper here until the other levers get pulled.

Those are the big four.

As we all know the state is at a crossroads regarding how to handle the Permanent Fund, given the current and future economic climate. While it is tempting to spend the fund now to stimulate the market (whether the money would even stay in Alaska or spent elsewhere is debatable), this is likely kicking the can down the road for a much bigger issue whose outlook is becoming more certain by the day. Alaska is unfortunately a one trick pony when it comes to revenue, and it's future is rapidly becoming clearer. Alaska's oil output is a quarter of its peak in the 1980s and falling lower every year. If we're being realistic then it's safe to say ANWR is unlikely to ever be developed, and other large projects such as the Willow are becoming questionable, oil companies don't have the money for big investments like they use to especially when the politics and courts are preventing development. The ANWR lease sale outcome is another example of this reality.

The Permanent Fund is Alaska's only future if we invest it right to generate revenue, to replace oil.
