I am writing to notify you that I have not received my full amount of the Permanent Fund Dividend I was eligible to receive for the dividend years circled below : 2016, 2017, 2018, 2019, 2020, 2021.

As you know an individual who complies with the stipulations of AS.43.23.005(a) is eligible to receive one permanent fund dividend in an amount to be determined under AS.43.23.025. I complied with the stipulations of AS.43.23.025 for years (circled) 2016, 2017, 2018, 2019, and 2020. (Electronic application forms attesting to these facts are on file with your office). Therefore, to the best of my knowledge, I was eligible for and should have received the following payments:

\$2,085 for the dividend year of 2016, \$2,458 for the dividend year of 2017, \$2,924 for the dividend year of 2018, \$2,884 for the dividend year of 2019, \$2,895 for the dividend year of 2020, and \$3,687 for the dividend year of 2021.

But I have only received the following payments :

\$1,022 on October 16, 2016, \$1,100 in October 2017, \$1,600 on October 2018, \$1,606 on October 2019, \$992 for 2020 and nothing for 2021.

Based on the annual rate of return posted on line 1 -column g, of the June 30th reports by the APFC board of trustees and the backed owed balances, I am owed the unpaid balance, plus the earnings on that sum. (Circle one below)

Hello AK fiscal policy working group,

I am a lifelong Alaskan and plan to be here for the rest of my life. I am writing to share a few brief comments about the current budget debate and the discussion of the PFD. I couldn't make the meeting here in Fairbanks, and I appreciate the opportunity to write them in.

- I have observed the steady erosion of state services in my lifetime, and this has increased in more recent memory. Given inflation, flat budgets are inherently a cut. A top priority to me is education and state services, and I worry that our teaching positions are non-competitive (at all levels of education). The university system is critical to the long-term prosperity of our state, especially as oil diminishes, and we need to reflect that in our budget priorities. We have cut so much already, it is clear to me that additional cuts are going to drastically diminish the quality of life that we expect as Americans.

- The issue at hand is clear - we need to diversify our revenue. I support a broad-base state income tax for a number of reasons - it will capture seasonal workers who spend little time or money in our communities and have a moderated effect on rural subsistence communities. A sales tax would not accomplish either of those things. I know the 'T' word is anathema in Juneau, but we have delayed the decision for too long and used up our savings account. A state tax isn't new, and it is time we paid our fair share again. Please find the courage to pursue this, we are ready to pay our fair share.

- I don't care about the PFD formula, I care about what kind of PFD is sustainable and best for the state given the conditions at the time. The whole idea of this thing is that it is managed as a trust for the greater good, and will bolster the economy long after the oil runs dry. I absolutely do not support efforts to enshrine the PFD into a formula that would reduce our options for when we face difficult decisions and unexpected scenarios (such as a global pandemic). I urge you to make decisions about the PFD based on the grandkids of our children - what would best serve them decades from now? I support the goal of reaching 100 billion in the principle account while the oil is still flowing so that it provides a sustainable input into our diverse revenue stream for years to come. There is going to be a lot of pressure to get the biggest payout right now, but please have courage and take the long-term perspective.
