My name is Kathleen Shoop and I am representing myself here in Alaska since 1992.

Back Owed PFD Amount close to \$14,000, is due to the failure to follow several statutes including AS 43.23.025 (historic PFD formula) and Sec. 37.07.014, the budget process where they set performance criteria in the budget to contain government expenditures. The PFD is at over \$80B, it had a rate of return last year over 28%, gas is at over \$70 a barrel, and the 5 year rate of return on the fund is over 11%. They should take a POMV overdraw, pay us the back owed with interest, and use Sec. 37.07.014 to cur the size of government. This money will give a great economical boost to our State which is exactly what we need at this time.

PFD is the best thing that the State has going for it and by taking this money from the people you are destroying the Alaskan economy and truly are hurting the people.

Representation Kreiss-Tompkins,

Briefly I want to address the State budget situation and express my support for some key items, and concerns regarding others. To begin, I do not support an overdraw of the Earnings Reserve Account--even one time. Once that line is crossed, it will be too easy to do it again. The point of the reserve was to keep it sacrosanct. Though we are at a rough juncture, there are options. Dipping into ERA shouldn't be one of them.

I am also not in favor of expanded PFD payouts. While PFD's are an important input to income for a number of Alaskans, bankrupting the system and the State is not a viable option for program longevity.

I applaud and support the key indicators selected for Healthy Alaskans 2030. In particular, measures that addresses mental health, substance abuse including alcohol, access to prenatal health care, and improving high school graduation rates are key items on which to focus funding.

I support restoration of funding for Public Broadcasting. Especially during response to COVID, public broadcasting has played a key role in getting important information out to the residents, visitors and entities doing business with the State. It should be treated as the vital function that it is, especially when notices are transmitted via the emergency broadcasting system.

Ferries continue to be critical to the economy and quality of life in Southeast Alaska and throughout the State. They need adequate funding just as other parts of Alaska's transportation infrastructure are funded. There continue to be opportunities for revenue generation and marketing that the AHMS has thwarted or ignored. We've hand-wrung and studied and committed and haven't yet made progress. Let's get to it. As the director of a small museum, I see visitors to the State that use that system. It has also been integral to student travel opportunities. It used to be a reasonable cost for families traveling within the State and to the Lower 48. It allowed small businesses to thrive that required travel between communities. It moved State vehicles and personnel to projects around Alaska. And it brought large numbers of visitors to the state, whose social media and personal contacts generated free advertising for Alaska communities and businesses.

Finally, it is time to re-institute a state income tax. If we are looking at possible short-term solutions, that is a much better method of capturing revenue than it would be to impact the ERA. Propose a 5 year tax program, to be re-evaluated at the end of the term. That is a much more fiscally responsible option that will also capture revenue from those working seasonally and then leaving the state.



Good evening,

I've been listening to the testimony my fellow Alaskans have been providing over the last hour or so, and would like to add this missive to the record. The PFD is, in my opinion, akin to Social Security in that Alaskans (largely) view it as sacrosanct, untouchable, the third rail. Because former Governor Walker and his lackeys in the legislature did touch it, we are now in this position. This entire problem could be solved in a matter of minutes if this legislature were to simply adhere to the statutory formula and pay everyone the PFD that state law requires. I heard plenty of other people talk about how the budget has been "cut to the bone" and that there is no money left. I don't know where those people are getting their news (probably the ADN), but the Permanent Fund made \$18 *billion* dollars last year. I think there's quite enough just in last year's earnings to give everyone a full PFD this year, and repay what was stolen from them in previous years dating back to Walker's original theft. But many members of this legislature are too beholden to special interests, too inculcated and rigid in the ways and methods of big government to perform their legal responsibility. 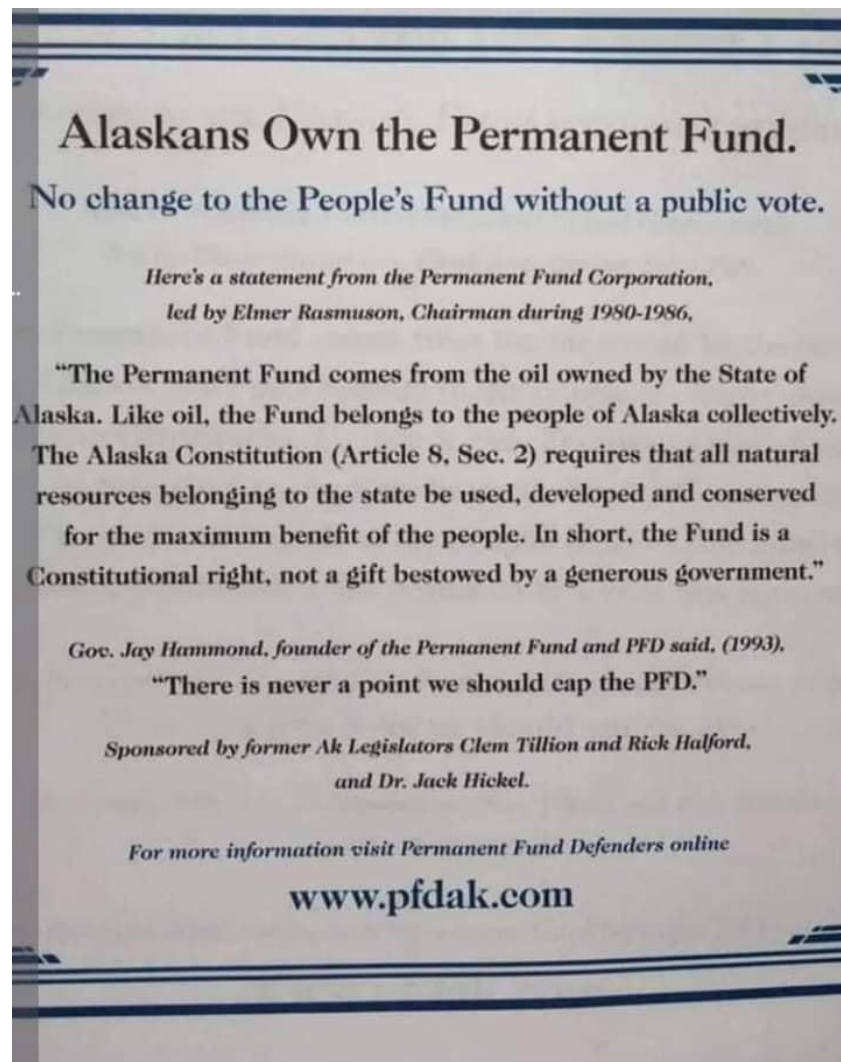

Thank you for this opportunity to testify.

My belief is that the Permanent Fund was established to share the wealth from a non-renewable resource with future generations of Alaskans. Not to pay a PFD. Protecting the Permanent Fund should be of utmost importance, and I am pleased that a few years ago the legislature passed a POMV statute to protect the Permanent Fund, although I believe the 5% draw limit should be reduced until the Permanent Fund reaches \$100 billion. If a constitutional amendment is necessary to protect the Permanent Fund, then I would support that. I am against any overdraft of the Permanent Fund. I am glad that the fund value has increased tremendously over the last year, but this is not a reason to break the POMV statute.

The PFD should not be constitutionally protected. Paying a PFD is not nearly as important as the many services that the State provides. The PFD does not have "First Call", it is one of numerous budget items and should compete against other government programs for prioritization and funding. Our Supreme Court has already determined that the PFD is subject to appropriation, thus any PFD amount paid is a full PFD. I do not feel that I am owed any back pay for historical reduced PFD's. Governor Dunleavy decided to reduce the PFD to \$0.00 this year, I am satisfied with this PFD amount and believe that he should be credited with the \$0.00 2021 DUNLEAVY PFD. The current PFD statute should be eliminated, and replaced with a statute that commits to attempting to pay a PFD as money allows. Perhaps a \$500 PFD cap should be included until the Permanent Fund reaches at least \$100 billion. While I believe that we should seek to receive the maximum compensation for our oil, I am not in favor of any income tax or sales tax to pay a larger PFD.

While I am against constitutionalizing the PFD, if this is pursued I believe that it should not be a 50/50 split. For the first 30 plus years the state has not used their portion of the 50/50 split, rather this money was left in the fund and continued to grow. My belief is that this non utilized money, as well as income from this money, should be subtracted from the Permanent Fund balance to determine an amount of money available for splitting.

I am of the belief that there are still minor savings to be found in the State of Alaska budget, and that as these savings are found they should be implemented. I am not naive enough to believe that we can find enough savings to allow for paying what some feel they are entitled to. There are some reductions that I would support that many others would not. The legislature was structured to balance the desires of the public and to provide the services that the citizens collectively desire. I am satisfied with that.

For the record my name is Katie Botz and I am a concerned constituent of our beautiful Capital City Juneau, Alaska. I am writing to you representing myself.

I understand that we are in a huge deficit, but the People's PFD is NOT the problem!! As you are well aware, if you paid attention at all, majority of the people were talking about the PFD. The REAL problem is Legislators isn't budgeting the paycheck properly. I'm 150% certain that if each of you were to have to budget the exact SAME amount of funds in your personal account, you'd probably manage the paycheck much differently. Please do a better job at managing the State's paycheck FOR THE PEOPLE. I respectfully request that the State Legislators place the PFD into our Constitution and place an END to the Political Football game which is being played each year. It shouldn't matter who wins the final field goal, either Legislators or Governor, please place an end to the Political Football Game to the PFD!

Alaskans are now used to the mindset of entitlement when it comes to the PFD. If I am understanding correctly, PFD was never supposed to be an entitlement by Hamilton. As a constituent, I had my PFD every year until my adulthood. I spent 10 years where my PFD was confiscated, and guess what? I survived!!!! If Alaskan Legislators can stop with this political football game, then perhaps we can end this entitlement with our PFD.

As a constituent, almost 34 of age, I live alone in a one bedroom apartment. My car is 20 years old, and I seriously question how safe my neighborhood is these days. Have approximately \$6K debt in dental, \$25K debt in hospital bill due to a bad accident in 2018, and numerous \$ amount of debt in credit cards bills. I have to request extra hours each day at work just to stay afloat. The sole reason why I am sharing with you is because I understand some of the difficulties which people have on a personal level. Life in Alaska is brutal expensive to live in, but is a beautiful State!

I do have some what I hope is helpful suggestions for each of you to consider. It is crucially painful for me to say, that taxes is a MUST in Alaska. As a State, we are one of the FEWEST State of the Country which doesn't have a State tax. I have to work hard for each penny that I get, and in Juneau we have a 8% municipality tax. Taxes should help with the deficit which we have, IF legislators can balance the checkbook correctly.

It may also benefit Alaskan's deficit if we can have a fee for vehicles crossing the borders of Alaskan/Canada. If we can have a \$5 for compact vehicles, a \$15 for next size up vehicles, and a \$25 fee for commercial vehicles crossing the border may actually help. Let me explain where the idea came from. I was asked to drive buses in New York for 3 weeks. After completing my agreement, I was given permission to use company car to drive from New York to New Jersey. One of the state between those

two, I had to pay a fee of \$3 for coming to the vehicle both ways to cross the border and drive through that particular State. If a State on the east coast can charge a fee, why can't we do the same, just a bit more expensive due to our cost of living?

I could say more, but I don't want to place you to sleep. I'm more than willing to talk more later, if you wished. Please let me repeat myself just once when I ask to budget the paycheck properly, and that we have a spending problem above everything in our beautiful state.

I am a now-retired Alaska physician who came to Alaska in 1970 with the Indian Health Service, then spent two years in residency training in Seattle before returning to practice in Ketchikan in 1974, where I practiced until retirement in 2018. I believe that the WWAMI program is more important than ever in addressing medical manpower needs in our state.

Where a physician train is one of the most important factors in determining where they will practice. Even if every WWAMI student and resident returned to Alaska to practice it would not meet all of our needs, but without it the situation would be dangerously inadequate. For many years many of us first came to Alaska with the Indian Health Service or the military, but the ways that they are staffing have changed dramatically and there is not that constant flow of folks into the state from which to draw.

The direct interaction with academic medical centers outside the state that come along with the WWAMI program provide important benefits to the practicing community in Alaska, as well. Continuing medical education on both a formal and informal basis is helped significantly by the relationships fostered between the practicing community and the academic centers.

Providing opportunities for academically capable Alaskans to enter medicine through the WWAMI program makes medicine a tangible career opportunity that extends incentives all the way down to high school level.

We already rely on other states to provide training for much of the medical manpower we need. Please continue to fund the WWAMI program as a means of our resource-rich state doing its part to provide needed medical care for Alaskans.

I am opposed to large dividends at a time when the residents of Alaska need basic services. I am opposed to putting the dividend in the constitution. Alaska's resources are owned collectively. We do not have individual mineral rights.

The dividend is simply one of many programs in statute to be funded, and not a sacred cow.

So How do we move forward?

First)We know that the state budget has already been cut.

State of Alaska employee wages account for only, approximately 3% of the state's total personal income, this is not a material item. If we want transportation, schools and other basic services some government is necessary.

2)I believe a 5% POMV draw is too high. Markets change rapidly and the endowment is a young fund.

3)I am opposed to a 50/50 split because the dividend is just one program of many competing priorities.

Legislative enactment of the 50/50 split was from a time when the permanent fund generated interest income. Today we have a very different diversified and sophisticated endowment. fund.

4) I am opposed to a sales tax. The sales tax is regressive, unfair to low-income households and fails to collect from out of state workers and industries.

And, responsible Alaska communities are already collecting sales tax for local government operations. Alaska is meant to be incorporated into municipalities across the state and a sales tax is an important tool for those areas that incorporate. If the state intercepts the sales tax revenue streams from the municipalities, this will further burden the state to prop up local governments while discouraging the growth of our state into municipalities.

Finally, If Alaska wants a dividend, it should be an affordable component. If additional revenues are necessary, a review of the oil tax structure and other industry tax structures should be reviewed along with a review for an Alaska income tax.
