## FISCAL NOTE ANALYSIS

## Analysis

A sub-account of the fish and game fund, called the Alaska sport fish enterprise account, existed to collect a surcharge on sport fishing licenses to satisfy sport fishing facility construction bond debt obligation. This bond expired in CY2020. With the expiration, the associated surcharges sunset and were repealed. New language provided in this legislation would reinstate the surcharge at a reduced rate and create a new account within the fish and game fund (FGF), called the sport fishing hatchery facilities account, to collect the surcharge revenue. The accrued revenue in the account would be used to fund future maintenance needs at the hatchery facilities.

**Revenue generated under reduced fee structure:**

The licensing fee structure of this legislation would take effect July 1, 2021. By averaging license sales from 2016-2019 and deducting 10% for vendor commissions and overhead, the department estimates approximately \$4.1 million in surcharge revenue. This is approximately a 32% reduction in fees previously being collected.
