

My name is Autumn Smith Amy and I am testifying on behalf of amy_consulting; a statewide barrier busting street outreach advocacy firm serving the City of Anchorage proper in the neighborhoods of Fairview, Mountain View, Government Hill, Muldoon, and Spenard with a totality of 300 clients and families and statewide advocating on behalf of 22 of 229 Native Villages. All of my clients are below federal poverty level, all of my clients struggle with disabilities and are victims or survivors of trauma; all of my clients need real time legal assistance just to access the basic level of services to improve their family and communities' welfare and safety.

I did not come here today to explain to the State; that Alaska has one of the highest rates of domestic violence and sexual assault per capita in the Nation. I came to explain that when victims and survivors need protective orders, need to secure custody of their children, need to rebuild their lives emotionally and financially; they are referred to Alaska Legal Services for assistance.

I did not come here today to explain that the City of Anchorage has 1800 unique houseless individuals who are struggling to equitably access the very services designed to assist them and face crippling systemic barriers in doing so such as housing discrimination, exploitation, and rampant benefit delays and denials. I came to explain that when my houseless clients have a legal issue preventing them from stepping forward out of their situation, they are referred to Alaska Legal Services.

I did not come here today to explain that the rural Alaskan Villages are struggling to preserve their families and culture due to systemic racism. I came to explain that when they face the loss of their children, their subsistence, their access to food and energy, or they are unsafe; they are referred to Alaska Legal Services.

I did not come here today to explain that the marginalized and poor in Alaska need protection and equitable access to the same justice those of power enjoy with little fanfare. I didn't come to argue semantics over people's God given right to be able to live in their communities safely, with access to opportunities that invest in their welfare and families livelihood, that keep food on their table, roofs over their head, or a warm home in the winter. I came to remind you that for my clients and communities facing abject poverty; the first and sometimes only service agency willing to help them move forward is Alaska Legal Services.

I did not come here today to explain that fundamental human rights are inalienable. Or that everyone has the right to receive justice and equitable access free from political retaliation for holding the line of accountability. The State of Alaska is accountable to its People. All of its People. Cutting any funds to Alaska Legal Services will result in a decimating surge of victims of violence unable to protect themselves or their children, mass illegal evictions and lock outs, mass elder fraud, and further decimate families and individuals facing barriers to accessing services. It places more fiscal burden on a nonprofit service array that can ill afford to support the load and greater unnecessary expenditure and burden on front line State systems. Specifically; the court system both criminal and civil, emergency services such as police, fire, ambulance, and the child welfare system. For every \$1 spent on Alaska Legal Services for these mutual clients, approximately \$6 is saved from burdening other systems by providing equitable access to felt justice that sets their families and ultimately their community; in the direction of not just surviving, but, thriving.

I DID come today to leave you with a quote that I think sums up my clients' thoughts and feelings on any efforts to oppress their fundamental human rights by gutting the budget of agencies that are the last line in defense of systemic injustice; it is summarized for this specific issue, and was written by Ms. Sarah Grimke when fighting to abolish another oppression of fundamental human rights; "But I ask no favors... I surrender not our claim to equality. All I ask of our brethren is, that they will take their feet from off our necks, and permit us to stand upright ..."

I thank the committee today for hearing my testimony and I hope that you invest in the People of the State of Alaska's access to justice by wholeheartedly investing in Alaska Legal Services critical work for impoverished community members to preserve their families' welfare and safety.

In 1971 I graduated from Georgetown University Law Center and was hired by Alaska Legal Services Corporation as a staff attorney in its Juneau office. Fifty years later I am still here, and transitioning into retirement from the private practice of law. I know, first-hand, that the availability of legal services for those unable to afford private counsel is an absolute necessity. A person or family with limited financial means must have the ability to legally pursue their rights and remedies when faced with an eviction contrary to the requirements of Alaska's Landlord Tenant Act, to contest an unlawful denial of social security disability benefits, to protect against unfair lending or predatory collection practices, and the list goes on. Equal justice under the law becomes a meaningless phrase when Alaskans are essentially locked out of our state's civil legal system.

The state of Alaska has done its fair share of funding over the years. Combined with private donations, the dedicated and diligent work of ALSC's staff, and thousands of hours of pro bono services by volunteer attorneys, much of the work needed to achieve the lofty goal of justice has been accomplished. But the \$400,000 cut by the Governor brings ALSC's state funding to the lowest level in a decade, and may well sound the death knell for an exceptional program that provides quality service to the most vulnerable of Alaskans.

Please adequately fund ALSC. Please make us proud of our Legislature. Thank you.

Dear Members of the House Finance Committee:

Thank you for your hard work and diligence during this year's extended legislative proceedings, and especially for the extraordinary lengths you went in providing ARPA funds to help fill an unexpected gap in federal VOCA funding. Your work was instrumental in ensuring stability in provision of services for victims and survivors of domestic violence and sexual assault. Thousands of Alaskans are better served because of your successful efforts.

As you consider amendments to HB3003 tomorrow, the Alaska Network on Domestic Violence & Sexual Assault (ANDVSA) respectfully requests that you to take note of the impact of the failed "reverse sweep" on the Recidivism Reduction Fund (code 1246). As you know, the FY22 Mental Health Budget HB71 included \$2M to the Dept. of Public Safety / Council on Domestic Violence & Sexual Assault from the Recidivism Reduction Fund to help provide sexual assault prevention services. Those funds are now swept into the CBR.

ANDVSA recognizes that new funds replenish the Recidivism Reduction Fund through the course of FY22. Indeed, the Office of Management & Budget estimates that projected revenue to the fund will likely provide all but \$474,1000 of the approved and enacted \$2M appropriation. (Please see OMB's "Budgetary Issues Due to the CBR Vote Failure" page 1 "Partially Unfunded Operating Appropriations" HERE.) Per these estimates, without a "reverse sweep" or a new appropriation of general funds in the amount of \$474,100, the CDVSA can expect a 26 percent reduction in Recidivism Reduction Funds in FY22.

We appreciate that the scope of the fiscal challenge you grapple with is great. Nevertheless, we ask you to bear in mind that HB3003 could potentially resolve this anticipated underfunding of prevention services.
