I am a third generation Alaskan who remembers paying income tax and school tax. I do appreciate the gift of the PFD and understand than many people rely on it. At the same time our shared resources were originally intended to provide the services and infrastructure that help each of us be healthy and as productive and financially independent as possible. Opponents to statehood argued that Alaska is too big and sparsely populated to afford to build the infrastructure necessary to support ourselves. I'm thankful for the oil wealth that has helped meet Alaska's basic needs and the foresight of earlier Alaskans who established the Permanent Fund designed to share the value of our finite natural resource with future generations. I doubt leaders who later supported developing the PFD foresaw the situation we're in now. Listening to hours of testimony it seems to have attracted people who are here for the "free money" and no taxes, with little interest in building Alaska as they earn their living. I want my Alaskan grandchildren, their peers and future generations to live in a financially stable and healthy

state. In this context I support the following positions.

Members of the House Finance Committee, I strongly urge you to support Governor Dunleavy's PFD plan to allow Alaskans to vote to put the historic distribution of the PFD into the state's constitution. Then if the state government wants voters to give them funding from the distribution to Alaskan's, they can request it as other charitable organizations are doing.

It is my opinion that the PFD distribution to Alaskans does more to the Alaska's economy and any state program. It provides employment training after high school, helps to pay for living and medical expenses and other household expenses to numerous to be listed while providing a strong economic boost to business which includes employment for many Alaskans.

Note that it is very difficult for a retired senior Alaskan forced on to Medicare to be accepted as a patient of a family doctor as the pay received by doctors from the US government will not support the costs incurred by a doctor in Alaska. Any other health insurance plan is secondary to social security which sets the pay rate to the doctor. So medical expenses are a major cost to seniors if they have to go to a hospital for care.

Now that the covid suspension of rent or mortgage payments has ended, back payment is now due as well are current ones. The current proposed PFD payment will not be adequate to cover this cost for a family.

My name is Tanya Kitka and I represent myself and my family, and especially writing in to testify on behalf of my two kids.

Let me say first and foremost that I support a full and statutory PFD, as well as back paying the withheld statutory PFD amounts from 2016 to present. My family of 4 alone is owed over \$50,000 from these withheld amounts. I know that legislators who claim that paying this would devastate the Fund are liars because the Dividends never touches the Fund and is only ever paid from an average of the earnings, most of which is sitting in the ERA, I believe. The state has the money, and it is owed to the people.

I know that many of us Alaskans do support this. I know that many legislators do not. Somewhere along the way, when royalties from oil companies were dwindling while oil tax credits appropriated by those same legislators were ever high, it was decided in Juneau to start using that PFD money to pay for state services.

This is wrong.

Alaskans didn't agree to this. It does not follow the state statute. Why are our representatives in Juneau allowed to ignore the laws when the rest of us must abide by them all?

Dunleavy has come up with a compromise. It is the middle ground between what Alaskans want, (the full PFD) and what legislators want (to use all that money for funding the state budget.)

I support Dunleavy's compromise PFD plan, so long as it is accompanied by a constitutional amendment to be put before the vote of the people, so that this new formula can be put into effect.

The constant bickering in Juneau every year, the endless special sessions and spending of money to decide what pittance of our state resources we should be allowed is ridiculous. I think I can safely say that we are all tired of this same mess every year.

The other argument against the state using the earnings from the Fund for the state budget that I recently heard and makes sense to me, is that when the state no longer depends on the local economy for funding government, it then loses the same interest it once had in ensuring that that economy is healthy, growing and producing. In other words, when the state is receiving enough money from the stock market to pay for services, what does it matter if oil and mining are paying royalties?

I recall in the early 2000s when my own Dad, Tom Quick of Ouzinkie, was explaining to me how there was talk in Juneau of paying every Alaskan a large sum, \$20,000+, and ending the dividend program. He didn't think that was right, and voiced his opinions against it. He said it would not be right to end the program for my future, and my kids' futures (although was still in high school and did not have kids yet.) Now it is my turn to fight for my kids' futures and the future of the PFD program.

I hope that you hear this year's testimony, although my faith is low. There was nothing said yesterday that you haven't heard before, except that many Alaskans are now feeling that Dunleavy's plan may be the only way forward, to strike a compromise that none of us wanted in the first place.

I watched most of your hearing last evening. Thank you for weathering the admonishments and lectures, and thank you for meeting the time commitment 2021 has required of you.

Clearly most Alaskans favor a PFD this year, and seem to also favor an amount of at least \$2,000 or thereabouts. My own view is that the amount of the PFD that goes to the IRS makes it a terrible program from an economic input/output standpoint, and because Alaska produces so little here — likely only one-third to one-half of the next least productive state — a program that indifferently ships so much money out is worrisome. But I seem to be in a minority and am reconciled to the PFD not only remaining with us but increasing in cost.

I strongly do not believe that taking an unsustainable amount from the PF now will be followed by sticking to a practice of sustainable spending later. I believe that taking \$3 billion now during a time of huge federal spending here is very likely to be succeeded by a period of inflation and bear markets that cause a future governor and future legislature to take even larger amounts from the PF. No one who looks at our history could reasonably conclude that one large draw now will be the final large draw.

I have always believed that if the annual state spend was forthrightly and honestly reduced, something that has not happened, Alaskans would come to see state government spending in a different light than was evident in your hearing last night. I think that taking as little as \$600 million GF from our total spending of \$12 billion to \$13 billion (all funds) would be adequate for the politics. Please consider reducing the 2022 budget by at least \$500 million to put that same amount in the PFD. I also think that there are symbolic actions you could take to address the concerns many have that state government and the PFD are two factions competing for the same dollars. Moving the state workforce to a 40-hour week and eliminating a few of the paid holidays are examples of symbolic actions I believe would help reduce the loud rancor the House seems to have garnered.

Taking action that goes against the grain of the conservative majority that spoke to you last night will not conclusively resolve anything. People remain angry over how the PFD was reduced by Governor Walker, and action you take in 2021 will not be the final word unless it seems reasonable to most voters in every region. Also, I wonder whether any long-term solution can be achieved until all Alaskans live in a place that has property taxes and a local contribution to local government responsibilities. By the way, I believe there is a large opportunity cost in having the statewide fiscal debate Alaska has had for years and continues to have while other states build their economies. Please arrive at an agreement that concludes this debate even if doing so requires cutting the annual state spend.

I think a sales tax is hands down a more appropriate and economically viable revenue measure than an income tax. We already have too few Alaskans working at producing goods to sell to the rest of the world; at least a sales tax would dampen consumption rather than output, and almost everything we consume is produced anywhere but Alaska. As a state we consume too much and produce far too little, and I don't believe Alaska will be ready for any broad-based tax of any kind until or unless that annual state spend is substantially reduced from current levels. Right now a family of four Alaskans represents over \$60,000 in annual state spending! Even a very productive state economy that has manufacturing and agriculture could not sustain that level state government. Also, Alaska has completely lost the positive wage differential we once enjoyed over other states and that also recommends we even stop talking about an income tax.

Finance Priorities:

- 1. Please do not provide a guarantee for Alaskans to receive a PFD . Please reread Joe Paskvan's article in the Sunday paper. Should you be tempted to have such an amendment provide the revenues, "taxes", or budget cuts first.
- 2. Please do not withdraw more than 5% of the Permanent Fund
 - a. As a member of the Fairbanks Permanent Fund advisory committee for over 10 years, having a maximum withdrawal rate, the endowment method, works.
 - b. As a city council member the max 4.5% withdrawal rate (times the 5 year average fund balance) was put to the voters on May 20, 2002 (ordinance 5485) and the Fairbanks citizens approved the City Charter amendment that fall.
 - c. Elected officials like to spend money to prove they love their community and state. Elected officials love to have their picture taken with a ribbon and a scissors in hand. You have to have a limit or the Alaska Permanent Fund will disappear quickly.
- 3. Should you elect to have a "full dividend" this year, come up with the revenue now, Sales tax, gas tax or income tax and pass that legislation now, don't take the funds from the earnings reserve or exceed the 5% withdrawal rate.

The Permanent Fund, the PFD, and budgetary issues

Thank you for this opportunity to testify.

My belief is that the Permanent Fund was established to share the wealth from a non-renewable resource with future generations of Alaskans. Not to pay a PFD. Protecting the Permanent Fund should be of utmost importance, and I am pleased that a few years ago the legislature passed a POMV statute to protect the Permanent Fund, although I believe the 5% draw limit should be reduced until the Permanent Fund reaches \$100 billion. If a constitutional amendment is necessary to protect the Permanent Fund, then I would support that. I am against any overdraw of the Permanent Fund. I am against "bridge funding". Governor Dunleavy wants to pretend that a constitutional amendment that he proposes for paying a 50/50 PFD is applicable now, but he wants to pretend that his proposed constitutional amendment, and the existing statute, for limiting the POMV draw would not be applicable. I am glad that the fund value has increased tremendously over the last year, but this is not a reason to break the POMV statute.

The PFD should not be constitutionally protected. Paying a PFD is not nearly as important as the many services that the State provides. The PFD does not have "First Call", it is one of numerous budget items and should compete against other government programs for prioritization and funding. Our Supreme Court has already determined that the PFD is subject to appropriation, thus any PFD amount paid is a full PFD. I do not feel that I am owed any back pay for historical reduced PFD's. Governor Dunleavy decided to reduce the PFD to \$0.00 this year, I am satisfied with this PFD amount and believe that he should be credited with the \$0.00 2021 DUNLEAVY PFD. The current PFD statute should be eliminated, and replaced with a statute that commits to attempting to pay a PFD as money allows. Perhaps a \$500 PFD cap should be included until the Permanent Fund reaches at least \$100 billion. While I believe that we should seek to receive the maximum compensation for our oil, I am not in favor of any income tax or sales tax to pay a larger PFD.

While I am against constitutionalizing the PFD, if this is pursued I believe that it should not be a 50/50 split. For the first 30 plus years the state has not used their portion of the 50/50 split, rather this money was left in the fund and continued to grow. My belief is that this non utilized

money, as well as income from this money, should be subtracted from the Permanent Fund balance to determine an amount of money available for splitting.

I am of the belief that there are still minor savings to be found in the State budget, and that as these savings are found they should be implemented. I am not naive enough to believe that we can find enough savings to allow for paying what some feel they are entitled to. There are some reductions that I would support that many others would not. The legislature was structured to balance the desires of the public and to provide the services that the citizens collectively desire. I am satisfied with that balanced approach.

I am Steve Fritsche of Nikiski, AK. I am representing myself.

Thank you for the opportunity to address the committee.

It seems like you have a difficult decision to make, but to me, it is simple. Paying the full Dividend amount based upon the statute would provide a decent income to residents so that they could buy the products that they need for the long winter ahead. This also reduces the burden on the budget for funding projects. Let me explain.

LEG tends to want to fund a lot of projects that really need to be funded by the consumers of those projects. For example, I heard testimony from a municipal manager that their community has almost no ability to produce income, but they need power, law enforcement, healthcare, etc. I don't fully understand why people would choose to live where they are unable to support themselves, but I guess that is their choice. But if those communities have to cover the cost of their own power like we do in Nikiski, then you wouldn't have to worry about funding that project. But the solution seems rather clear. With a full PFD payment, those who live in those communities have means to choose what they buy. Heating oil, generator diesel, medical insurance might be high on their list. It would reduce the services that need funding to those like law enforcement and ... well, not much else.

What I see, here in Nikiski, is that we have many low-income families who desperately need the full Dividend. It is the bulk of their income. Without it, they can't buy wood for their stoves, winter jackets and boots for their growing kids, repairs on their cabins to keep the cold air out of their kids' sleeping space, roof repairs to keep moisture, ergo mold, out of their home, lumber to replace their failing outhouse, food staples to make it through the winter. For them, the Permanent Fund investment is a critical part of their income, and they depend upon it.

Others, here in Nikiski, you might argue, don't NEED the dividend. And maybe you are wealthy and you don't really relate to most us. But I have lived elsewhere, and I can testify that it is far more expensive to live here, especially considering that pay is not higher enough to cover the difference. But, when you factor in the full PFD, income is more in line with the lower 48 compared to cost of living.

So, we, the people of Alaska, have a significant investment in the Permanent Fund. The income from that investment is a significant part of the income we need to live here. When the full amount is paid, we have a good economy. When you fail to pay the statutory amount, the economy withers. Since Gov Walker started shorting us to fund your projects, we have seen people suffering and leaving the state.

STOP IT! It is time to pay the full Dividend PLUS back payment for what we missed out on receiving over the last five years. The ER is fully funded and stands ready to pay the full amount. So, just do it.

Bottom line: if you want to fund your projects, go find new sources of financing like from the project consumers. STOP FUNDING YOUR PROJECTS WITH OUR MONEY! Pay us our money, and let us decide what projects WE want to fund. For me, I choose to pay property taxes which fund our local services, and also, to buy products I need for winter which supports local businesses. If YOU don't need the Dividend, you can feel free to pick, click, give the full amount to the project of your choice. Just don't take our choice away from me and my neighbors.

Good afternoon, members of the House Finance Committee. I'm William Topel of House District 27, Senate District N in Anchorage, representing myself. Regretfully, I'm opposed to HB3003A for the primary reason that your appropriation amount for the people's PFD is underfunded, according to the traditional statutory PFD distribution law.

This bill is a compromise between the traditional statutory PFD distribution law and SB 26. SB 26 continues to cause annual hassles over the amount that Alaskans should receive for their PFD. I don't like SB 26 and I don't like this compromise. I want the FULL PFD.

If you legislators would use the traditional statutory PFD distribution law, which you have ignored for over 5 years now, we Alaskans can get our legal FULL \$3,687 PFD this year. Based upon 630,000 applicants for this year, the overall amount appropriated from the Earnings Reserve Account would be about \$2.3 B. That would also allow you to appropriate a like amount from the ERA for state government, which is Hammond's 50/50 plan, which would cover your anticipated budget deficit of between \$1.6 B to \$2 B with some money left over, which you could transfer to the CBR. There is enough money in the ERA, over \$15 B as of July, to do both of these functions without putting new taxes on the people or the private business sector or jeopardizing essential state services.

Repeal SB 26. Keep the Earnings Reserve Account as a pivot savings account that receives Permanent Fund investment income and from which distributes the PFD and money for state government, and can also be used for state or regional emergencies. Keep the traditional statutory PFD distribution law, and pay the people what you owe them. For this year, that would be about \$3,687, and you also owe us the back PFDs of over \$10,000 per person, too. If you eliminate the ERA through proposed constitutional amendments or statutory bills that would transfer its balance to the Permanent Fund corpus, then you would be denying the people the ability to recover our back PFDs.

Alaskans are hurting. FULL PFD NOW or the people will vote for a Constitutional Convention next year. Thank you.
