RE: SUPPORT FOR SENATE BILL 3006

Chair Costello and Vice Chair Revak:

On behalf of Teladoc Health, I write to you in support of Senate Bill 3006. If passed, this legislation will increase access to safe, cost-effective health care for Alaskans at a time when COVID-19 cases continue to increase. Senate Bill 3006 would create a pathway for out-of-state medical providers who are licensed and in good standing within their own states to treat Alaskans through telemedicine until July 1, 2022. This provision is crucial to mitigating health care shortages amid the pandemic while simultaneously ensuring patients have access to safe, high-quality care. I urge you to pass this bill.

Teladoc Health is the world's largest telehealth company. We are successfully transforming how people access and experience healthcare, with a focus on high quality, lower costs, and improved outcomes around the world. As we experience the resurgence of COVID-19 and witness its strain on health care systems across the country, it is clear that Senate Bill 3006 is a timely, common-sense measure that would benefit residents across Alaska. Relaxing licensure requirements so that licensed out-of-state providers can treat patients via telemedicine will ensure Alaskans can continue to access safe, timely and cost-effective care.

Thank you for your time and thoughtful deliberation of this issue that is so important to the residents of this state. I look forward to continued collaboration and hope that you will continue to see Teladoc Health as a resource.
